Power!

May Almighty God continue to bless and long preserve your Majesty to make these Kingdoms happy under your mild and auspicious Government; and may the British Scepter continue to the latest Posterity in your illustrious House; that so we may always have a Protestant Sovereign to secure us in the Possession of our most valuable Rights and Privileges.
