Berlin, Aug. 9, N. S. Every Thing is preparing for his Prussian Majesty's Return from Silesia to this Town upon the 11th Instant. The Hussar here-have received Orders to setch their Horses from the Country, and to exercise every Day that they may be ready on the 18th Instant, when, after the Review is over, they are to attack the Insantry, which will defend itself according to the new Exercise. The Gendarmes are buying Horses for the same Purpose, and the Corps of Hunters is to be assembled.

Berlin, Aug. 13, N. S. The King of Pruffia return'd the 11th Instant in the Morning from Silesia. M. Czernichow intends to set out To morrow for England, being appointed to reside there as Minister from the Empress of Russia.

Copenhagen, August 13. Lieutenant-General Lerche is made Secretary at War, in the room of Lieutenant General Nummen, who is promoted to the Rank of General of the Cavalry in the Army, with proportionable Appointments. The Privy Counsellor Vander Osten, who was at the Head of the Finances, is removed; yet he is still allowed to keep his Post of Comptroller of the Duties in the Sound. M. Thott, one of the Chief Deputies of the Chamber, supplies his Place in the Treasury till farther Orders. The Order is now notified and made publick for a general Mourning, which is to commence the 4th of next Month, and is regulated after the deepest and most extensive Manner. All Persons of the first Class are to have two Chambers in their Houses bung with black, as well as their Coaches, Servants and Equipage in the Jame, which is to continue with small Variations for a Year, and the whole to conclude in a Year and fix Weeks.

The King of Denmark has given to M. Molck a fine House with a pretty Estate belonging to it, called Bregentwed, which the late King purchased from M. Lewenoren, and M. Vander Luke has received the Key of Chamberlain. M. Clausberg, who had the late King's Privy Purse, is dismiss'd from that Post, and has obtained a good Place in the Customs at Elsenore. Major General Furgott, the Saxon Artillerist, who was lately taken into the Danish Service upon a very savourable Footing, is dismis'd; as is also M. Schomberg President of Altona.

From the Camp at Viler, Aug. 13, N. S. Seven Battalions of the Garrison of Namur have joined us.

Camp at Viler, Aug. 17, N. S. Advice is just brought from Marshal Bathiani's Quarters, that the Enemy, who have been for three Days past in continual Motion, are advancing towards us, which gives us the greatest Reason to expect a general Engagement very soon. We have lately had good Success in our Skirmishes. Some Days ago two Squadrons of French Horse, with the Lieutenant Colonel and seven Officers, were made Prisoners, and the greatest Part of Eg-

mont's Dragoons cut to Pieces, and 14 Officers of that Regiment taken. Yesterday Morning there was a smart Engagement on our Lest, in which our Irregulars and Free Companies killed and took Prisoners several of the Enemy, with the Loss only of two Men on our Side. Lord Garrnick, who is Aid de Camp to Lord Craufurd, was Yesterday mistaken for a Frenchman by our Hussars, who fired at him. In endeavouring to escape from them he fell into the Hands of the Enemy, and was carried before Marshal Saxe, who immediately released him.

Hague, Aug. 19, N. S. Letters of the 16th from the Camp of the Allied Army near Namur inform us, that Marshal Saxe, after having sent off a large Detachment on the 13th Instant, had the next Day broken up his Camp and marchedto the Left, whereupon our Army made a Motion to the Right towards the Mehaigne, by the Way which leads by Tourine les Beguines to St. Tron and Tongres. A Courier from the King of Sardinia to his Minister here, who lest that Prince's Head Quarters on the 9th Instant, N.S. brings Advice, that his Sardinian Majesty had passed the Lambro at the Head of his own Troops, and Count Brown's Detachment, and dislodged the Enemy from all their Posts upon that River, as low as Hospidaletto, and that M. de Gages had likewise abandon de Lodi and Codogno, and was drawing his whole Force together on the Po, over against Placentia, and throwing up Intrenchments to guard, his Bridges of Communication with that Place, into which it was thought that he would foon, be oblig'd to retire. The Report of the Infant's having left the Army is not confirmed.

Hague, Aug. 22, N. S. By our Advices from the Allied Army of the 18th Instant, it was then posted along the Southern Side of the Mehaigne; and had passed all the preceeding Day under Arms, expecting an Attack from the French, who had appeared drawn up in Order of Battle on the opposite Side of that Rinver. Marshal Saxe did not push his Maich, at the farthest, beyond St. Tron, before he fac'd about, and drew up to the North Side of the Mehaigne. Brigadier General Houghton, with the Regiments of Wolf, Pulteney and Sempil, pass'd by Helvoetsluys last Saturday on their Way from Leith to Willemstadt, where they

arrived the same Night. Hague, Aug 23, N. S. By Letters from the Army of the 20th Instant, Marshal Saxe had advanced his Left, as Prince Charles had him Right, lower down the Mehaigne, the former having his Head Quarters at Hennuye, and the latter his at Bourdenes. The Report of Marthat Saxe's being declared Generalissimo, is now as confidently contradicted, as it was lately affirmed; and it is represented only as an Expedient which the French King had once entertained Thoughts of, for putting an End to the Contest between that General and the Prince of Conti; but which has fallen to the Ground by the latter's withdrawing himself from the Army. Letters of the 15th from Italy mention, that the King of Sardinia was then repalling the Po, and General Botta had advanced to Castel St. Giovanni. The poor Remains of the French and

Spaniards

Spaniards were said to have fled beyond Tortona, abandoning their Baggage and Artillery in their precipitate Retreat.
