The humble Address of the Pastors of the Churches in his Majesty's Province of the Massachusetts Bay in New England, assembled in Boston at their Annual Convention, May 28, 2746.

Most Gracious Sovereign,

WE your Majesty's most dutiful and loyal Subjects, the Pastors of the Churches in the Province of the Massachusetts Bay in New England, beg Leave to take this first Opportunity to express our utmost Detestation of the unnatural, wicked and traiterous Rebellion, rais'd in Great Britain, and abetted by the grand Supporters of the Papal Interest, against your Majesty's Royal Person and Crown, in Favour of an abjur'd Pretender, train'd up in the Bigotry and Tyranny of the Romish Principles and Practices, utterly Destructive to all true Religion and Liberty; and to assure your Majesty, that as in the Days of your Royal Father, so in the present Day we know not a single Man belonging to any of our Assemblies, but what is firmly attached to your Royal Person and Illustrious House.——At the same time we congratulate your Majesty upon the Success of your Arms, under the Conduct of his Royal Highness the Duke, against the infatuated Men, whom Heaven indeed has righteously made a Scourge to the British Nations, while yet, they are but the vile and contemptible Tools of France and Spain. And in the Name of our Lord Jesus Christ, we make it our fervent Prayer to the Supreme Ruler of the World, that all the Enemies to your Majesty, and the Protestant Succession in your Royal House, may be clothed with perpetual Shame.

We beg Leave also joyfully to congratulate your Majesty upon the wonderful Success God has given to your American Forces, in the Reduction of that important Key of North Ame-

rica, Cape Breton, to your Majesty's Government, which we can't but hope and trust in God, shall never be wrested out of your Royal Hands.

We chearfully rely on your Majesty's Royal Goodness, under God, still to protect us and our Churches, in the Possession of our invaluable Rights; and that our Province, which have so signaliz'd their Loyalty, shall always find Favour in the Eyes of our Gracious King, while we constantly present our hearty Prayers to Almighty God, for the long Prosperity of your Majesty's Reign, and the Continuance of your Crown in your Royal Family, throughout all Generations.

Munich, August 29. The first Division of the Bavarian Corps began to move from Donawert towards the Netherlands two Days ago.

Berlin, August 30. The Russian Minister Baron Kayserling, who was formerly at the Court of Dresden, and since at the Diet of Germany, is named to reside at this Court, in

the room of Count Czernichew. Vienna, August 31, N.S. There is now confirmed Advice of M. de la Mina's Arrival. and of his having taken the Command of the Spanish Army at Voghera; from whence he marched the next Day, with the greatest Precipitation, to Gavi, and the Borghetto, leaving a small Garrison only at Tortona, and abandoning not only Novi, but the important Post of Serravalla, of which two last Places the Austrians and Piedmontese are in Possession, after having killed or made Prisoners, in different Parts since the Affair of the 19th Instant, above 1500 Men, and left ten Battalions to block up Tortona. The farther Operations agreed upon are faid to be, that M. Botta shall, with the Austrian Infantry, pursue the Enemy first to Gavi, a Place that demands Artillery, and afterwards which ever Way they turn; whilst the King of Sardinia, with his own Troops, takes the Route of Acqui, by the Valley of Bormida, in order to cut off their Retreat into France. The Emperor returned alone to his Estate of Hollitsh, the Day before Yesterday, in otder to pass a Fortnight there in hunting.

Hombourg, Sept. 2, N. S. Captain Bladwell, in his Majesty's Ship the Mercury, is safely arrived in this River, with fix Sail under his Convoy for Hambourg, after having seen into the Weser two Ships for Bremen, and three into, the Texel. The new French Minister at the Court of Dresden, M. des Issarts, arrived there the 22d of last Month, and was to

Liege, Sept. 6, N. S. The French have posted Centinels in our Suburbs. Last Night there were not above 4000 of the French near Huy, the rest having rejoined the Army. We have not as yet any Account that the French have invested Namur.

Camp at Wigimont, Sept. 6, N.S. We arrived in this Camp last Night. The Frénch had 20,000 Men on this Side the Meuse, which the Day before Yesterday, at our Approach, repasfed that River with the utmost Precipitation. Our Communication is now opened with Maestricht, from which we are distant five Leagues. For these 24 Hours past we have had such violent Rains, as were hardly ever feen, by which the Roads are become very bad. The Enemy's Army marched Yesterday, and encamped with their Right at Warem, and their Left at Tongres, so that it looks as if they designed to dispute our repassing the Meuse.

Camp at Wigimont, two Leagues from Liege, the 6th of September, N. S.

We halted one Day at Ohet, after we had passed the Meuse without the least Molestation from the French. We have continued our March towards Maestricht, which, considering the strong Defiles over a mountainous Country, and three Rivers to pass, we have hitherto effected with Success, and are at' present within a good Day's March of the abovementioned Town.

Sept. 4. The Army marched and passed the Emblent, the Right at Louvigne, and the Left at Spremont: Count Mersi reported, that the French were repalling over the Bridge at Liege, and begg'd Leave of Prince Charles to attack them; but as the Gros of the Army had not then passed the Weze, nor got clear of the Defiles, it was thought adviseable for Mersi to defist.

Sept. 5. The Army marched and passed the Weze at Trepont, through a very bad Defile of two Miles long, the Right of the Army at Melin, and the Left at Herve. Count Palfy's Corps covers the Right Flank, and General Mersi's the Left. Our Communication with Maestricht is now open, where Magazines for Bread, &c. are provided in sufficient Quantities.

Sept. 6. We halt here To-day and To-moryow on Account of our Baggage, which the heavy Rains that fell lince Yesterday, and world Roads, have prevented joining us to toon we expected. Our next Encampment will be on the Plain's of Maestricht, if we do not kepas the Meuse at Liege, which some imagine may posfibly be effected. Marshal Saxe is encamped his Right at Warem, and his Lest at Tongres; which looks as if he intended to dispute the Passage of the Meuse with us.

Hague, Sept. 6, N.S. There are Leners from the Confederate Army of the 3d, which give an Account of their having passed the Ourte at Ham, after a very long March of near 24-Hours. They are now encamped at Mye and Harsez, and the Communication with Maeltricht is open; so that there is not at present any Danger of their being in Want of Sublitance, great Quantities of all forts of Provisions having been of late brought to that Place. Our Advices from Italy go down to the 23d paff, when our Allies, after having left a suitable Lorps to mask and block Tortona, had driven the Enemy, wi h continual Loss on the Part of the latter, into the Mountains of Genoa; had rendered themselves Masters of the Castle of Sarravalla, and were preparing to penetrate into the Genoese Territory, the Austrians by the Way of the Bochesta, and the King of Sardinia more to the Right by the Valley of Bormida. We have Advice from Paris, that M. de la Mina, who has taken, the Command of the Spanish Troops, has Ot ders to conduct them Home as fast as he can. Count Czernichew, whom the Empress of Rusfia is sending her Envoy to the Court of Great Britain, is arrived here from Berlin, and proposes pursuing his Journey to London in a Day or two.

Hague, Sept. 9, N. S. The Greffier Gilles, who arrived here last Night from Breda, was this Morning unanimously named by the States Letters from our Army of the 7th Instant we Maestricht as far as Herve, about half Way be Sept. 2. The Army made a very long and tween Vervier and Liege: That the Detach-Side of the Meuse had repassed that River, and joined their main Army, which had made as Motion by Warem towards Tongres, with a View, according to some Advices, of passing under that Fortress. In the mean Time Count, mounted the Western Side of the Meuse from Huy to Namur, and even to have begun the Investiture of that Place. It is mentioned in Letters from Paxis of the 5th Instant; that the Spaniards in Italy were separated from the French and Genoese, and were preparing to return to Spain. We have received the following Journal of the Motions and Operations of the Austrian and Sardinian Armies in Lombardy, from the 15th to the 22d past, N. S.

From the Camp at Rivalta, August 22, N.S.

Upon the 15th the King of Sardinia's Army marched in order to pass the Po, and encamped at Carteggio, whither Advice was brought, that General Botta was advanced to Bron. Out Avant Guard pushed on to Montebello, but General Nadasti, whose Corps had been employed in investing Placentia, after the Reddition of that Place, had marched with such Expedia tion, that he was got before them, and was ad

vanced

mahoed to Voghera, where he attacked a Rear Guard which the Enemy had left there; and made some Prisoners.

Upon the roth, in the Morning, M. Brown marched to Ponte Curone. General Nadasti, who preceded him, attacked a Rear Guard of the Enemy, made 60 of them Prisoners, and cut the rest in Pieces. His Avant Guard encamped with their Lest at Ponte Culone, and wheir Right extending on the Side of Castel Novo de Scrivia, which, they took Possession of, and sent our Parties to within two Miles of Tortona. The King's Army encamped at Voghera, and M. Botta remained at Bron.

Upon the 17th M. Botta's Corps advanced to Carteggio, and the King's Army and M. Brown's Avant, Guard remained, one at Voghera, and the other at Ponte Curone and Castel Novo. This Day M. Brown's Corps was reinforced with three Battalions, one of Imperialists, and two Piedmontese, and the Queen's Regiment of Dragoons, whereby his Corps was compleated to 20 Battalions, and three Regiments of Dragoons, and all the Carabineers from that of Nadasti. We had Advices this Day, that the Enemy was retiring towards Novi, but that the Rear Guard, under the Command of M. de Campo Santo, remained still at Vighizzola and la Toire, upon the Road of Ponte Curone to Tortona.

Upon the 18th M. Brown encamped at Garolfo, and the King of Sardinia at Castel Novo
de Scrivia. M. Botta advanced to Voghera.
Thus these three Corps kept at the Distance of
one March from each other.

The Enemy were still encamped under Tortona, with their Right at that Place, and their Lest extended upon the Road of Saravalla. Towards Noon they made some Motions as if their Design was to march up the Scrivia, and to file, off towards Saravalla. Thereupon M. Brown advanced towards them with his Corps, and towards the Evening attacked the Post of Riyalta, where the Enemy had a Post of between 5 and 600 Men. The Commandant defended himfelf for some Hours; but after having lost about) 100 Men in killed and wounded, he surrendred Mrisoner of War with the rest of his Corps. The Enemy, under Favour of this Detachment, which they sacrificed, had Time to retire towards Saravalla and Gavi, which they did with the utmost Precipitation. A Body of Light Troops were detached after them, and upon the 19th M. Brown with his Army marched. The King decamped the same Morning, and marchnd to Rivalta.

Upon the 20th, the Method of pursuing the Enemy was settled. The Generals assembled at the King's Quarters. It was judged, that the Siege of Tortona was of too great Consequence to be attempted at present, as the Enemy had lest nine Battalions and above 50 Pieces of Cannon in that Town: And therefore a Resolution was taken to blockade it, and to employ upon that bervice ten Battalions, composed of the Troops of each Nation, and some Warasdins, together with some Regiments of Horse; that the sest of the Cavaby should be sent back; and that the Infantry should be formed into two: stparate Corps, the Austrian Corps to act towards the Bochetta, and that under the King to descend into the Valley of Bormida, in order to operate in the Riviera di Popente. This was u manimously agreed to upon the zist.

This Morning (the 22d) the King received Advice, that the Commandant of the Castle of Saravall had surrendred Prisoner of War, with his Garrison consisting of 200 Men.

Maestricht, Sept. 7, N.S. The Allied Army was encamped Yesterday between Herve and Vaudermont, covered by the Rivers of Wezé and Bervine; so that our Communication with it is now open again. General Trips has passed the Meuse to reconnoitre the Enemy. The Allies are expected To-morrow in our Neighbourhood. Marshal Saxe's Quarters were Yesterday at Tongres.

Brussels, Sept. 8, N.S. A French Courier, who passed through this Place on Tuesday last, in his Way to Paris from the Army, reports, that Namur is invested, and that no Person is permitted to go out of, or enter into that

Place.

Rotterdam, Sept. 9. The last Letters from the Army were of the 7th; the Head Quarters were at Herve, the Right Wing at Sour-Magne le Moine, and the Lest at Crevecoeur, waiting for the Baggage to come up, which was stopt, or at least retarded by the overslowing of the Rivers. There is a Letter from the Army of that Date, wherein it is mentioned, that the French were at Tongres, and that the Allies were going to throw a Bridge over the Meuse.
