Y Letters from France, of the 9th Instant, we have an Account, that a Fregate called La Renommée, belonging to the Squadron under Duke d'Anville, was arrived at l'Orient; and that two French Ships were come into Rochefort from China; a Third, which failed from thence along with them, having been lost in the Voyage home, and only 50 Men saved. Befides the twenty Battalions, which were arrived in Provence, twenty-three Battalions more, and twenty Squadrons, were expected there foon, and twenty-five other Battalions were said to be upon their March through Burgundy, in order to join Marshal Belleisle.

- Hague, Dec. 13, N. S. By our last Advices from Aix, Marshal Belleisle, who arrived there upon the 27th past, set out from thence for Marseilles upon the 28th, and proposed to be at Toulon upon the 1st Instant, N. S. in order to visit the Fortisications upon the Coast. Great Preparations were making to stop the Progress of the Austrians upon their Passage of the Var. Letters from Liege of the 9th Instant mention, that a Detachment of French Troops had taken Post at Dinant, and were fortifying the Head of the Bridge there. And it is written from Brussels the 12th, that the greatest Part of the French Militia had been incorporated into their different Regiments of regular Troops.
