Naples, March 7, N. S.

N the Night of the 22d past, two Abbes, Subjects to the Pope, by Name one Emilio and the other Lecce, were, by Order of the Committee of Diffidents, arrested and conducted to Castle Nuovo, upon Suspicion of being Emis-Taries from the Court of Vienna. On the 26th anchored at this Port, two Transport Vessels, one with the remaining Part of the King's Troops made Priloners of War at Tortona, and the other with 170 Spanish Soldiers arrested and conducted to Mahone as Prisoners of War, by an English Frigate, and since released. On the 5th anchored likewise two other Transports from Genoa, with about 250 Recruits for the Swiss Regiment Jauch, mostly Croatians, Pandours and Germans, Deserters out of the Austrian Army. The King has appointed a Committee of five Subjects to enquire and examine into the Administration of the Duke Barretta; as Agent Victualler of his Troops, during the Campaign in the Ecclefiastical State and Lombardy.

Rome, March 11. The King of Spain, in the present dangerous State of Health of Cardinal Acquaviva, has charged M. Clementi, Auditor di Rota for the Spanish Nation, with his Affairs at this Court. On the 26th past, the Pope, attended by M. Simonetti, the Governot of Rothe, M. Mesmer, Treasurer in Ordinary, and many Prelates of his Bed-Chamber, received, with the usual publick Formalities, from Cardinal Valenti Gonzaga, Secretary of State, the Oath as High Treasurer of the See of Rome, and invested him with all the Authority belonging to that Post, of which his Eminency took Possession accordingly, and teceived Comliments thereupon from the College of Cardimals, many Prelates, and the Nobility. Then

mals, many Prelates, and the Nobility. Then the Pope nominated M. Simonetti Vice-Trea-furer. On the 5th Instant a Courier from Genoa, by Way of Orbitello, passed by this City or Maples. On the 6th, Madame Fogliani, ster having seen the Antiquities of this City, proceeded on her Journey to Naples. Prepations are making at Palo and other Villages,

Florence, March 14. By the last Mail from Lombardy we are informed, that in Consequence

of Directions from the Court of Vienna, Difpositions are making at Placentia to divide the large Train of Artillery, Mortars, Ammunition and military Stores, taken in the last Campaign at that Place from the French, Spaniards, Neapolitans, and Genoese; one half of which is to be configned to the King of Sardinia. Recruits from Germany by the Tyrol daily join the Austrian Troops in Lombardy; and many Battalions of veteran Troops from Parma, Placentia, and other Garrison Places, have marched to join Marshal Schulemberg at Novi, who is making the necessary Preparations to begin his Operations against the City of Genoa; to which End frequent Councils of War are held by the Austrian and Sardinian Generals,

THIS Court being informed, that common Players of Interludes have, for several Years past, used and accustomed to assemble and meet together at or near a certain

Place near Hide-park, now called May Fair, within this City or Liberty, and to erect Booths, and act and exhibit Drolls and Shows, and use and exercise unlawful Games and Plays, whereby great Numbers of his Majesty's Subjects have been encouraged to allemble and meet together, and commit Riots and other Mildemeanors, in Breach of his Majesty's Peace, and to the Disturbance of the Neighbourhood of the Places aforefaid; and that some of the faid Players of Interludes, and other evil-disposed Persons, are now feeking out and contracting for Ground, in ofter to erect Sheds, Booths, and other Places in or near the Places aforesaid, and others of them are feeking out for Rooms, Parts of Houses, or Yards, for showing and acting such Plays and Drolls, and other Shows, and for carrying on and encouraging of unlawful Plays or Gaming, and for other unlawful Purposes: And whereas divers other evil-disposed Persons having taken upon themselves, in several other Houses and Places within this City and Liberty, to act or represent for Gain, Tragedies, Comedies, Operas, Interludes, Plays, Farces, and other Entertainments of the Stage, who have no legal Settlements in the Places where the same are acted or represented, or any lawful Authority so to do; And whereas all such Persons doing, acting, or representing the several Matters and Things before-mentioned, are deemed and declared Rogues and Vagabonds, and every fuch Person, as aforesaid, who shall represent any Interlude, Tragedy, Comedy, Play, Farce, or other Entertainment of the Stage, or any Part therein, having or not having such legal Settlement, are subject to the Forseiture of Fifty Pounds for every Offence; And whereas such Entertainments, Gaming, and Meetings, are carried on and practifed in Defiance of the Laws and Statutes of this Realm made for perventing the fame, and manifeltly tend to the Encouragement of Vice and Immorality, to the corrupting the Minds and Morals of the most virtuous and innocent Persons who frequent the same, to the debauching and ruining of Apprentices, Servants, and others of low Rank, as well as to the Disturbance of the publick Peace, by occasioning Riots, Tumults, and other Disorders; for the preventing of which for the future, It is thought fit and ordered by this Court, That it be, and it is hereby recommended and referred unto his Majesty's Justices of the Peace for the said City and Liberty, or any two or more of them, to order by Warrant under their Hands and Seals, as often as they shall think needful, and require the High Constable of the said City and Liberty to summon and take to his Assistance, from Time to Time, the several Petty Constables and Headboroughs, and Officers of the Peace within the same, (whom this Court doth hereby require to affift him therein) or so many of them as he shall think sufficient for that Purpose, and that he and they whom he shall so take to his Assistance, do apprehend all and every Players

of Interludes, Plays or Drolls, and all and every other Persons who shall exhibit or shewe any fuch Interludes, Plays or Drolls, or play at _____ encourage or procure any unlawful Game or Games to be played at therein, or thereabout, and every Person who shall keep any unlicensed Booth, Shed, or Place for the Entertainment or Encouragement of Persons who shall come to any of the Places aforesaid; and also that they apprehend all and every other Person and Perfons, who in any other Place or Places within the faid City and Liberty, shall act or represent for Gain, any Tragedy, Comedy, Opera, Play, Interlude, Farce, or other Entertainment of the Stage, who have or hath no legal Settlements or Settlement, in the Places or Place where the same are or shall be acted, represented, or exhibited, or have or hath no lawful Authority so to do; and that the faid High Constable, Petty Constables, Headboroughs, and all other Peace Officers, also search all Gaming-houses and Gaming Places, and apprehend all such Persons as they shall find therein practifing or encouraging any unlawful Gaming; and that such Officers do carry all and every Person and Persons so offending, before one or more of his Majesty's Justices of the Peace of the said City and Liberty, to the End they may be punished according to Law. And for the more effectual Suppressing the Evils aforesaid, it is hereby recommended unto his Majesty's Justices of the Peace for the said City and Liberty, or any two or more of them, to meet together at such Place. and Places, next or near to the Places where the said Offences shall be committed, and at such Time and Times as they shall appoint, in order to proceed according to Law against all such Offenders as shall be brought before them by any of the said Peace Officers, who are hereby required to be aiding and affifting to the faid Justices of the Peace, and to observe their Orders and Directions for the more effectual Suppressing and Preventing the Abuses aforesaids And it is further ordered by this Court, That this Order be forthwith printed and published in one or more of the publick News Papers, and that printed Copies thereof be also pasted up in proper Places, for the better Notification of the same.
