Copenbagen, April 15, N. S. His Danish Majesty has declared his Resolution to recal Count Dehn from the Court of Madrid, and to send him with the Character of Plenipotentiary to the Hague.

Head Quarters at Alphen, April 25.

The Junction of the Army is now formed. On Sunday last the Austrian Corps of 49 Battalions, 39 Companies of Grenadiers, and 63 Squadrons, came and encamped on the Right; the Dutch have already in Camp 24 Battalions and 34 Squadrons; and this Day the last Regiments of Hanoverians and Hessians came into Camp. It is expected the Army will march forward in three or four Days.

Hague, April 25, N. S. Our Advices of the French Operations in Dutch Flanders, by

Way of Antwerp, are, that Sluys capitulated last Saturday: The Reports of the taking of Philippine, and the Surrender of Ysendyke, are not confirmed. The People of Zealand shew the greatest Resolution for the Desence of their Country, and have been encouraged by the Arrival of Commodore Mitchell with four English. Men of War and a Bomb, so that there are now ten Ship's of War in the Roads of Flushing and The Inhabitants of the Island of Ramekens. Tergoes, or Zuyd Beveland, are armed, and prepared against an Invasion. M. de la Roque; who commands at Hulst, gives great Hopes of his being able to maintain his Posts in the District of Hulst, if the four Battalions and four Squadrons, to be embarked at Bergen-op-Zoom, can reach him. It is confirmed from Paris, that the French East India Fleet has been dispersed in a Storm; and we have Advices this Day, that M. de St. George, with three Men of War that went out as Convoy to this Fleet, is returned to the Isle d'Aic, and can give no Account of the rest. Advices from Provence of the 9th Instant say, that of three Barks that had retired into Agay, one had been taken by an English Man of War; she had on board 183 Men of the Regiment of Dunant; the two others got into Antibes, from whence the others, that had got in there before, were not yet sailed for Genoa. From Brussels we learn, that M. de Saxe set out last Thursday for Mechlin, Louvain, and Antwerp; and that he was to have an Interview with M. de Lowendahl, who commands the Expedition in Dutch Flanders. Last Sunday none of the French Troops had yet pitch'd their Tents. It is thought that M. de Clermont, with his Corps assembled about Sedan, instead of going to the Moselle, as was thought at first, will have Orders to draw towards Namur. A second Embarkation for Genoa, in the Ports of Provence, is talked of, and is to be commanded by M, de Boufflers.
