Y Letters from Nice there is Rea-fon to apprehend, that the French and Spaniards are again preparing to attack the Islands of St. Marguerite, and to pass the Var. The Islands are well fortified, and the Var at this Time of the Year is very much swelled by the Melting of the Snows in the Mountains. Rear Admiral Byng joined Vice Admiral Medley upon the 17th of last Month, O.S. at Vado. Capt. Holcomb, of his Britannick Majesty's Ship Nassau, has lately taken and fent into Savone two Transports of the Enemy, having on board 210 Spanish and French Soldiers and Officers. These two Vessels were Part of the first Embarkation, and had been driven into the Island of Corsica, from whence, after feveral Weeks Stay, they had taken the Opportunity of a fair Wind for attempting to run into Genoa. Marquis d'Ormea fet out this Morning for the Imperial Army, in order to concert every Thing with Count Schulemburg for the March of the Sardinian Battalions, which are to advance immediately to Sestri, and from thence to Bifagno. They are to be commanded by Lieutenant General Count le Roque, two Major Generals, and three Brigadiers, who are all ordered to repair immediately to Savona, where the Troops are to assemble, and from thence to join Count Schulemburg; and the two Admirals are preparing every Thing for transporting the Artillery to Bisagno.

But such Widows as live at too great a Distance from the Places above-mentioned, may apply by Letter to Mr. Thomas Riley Blanckley, at the Admiralty Office, who will send them all necessary Information. And the Governors of the said Charity intending to distribute to the Widows of Sea Officers who died before the 30th of August 1732, as well as to the Widows of those who died since that Time, whose Circumstances come within the Rules of the Establishment, such Monies as may be due to them on the 31st Day of May next; This is to give Notice, that any Widows who have not yet applied, and intend to lay in their Claims, may do so as foon as possible; and that all such Widows whose
