**O**N the 7th Instant the General Assembly of the Church of Scotland met at Edinburgh, and chose for their Moderator the Reverend Mr. Robert Kinloch. His Majesty's Commission to the Right Honourable the Earl of Leven was read, as likewise his Majesty's most gracious Letter to the Assembly. A Committee was appointed to draw up a dutiful Answer to his Majesty's Letter; which having been transmitted by the High Commissioner to his Grace the Duke of Newcastle, one of his Majesty's Principal Secretaries of State, was presented to his Majesty, who was pleased to receive the same most graciously. It is as follows.

*May it please your Majesty,*

**Y**OUR Majesty's Goodness in taking Notice in your gracious Letter to this General Assembly, of the Loyalty and Affection of the Church of Scotland to your Royal Person and Government, particularly on Occasion of the late unnatural Rebellion, the happy Extinction of which gives us the highest Joy, we esteem as the greatest Honour that could be done us: And as our unshaken Zeal for the Service and Support of your Majesty's Government and Royal Family, is the natural and just Effect of your Majesty's unwearied Care for the Support, Defence, and Protection of your Subjects, in the full Enjoyment of all their Rights and Privileges both sacred and civil; we look on it as our Duty to manifest it on all Occasions, especially in the Meetings of our General Assembly, and place on it our Hopes of the Continuance of your Royal Favour to us, and of our Happiness under your auspicious Reign, which we pray God may long continue and prosper.

Your Majesty's kind Assurances of maintaining and protecting the Church of Scotland in the full Enjoyment of all their Rights and Privileges, do lay such Obligations on us to our Duty, as we shall endeavour better to express in the Course of our Actings, than now we are able to do by Words.

Your Majesty's Choice of the Right Honourable the Earl of Leven to represent your Royal Person in this Assembly, is most acceptable to us, he, following the Example of his noble Ancestors, having given the Church of Scotland many Proofs of his Adherence to their Interest, as well as of Fidelity, Abilities, Diligence, Prudence, and Affection to your Majesty, in the Discharge of that important Trust.

We shall, on our Part, be wanting in Nothing that may be necessary for attaining the wished-for Success to your Majesty's tender Care and Concern for the Advancement of Religion and Piety, and hope, by the Blessing of God, to attain those good Ends for which we are at this Time assembled.

We acknowledge with humble Thankfulness your Majesty's great Goodness, in renewing, at this Time, your Royal Bounty for the Reformation of the Highlands and Islands, and committing the Distribution of it to our Care, of which your Majesty's High Commissioner has given us Notice; and we shall endeavour to execute that Trust with Fidelity, Prudence, and Exactness, suitable to the Confidence your Majesty is graciously pleased to repose in us.

We beg Leave to add, that we daily put up our fervent Prayers, in Private and in Publick, to Almighty God, that as Divine Providence was graciously pleased to place your Royal Family on the Throne of these Realms, for their Deliverance, Protection and Defence from the threatened Calamities of Popery, Slavery, and Arbitrary Power; it may likewise please the Divine Goodness, in Reward of your Majesty's tender and fatherly Care for the Religion, Laws and Liberties of your Subjects, to pour down in Abundance, Heavenly Blessings on your sacred Person, on his Royal Highness the Prince of Wales, his Princess and Royal Issue, and on all the Branches of your Royal House, and in particular for the Safety and Preservation of his Royal Highness the Duke, now in the Field at the Head of your Armies; and that Victory and Success may attend the distinguished Courage, wise Conduct, and indefatigable Application, with which his Royal Highness generously exposes his precious Life for the religious and civil Interests of his native Country, and the Liberties of Europe. *Edinburgh, May 9, 1747.*

*Hague, May 18, N. S.* By all Accounts from Paris they are much struck at the News of the Revolution in this Country: The French King's Departure for the Army was still put off, and

and began to be very dubious. M. De Boufflers failed from Marseilles with several Transports, was attacked by some English Ships of War; some of the Transports and Part of his Equipage were taken, and the Ship he was in is supposed to be got into Monaco, or one of the Ports of the State of Genoa. The Brest and Rochelle Fleets are not yet failed. M. de Noailles is arrived at Brussels; and it is said that the Abbe de La Ville is along with him. The last Advices they had at Paris from Genoa were of the 3d, and the Siege was then upon the Point of beginning, as the Difficulties for bringing forward the heavy Train were removed. The Quarter Masters were sent last Monday from Brussels to mark out a Camp between Louvain and Mechlin. The French Troops were still cantooned, as also the Corps under Count Clermont in the Neighbourhood of Maestricht. The Prince of Orange set out Yesterday from hence for Zealand, by Way of Rotterdam, when he went on board his Yacht, and was followed by several others of the States General, and the States of Zealand.

*Hague, May 23, N. S.* Yesterday's Letters from Brussels inform us, that the French Troops were getting in Motion, in order to encamp between Louvain and Mechlin: Count Lowendahl was continuing without Intermision to augment and improve the Fortifications of Antwerp, where his Garrison camps in the Outworks. The Garrisons of Ostend and Bruges are marched out towards Sas van Ghent. By an Order of Battle of the French Army in the Netherlands, publish'd at Ghent, and including Garrisons and all, the same amounts to 247 Battalions, and 284 Squadrons, without any Mention of the Number of Men in each Battalion and Squadron. They write from Rochelle on the 11th, that a Fleet of 35 Sail, several of which were Ships of Force, went out to Sea the Day before from that Port; and that some Ships, which arrived there two Days before the Departure of this Fleet, had seen, about twelve Leagues from the Coast, in one Place, four British Men of War, and at a small Distance from them seven more. Advices from Genoa by the Paris Letters of the 19th say, that M. Boufflers was arrived safe there, though with no more than five Persons in his Company. And according to Accounts from Turin of the 8th, by the same Way, the Austrians had made themselves Masters of the Height called the Two Brothers, by which the Siege would be very much shorten'd. There was no Army yet assembling in Provence. Every Thing was ready on the 9th for the Attack of Fort St. Marguerite, which was to be attempted with four Gallies, two Galliot, two Bomb Vessels, two armed Barks, forty Feluccas, fifty Transports, two Fire Ships, and two hundred Boats. This numerous Armament was got together in the Port of Cannes; and five British Men of War were within Sight of the Coast waiting for them.

*Flushing, May 21; N. S.* Upon the 19th Instant His Highness the Prince of Orange arrived at Campveer. The same Day he went to Middlebourg, and Yesterday took the usual Oaths and his Seat in the Assembly of the States, and

is now hourly issuing Orders. The Joy of People of all Ranks is inexpressible. Yesterday Commodore Mitchel was introduced to his Highness, and received with extraordinary Distinction. It is not known how long his Highness will remain here. By all Accounts the French are continuing with Diligence their Preparations for the Invasion of this Province, but our Preparations for Defence keep Pace with theirs to invade us. The Garrison of Axel, and the Troops that were in that Island, are arrived in South Beveland, where there are now said to be above 10,000 Men under the Command of Lieutenant General Smiffaert. Brigadier Douglass commands the English in the Place of Major General Fuller.

*Flushing, May 23, N. S.* General Huske arrived this Afternoon with the Battalion of the Guards, and immediately waited upon the Prince. Orders are given to raise Batteries in South Beveland. To-morrow, or next Day, Admiral Mitchell will go further up the River, with Admiral Welschut of Zealand, and Vice-Admiral Schryver of Holland, who is just arrived. Nothing certain is come from our Army; and no News from the Enemy's Quarters.

*Flushing, May 24, N. S.* Major General Huske, with the Transports, anchored in this Harbour Yesterday in the Afternoon; and the Prince of Orange being arrived here, Major General Huske immediately waited on his Highness, who received him very graciously. The Dutch Admiral, Schryver, with Commodore Mitchel, is to go To-morrow to take a View of the opposite Coast, in order to station their several Ships. The Battalions of the Royal's, Braggs, and the Highland Regiment, continue cantoon'd in South Beveland, under the Command of Brigadier General Douglas.
