HEREAS there was this Day read at the Board & Report made by his, Majesty's Attorney and Spllicitor General to the Lords Commissioners of his Majesty's Treasury, upon con-siderine, Therestuation from the Committee oners of the Excise, together with several Papers thereto annexed, relating to the audacious Behaviour of the Smugglers in the Counties of Kent and Sussex, who assemble in great Bodies, and go armed to affift in the Smuggling and Receiving of Run Goods, and not only menace the Magistrates, but resist the Officers of the Revenues in the Discharge of their Duty: Which Report is as follows, viz-

To the Right Honourable the Lords "Commissioners of his Majesty's Treasury.

May it please your Lordships, IN Obedience to your Lordships Commands, fignified to us by Mr. West in his Letter of the 23d Instant, transmitting a Representation of the Commissioners of the Excise, of the audacious Behaviour of the Smugglers in the Counties of Kent and Suffex, and of their Menaces to the Justices of the Peace, the Officers of the Revenues, and all others who shall dare to obstruct their outra-"geous Proceedings: By which Letter we are directed to take the said Representation and the Papers annexed into Confideration (which 44 are all herewith returned) and report to your Lordships what Powers there are at present for any of his Majesty's Officers, either Civil or Military, to resist and subdue those Of-"fenders, and to prevent the like for the fu-"ture by Force, as all other Means have hitherto proved ineffectual to that End.

We have taken the same into Consideration, and are of Opinion, that all his Maiesty's Subjects, both Civil and Military,
Magistrates, Officers and Private Persons, 66 have, without any express Warrant for that "Purpose, Authority to seize and apprehend 44 any Persons assembled, armed, and acting, or who have assembled, armed, and acted in such Manner as described in the aforementioned Representation and Papers, and bring them before a Magistrate, who may commit them % to Prison; and in the seizing, apprehending, fecuring, and committing them to Prison, may reper rule, with Fare and justify any Violence or Hostilities which may be necesfary to suppress and subdue them, or bring them to Justice.

"The Powers abovementioned are vested in 55 all his Majesty's Subjects generally for the er Preservation of the Peace. But the Justices of the Peace and Peace Officers are, both "by the Nature of their Office, and the exof press Direction of diverse Acts of Parliament, bound to suppress all Riots, unlawful Assemblies and Breaches of the Peace, of which the " Offences complained of are notorious Ines stances. And the Neglect of it is a high Misdemeanour, for which they are accountable " in a Criminal Profecution.

"The Law has likewise for this Purpose furnished them with Strength and Force as well s Authority, by empowering and commanding them to use the whole Power of the « County, that is, to call all or any 46 his Majesty's Subjects, except Clergy, capable of Arms, to affift them, and, as Part of those Subjects, they may command, and take "the Assistance of any Military Force in those

re Parts, who, and all others, will be fully juses tified in any Acts of Violence they shall do "against the Offenders. "As to the preventing the like Offences for the

"future, the Law has already made them very especially by an Act of the last Ses-"fions, by which the assembling and going armed to the Number of Three, to assist in any

ee Sort

Sort of Smuggling, or receiving or protecting Run Goods, or in rescuing Prisoners guilty of Felony, by the Laws relating to the Customs or Excise, and the resisting the Officers of those Revenues, by the like Number of armed Persons, are made Felony without Benefit of the Clergy; and, in which Act, par-"ticular Provisions are made by great Rewards and otherwise, for the apprehending and bringing such Offenders to Justice. " we don't know what further can be done, than by keeping a sufficient Force in those Parts, and giving strict Orders to all Officers, 66 Both Civil and Military, to use that Force in Support of the Laws, and suppressing, sub-" duing, and bringing to Justice all such Ofsee fenders, and by seeing that such Orders be obeyed,

Ulm, June 12, N. S. This Mörtting we reecived Advice from Italy, that in the Night between the zoth and zist of:last Month, General Schulemberg, who commands the Austrian Army before Genoa, attacked the high Ground contiguous to Pontcevera in five Columns; and that notwithstanding the advantageous Situation of this Post under the Cannon of Genoa, and cover'd by the Mountain upon which the Troops of the Republick are encamped, the Austrians made themselves Masters of it before Break of Day; and being afterwards attacked with all the Force which the Duke de Boufflers could possibly bring against them, they had kept their Ground with the Loss of about fixty Men, killed and wounded, having killed Five Hundred of the Enemy, and made Fifty Prisoners, amongst whom is the Marquis de Grimaldi. The Possession of this important Post opens a Passage for the Austrian Artillery to Sestri, and twelve Pieces of Cannon were alteady arrived there.

Ulm, June 6. Letters from Italy confirm the News lately received from Genoa, and say the Austrians are now Masters of all the Hills about

that City.

Head Quarters at Bouwel, June 13, N. S. The Corps de Reserve, under Prince Wolfembuttle, has made a Motion this Morning to our Lest, and will encamp this Night upon the Great Heath behind Westerloo. General Baroniai with his Corps of Irregulars and the Regiment of Styrum's Dragoons, are advanced to Sichem on the Demar, where he will be better situated than before, to observe the Motions of the Enemy, who by their Preparations seem to point towards Maestricht; they have given out amongst their People, that their Design was to attack the Allies in their Camp; but that Report gains but little Credit.

Since the French King's Arrival at the Army, the Works along the Dyle have been considerably augmented; and they act with so much Caution, that they have thrown up a Sort of Parapet all along the Front of their Camp, between the Redoubts which had been made before.

The 11th and Yesterday a large Body of Troops moved to the Right, and the Corps under the Comte de Clermont moved back again towards the Meuse; it is said the Troops marched towards their Right are 10,000 Men, and in Conjunction with Clermont's Corps are intended to attempt the Siege of Maestricht.

The French King is still at Brussels, and they give out now, that he will fix his Head Quarters at Louvain, when he leaves that Place: Their Horse are to encamp the 16th, the Dragoons being already moved out: They are continually

changing the Garrison of Antwerp, though they seldom have sewer than twenty Battallions in the Town.

The Imperialists and French Generals, appointed for settling the Exchange of Prisoners, have had several Meetings within these sew Days, and for the Security of both Parties, a Cessation of Hostilities was agreed on within such a District, which was between Dussel and the Right of Lier: To-morrow that Cessation is at an End. The Imperial Troops, which will be released on this Occasion, are intended to join the Allied Army, and will amount to fix or seven Battalions.

The Recruits for the Austrian Cavalry arrive daily; they are perfectly well mounted and

arm'd, and make a fine Appearance.

Prince Saxe Hildburghausen, with the Detachment of the Army, is still encamped at West West; the Posts which the Enemy had at Mexem, Eckeren, and the Villages on this Side Antwerp, are all withdrawn.

Hague, June 13, N. S. General Ligonier arrived here on Sunday Morning, and immediately had an Audience of the Prince of Orange; he proposes to set out for the Army To-morrow Morning. Marshal Saxe has recalled the Body of Troops under M. de Clermont, and likewise those that were in Dutch Flanders, except about 6000 Men that are left there to guard the Towns. M. Van Hoey has had his Audience of the Prince of Orange. An Express arrived last Sunday from Hesse Cassel, with the Consent of that Court relating to three Battalions of Foot, and one Regiment of Dragoons, which the States General are to take into their Pay, amounting to 3040 Men. [The Corps under Count Clermont is marched towards Wayre with 26 heavy Cannon, besides their Fieldpieces: They have been joined by the Regiments of Alface and Naslau Sarbruck, so that they are now 20 Battalions and 34 Squadrons. By Letters from Brussels of the 11th, the French Cavalry quitted their Cantonments on Thursday last, and joined the Grand Army, whose Center is at present at Wakezele, with their Left at Malines, and their Right at Louvain. The Letters from Paris pretend, that they had private Advices from Provence, that Marshal Belleisle's Army was upon the Var; that the Head Quarters were at Cannes; and that the Marshal only waited for the Spaniards advancing to pass that River.

Captain Harland, of his Majesty's Ship the Tilbury, who arrived in the Downs Yesterday with the Trade from Portugal, gives an Account, that on the 7th past, Captain Cosby, of his Majesty's Ship the Shoreham, one of the Ships of Vice-Admiral Anson's Squadron, brought into Lisbon a Ship and a Brigantine laden with warlike Stores, being two of the Convoy who escaped from the said Vice-Admiral on the 3d of May.

Captain Harland also gives an Account, that on the 3d Instant, as he was coming up the Channel with the Vultur Sloop, he saw a French Dogger Privateer between Portland and the Isle of Wight, to which he ordered the Vultur to give Chase, who in three Hours came up with and took her, and has sent her into Weymouth. She proves to be the L'Huitre of Cherburgh, with two Carriage and ten Swivel Guns, and 32 Men, and had been but two Days out of Port.

Conditions of Admission into the General Hospital at Bath.

1. HE Case of the Patient must be described by some Phy-fician or Person of Skill in the Neighbourhood of the fician or Person of Skill in the Neighbourhood of the Place where the Patient has resided for some Time; and this Description, together with a Certificate of the Poverty of the Patient, attested by some Person of Credit, must be sent in a Letter, Franked or Post-paid, directed to the Register of the General Hospital at Bath.

The Age of the Patient ought to be mentioned in the Description of his Case; and the Persons who describe, are desired to be particular in the Enumeration of the Symptoms; that so neither improper Cases may be admitted, nor

proper ones rejected.

II. After the Patient's Case has been thus described, and fent, he must gemain in his usual Place of Residence, till he has Leave to come, signified by a Letter from the Register; who will, at the same Time, send a blank Parish Certificate.

IH. Upon the Receipt of such a Letter, the Patient must set forward for Bath, bringing with him this Letter, the Parish Cer-

tificate duly executed, and Three Pounds Caution Money. IV. Soldiers may, instead of Parish Certificates, bring a Certificate from their Commanding Officers, signifying to what Corps they belong, and that they shall be received into the same Corps, when discharged from the Hospital, in whatever Condition they are, But it is necessary that their Cases be described, and sent previously; and that they bring with them three Pounds Caution Money.

The Intention of the Caution Money is to defray the Expences of returning the Patients, after they are discharged from the Hospital, or of their Burial in Case they die there. The Remainder of the Caution Money, after these Expences are defray'd, will be return'd to the Person who de-
