Copenhagen, July 11.

Denmark was happily brought to Bed of a Princess, who was baptized the same Evening, and named Wilhesmina Carolina, after the late Queen of Great-

Britain, her Danish Majesty's Mother.

Hague, July 14. The States General have published a Placart, to prohibit the Exportation of all Provisions and warlike Stores from these Provinces, unless they are intended for the Service of the Allied Armies, their East and West-India-Companies, or the Colonies belonging to the Republick. There is Advice, that the Officer who commanded at Sandvliet, had retited with his Gartison, upon the Dispositions the French had made to storm that Place. This is looked upon as the Forerunner of the Siege of Bergen-op-Zoom, but as the Inundations are compleated, and especially that from the Sea, they don't appear to be under much. Apprehension. They are likewise preparing at Breda to receive the Enemy, by cutting down the Trees, and demolishing all the Houses within the Approaches of that Place.

Hague, July 18. The States General came Last Saturday to three Resolutions: The first, to prohibit the Exportation of Horses under very severe Penalties. The second is an Order to arm not only the Inhabitants of Breda, Boisleduc, and other Towns of the Generality, but likewise every Tenth Man of the Peasantry, and these last are to be directly regimented for the Defence of the abovementioned Places. The third Resolution absolutely prohibits all Treaties with the French Army about Contributions; with strict Orders to refuse Pioneers, Horses, Waggons, or any Thing else, that may happen to be required of them. M. de Lowendahl's Corps has been lately reinforced by nine Battalions from their main Army, and they opened the Trenches before Bergen-op-zoom in the Night between the 14th and 15th Instant. The Garrison con-

fifts of 24 Battalions and 14 Squadrons, and the Prince of Saxe Hilbourghausen is posted very advantageously in the Lines. Prince George of Hesse Cassel arrived here last Saturday; he is come to make a Visit to the Prince of Orange. It is said that Count Maurice of Nassau is to have the Command of the Prince of Orange's Life Guards. The Letters that came in this Day from Paris mention, that the Duke de Boussers died lately of the Small Pox at Genoa. Several Sail of the Homeward bound St. Domingo Fleet are arrived at Brest, and other Ports, as also the Men of War their Convoy.

Hague, July 21. By Letters from Liege we learn, that the Erench Army still continues in the same Position, as well as the Corps upon the Banks of the Meuse under Count Clermont and M. d'Etres. It is generally reported that the French began firing upon Bergen-op-zoom the Night before last, but that they are very briskly answered from the Garrison. They had at Paris the News of the raising of the Siege of Genoa, and of the Castle of Ventimiglia's having surrendered the 1st Instant, the Garrison Prisoners of War. M. de Belleisle has detach'd Part of his Army to try to penetrate into the State of Genoa.

Flushing, July 22. Fort Lillo is still in Possession of the Dutch, and hath been lately supplied from the Ships with Men, Provisions and Water. The French carry on the Siege of Bengen-op-zoom with great Vigour, and took Post at the Foot of the Glacis the third Day, from their opening the Trenches. The Townfired upon them very briskly with their Cannon-

and Mortars.
