HE French quitted the 4th their Camp opposite to Maestricht, to occupy one near Tongres; and an Officer just arrived from the Lines of Bergen-op-Zoom says, that a Letter has been received there, mentioning, that the Allied Army had taken the Camp which the French had abandoned. The Accounts from Bergen-op-Zoom are, "That about One o'Clock of the Morning of 46 the 16th, the Enemy sprung a Mine under the Lunette of Zealand, and soon after attacked it, got Possession of the Breach, and made a Lodgment: They continued there perfecting 46 their Work till Eight o'Clock, when we made. of an Attack to regain the Breach, in which we " succeeded, and continued Masters of it for 66 half an Hour; during which Time we deof molish'd a good Part of their Lodgment, and made a Breast Work against them, but were immediately driven off again by the Enemy returning to the Assault, who have fince continued Masters of it. That Night of the 16th a Sortie was made by four Officers and 100 Voluntiers from the Tambour, an Entrenchment in the Gorge of the Lunette of " Zealand; but three of the Officers being "kill'd or wounded by the first Fire of the Enemy, they were put into Confusion, 46 and oblig'd to retire without effecting any "Thing. In the Night of the 17th the French stacked three different Times the Tambour of the Lunette of Zealand, but were repulsed by the Hessians, who behaved extremely " well. The Garrison had sprung two Mines, " which had a very good Effect. The Enemy 66 had erected two new Batteries of Cannon and one of Mortars."

Hague, August 22, N.S. The chief Business at present at Bergen-op-Zoom, on both Sides, is Mining and Countermining, and defeating the Schemes of each other under Ground. It was after springing one of their Mines Yesterday was S'en-night, that the Enemy sound Means to lodge themselves upon one of the Faces of the Lunette of Zealand. The Garrison

Garrison still continues in Possession of the Tambour and Traverses of that Lunette. That very Evening 300 of the Enemies were blown up, and 40 of them, with a Captain of Saxe's Regiment, were thrown into the Fosse of the Town. On Saturday Night the Besiegers sprung a Mine at the Angle of the Lunette of Utrecht, and storm'd it directly, but were repulsed with great Slaughter, and could only lodge themselves at the Foot of it. The Enemy, it is said, must be at least Masters of these two Lunettes before they can pretend to batter in Breach. The greatest Efforts are therefore now made on both Sides to attack and defend those two Works. Another of the Enemy's chief Attempts is, to destroy by their Mines the Gallerie Majeure, that keeps a free Communication between all the Works of the Town. They have fprung feveral Mines for that Purpose with no Sort of Success, except it be the very first Mine they play'd, which occasioned several considerable Cracks in the Vault, but that has been fince remedied in a great Measure by supporting it with large Props of Timber. The Enemy attempted again last Saturday to burst the Gallery at the Point of the Cover'd Way, facing the Angle of the Bastion of Coehorn, but the only Success they had was burying a Couple of Miners, and bursting a small Branch or Rameau belonging to one of our Mines. General Cronstrom is now very busy in making the necessary Dispositions for defending himself to the last Extremity, in order to dispute the Ground Inch by Inch with the Enemy. The Loss of the Besiegers, from the Beginning to last Saturday, is thought to amount to 9000 Men. The Attack against Fort Rover was renewed last Friday Night, but as the Enemy has but one Battery of four Pieces of Cannon left there, it is imagined their Design is chiefly to make a Diversion, and oblige us to employ a greater

meet with less Opposition on the Side of the Town, the Day they intend to celebrate the Feast of St. Louis, which falls upon next Friday. The Letters of this Day from Paris tell us, that the French King is resoved to quit his Army on the 1st of September, whether Bergen-op-Zoom is taken or not. M. de Saxe has lately detached to the Assistance of M. de Lowendahl, three Brigades of Infantry, and two of Cavalry. We learn by Colonel Yorke, who arrived this Evening from the Grand Army, that his Royal Highness the Duke has likewise made a Detachment of 15 Battalions. The French had erected a Battery at Burghvliet, which raked the Banks of the River on that Side, but a Battery raised by the Besieged has quite silenced it.

Hague, August 23, N. S. The News received this Morning from Bergen op-Zoom is favourable: The Enemy have indeed sprung a Mine, by which they have damaged a farther Part of the main Gallery opposite to the Ravelin Dadem, where they endeavoured immediately to form a Lodgment; but the Garrison made a Sally, in which, after a long Struggle, they had the good Success to dislodge them entirely, having torn away 50 of their Gabions, filled up their Works, and destroyed every Thing that came to oppose them.

Extract of a Letter, dated at Saftingen Road, Aug. 11, O. S. The Enemy has sprung several Mines, by which they have ruined Part of the main Gallery, and made their Lodgment better in the Lunette of Zealand, and are now approaching the Ravelin of Dadem, which there is Reason to think they are mining under. There has been less firing than usual these two Days past, which 'tis believed is occasioned by their now keeping closer to their Mines; at the same Time they have erected three Works, from whence they throw great Quantities of Stone into the Coehorn and Pucelle Bastions. Five this Morning the Enemy sprung two Mines before the Ravelin of Dadem, which destroyed Part of our Gallery, and made two Descents into the Fosse before Dadem. A Mine of ours was sprung before the Bastian of Coehorn, which had a good Effect, several Bodies having been seen in the Air. Major General Huske set out from Bergen towards the Duke's Army Yesterday.

Extract of a Letter from Bergen-op-Zoom, dated Aug. 12, O. S. At Ten o'Clock the Enemy attacked Dadem, but were repulsed. At Eleven o'Clock there arrived an Express with the agreeable News, that the Generals Baroniai and Trips have defeated St. German's Party, and surrounded the Rest, and have it now in their Power to destroy most of their Artillery. This Morning at Six o'Clock the French blew up a Mine at Coehorn, but without Success. About Eight a Mine of ours was blown up with as great Success as ever; it is reckoned the Enemy

lost some Hundreds, kill'd and wounded, and that they are put so much backward in their Works, that it will require two Nights to bring them to their former State. There arrived Yesterday Ninety Miners, who worked the whole Night to discover their other Mines. This Day the Ships with the Artillery arrived, which brought three Twelve Pounders, two of which are already placed on the Kyk-en-de-Pot, and fire on the Enemy. This Day at High Water twelve Twenty-four Pounders are expected.

Extract of a Letter, dated at Flushing, Aug. 13, O. S. Yesterday the French took from Sluys all the Bomb-Shells and Gunners, and went directly to Bergen with them; and there are not above 400 well Men now left in the former Place.
