A T the Court at Kensington, the 8th Day of September, 1747,

PRESENT,

The King's most Excellent Majesty in Council.

Hereas on the eighteenth Day of June last his Mario pleased, by his Order made in his Privy Council, to establish several Rules, Orders, and Regulations, for the better preventing the Spreading of the Distemper amongst the Horned Cattle; Which Rules, Orders, and Regulations were thereby directed to be carefully obferved, and to continue in Force for and during the Space of three Calendar Months, to commence from the first Day of July last: And whereas his Majesty hath received Information, that the said Distemper hath of late greatly increased, and extended itself into many Parts of this Kingdom which had been entirely free therefrom; and that this had been occafioned chiefly through the Neglect of the Officers appointed to carry the faid Rules, Orders, and Regulations into Execution; —His Majesty taking the same into his most serious Consideration, and being defigures of doing every Thing in his Power towards putting a Stop to the said Distemper, which, if not timely prevented,

may end in the entire Destruction of the Horned Cattle, hath therefore thought it proper, by and with the Advice of his Privy Council, to order, and it is hereby ordered, That a Prohibition be laid on the Buying, Selling or Removing of all lean Horned Cattle, not only in those Counties where the Distemper now is or may hereafter happen to be, but in all the Counties throughout England; and to that End, that no Person do, from and after the twentieth Day of this Instant September, send, drive or remove, or cause to be sent, driven or removed, any Ox, Bull, Cow, Calf, Steer or Heifer, out of any Town, Parish or Extraparochial Place, to any other Town, Parish, or Extraparochial Place whatsoever, within that Part of Great Britain called England, or do buy, sell, or expose, or offer to Sale, or cause to be bought, sold, or exposed, or offered to Sale, any Ox, Bull, Cow, Calf, Steer, or Heifer, in any Fair, Market, Town, Parish or Extraparochial Place whatsover, except only fatted Cattle ready for immediate Slaughter. Provided nevertheless, that nothing herein containeds is meant or intended to take away the Liberty granted by his Majesty's Order of Council of the 18th of June last, for removing Cattle from one Pasture to another, though the same should be in different Parishes, or to drive Ox-Teams in any kind of Carriages from one Parish or Place

Place to another, provided the several Conditions, required by the said Order of Council in the said respective Cases, be in all Things strictly and duly complied with.

And for the greater Certainty that the fatted Cattle are not infected, or come from any infected Place or Herd, his Majesty doth hereby further require and command, That no Person or Persons whatsoever do buy, sell, or expose, or offer to Sale, or cause to be bought, fold, or exposed, or offered to Sale, any such fatted Cattle, unless the Person or Persons driving, sending or removing, or selling such Cattle, do deliver, or cause to be delivered to the Person or Persons who shall buy the same, a Certificate under the Hand and Seal, or Hands and Seals, of one or more Justice or Justices of the Peace for the County, Riding, Division, City, Liberty or Town Corporate, or of one or more Commissioner for Commissioners of the Land-Tax; qualified to act herein, for the County, Riding or Division, where the Town, Parish or Extraparochial Place shall lie, from whence such Cattle shall be driven; or (in Casa no Justice of the Peace, or Commissioner of the Land-Tax as aforesaid, shall be refident at that Time, within three Miles of such Parish or Place) of the Rector, Vicar, or Curate of such Parish, or of some neighbouring Parish, attested by one of the Churchwardens on Overseers of the Poor of the Parish or Place from whence such Cattle shall be brought or remov'd, specifying the Name or Names, and Place or Places of Abode of the Person or Persons selling the same; and that upon Examination on Oath, of one or more credible Person or Persons, it apo peared to him or them that the said Cattle, and the Herd or Herds out of which the same was or were taken, was or were at that Times and had been for the Space of two Calendar Months before the Date of such Certificate, entirely free from the said Distemper or Insection, and that such Beast or Beasts had been in the actual Possession of the Person or Persons selling the same, for the Space of two Calendar Months at least before the Sale thereof, which Certificate the Person or

Persons buying such Cattle shall produce, being thereto required, by any Justice of the Peace, or Commissioner of the Land-Taxas aforesaid, or other Officer empowered to examine Persons relating to Certificates.

And for the better preventing the Spreading of the said Distemper, by the Sale of lean Cattle, under Pretence of their being fatted and ready for Slaughter—His Majesty doth hereby surther order, require; and command, That all Butchers, and every other Person or Persons, who after the twentieth Day of this Instant September, shall buy or cause to be bought any of the aforementioned Cattle, shall kill or cause the same to be killed and slaughtered within the Space of ten-Days after he or they shall have bought the said Cattle, or caused the same to be bought.

And his Majesty doth hereby Order and Direct, that the aforegoing Rules and Regulations, and also those contained in his Majesty's Order of Council of the Eighteenth of June last, (except only such Parts thereof as may be varied by this present Order) do continue and be in Force for and during the Space of three Calendar Months, to be computed and begin from the Twentieth of this Instant Sep-

tember.

And his Majesty doth hereby recommend it in the strongest Manner, to all his Justices of the Peace, and to the Commissioners of the Land-Tax as aforesaid, and also to all Constables, Churchwardens, Overseers, and Inspectors, that they be careful and diligent, in causing all the Rules, Orders and Regulations aforementioned, to be strictly observed, and carried into due Execution—And that all Farmers, Cowkeepers and others, do conform themselves thereto.

And his Majesty taking Notice, that notwithstanding the Justices of the Peace and Commissioners of the Land-Tax as aforesaid, were directed by his Majesty's aforementioned Order of Council of the 18th of June last, to transmit to his Privy Council, from Time to Time, a particular Account of their Proceedings in Pursuance of the said Order, yet that the same hath not been complied with; His Majesty doth therefore hereby strictly charge and

enjoin

enjoin the Justices of the Peace, and Commissioners of the Land-Tax as aforesaid, that they do not fail complying with his Majesty's Commands, so signified by his said former Order, upon Pain of his Ma-

jesty's Displeasure.

And for the better notifying of this Order, it it his Majesty's Pleasure, that the same be forthwith printed and published, and be also inserted in the next London Gazette, and be likewise read, together with the said former Order of Council, in all Parish Churches, Chapels, and other Places set apart for Divine Worship, on the first Sunday after the Publication hereof, and on such Sunday in every Calendar Month as the Minister of such Church, Chapel, or other Place, shall think proper, agreeable to what is required by an Act passed in the last Session of the last Parliament.

Copenbagen, September 9. The Coronation of the King and Queen of Demmark was celebrated at Fridericksbourg, on the 4th Instant, with great Solemnity and Magnificence. The Ceremony of at nointing

nointing and confectating was perform'd by the Bishop of Copenhagen, assisted by those of Christiana and Aalburg. Three Ministers of the Council, and General Arnold, and General Scholsen have received the Order of the Elephant, and the Grand Marshal, M. Molck, has the Title of Privy-Councillor.

Copenhagen, Sept. 12. Preparations are making for the Reception of their Danish Majesties To-morrow or next Day at Jagersburg, where his Majesty proposes to hunt for the rest of the Season.

Head Quarters at Richel, Sept. 14. The French Regiment of Orleans, Dragoons, that was posted on the Maese between Liege and Huy, has been surprised by General Trips, and almost entirely ruined. This Accident so alarmed the Enemy, that they immediately marched a Body of 10,000 Men to oppose our passing the River, as they imagined we were going to do. We have received a Reinforcement of three of his Majesty's Electoral Battalions; and the other two will arrive this Week, as well as two thousand two sundred Austrian Prisoners, who have been returned this Day by the French.

Hague, Sept. 19, N.S. We have received here the following Account from Bergen-op-Zoom. The Enemy began their Attack on the 16th Instant about Four in the Morning, by springing a Mine before the Ravelin of Dedem, throwing an immense Quantity of Bombs, and firing at once from all their Batteries. In the mean Time, Fifty Companies of Grenadiers, supported by Sixteen Battalions, threw themselves into the Fossé; and having cut off the Communication between the Outworks and the Town, some attack'd the Ravelin of Dedem by the Breach, whilst others got into it from behind, and soon made themselves Masters of it. At the same Time, they Forced their Way through the Sally Ports, scaled the Walls of the Town with their Ladders, and mounted the narrow Breaches of Pucelle and Cohorn, and entirely possessed themselves of those Works. The Enemy's Colours were flying in the Market Place, when the Prince of Hesse Philipsthal appeared with

some Troops he had got together to stop their Progress. The Regiment of Deutz, that was to march into the Lines that very Morning, was then under Arms, which gave Time to the other Troops to assemble, otherwise the whole Garrison might in all Probability have been cut off. The Prince of Philipsthal, who was wounded in the Leg, did his utmost to repulse the Enemy, but to no Purpose, he being obliged at last to give way to their Numbers, and to make his Retreat with great Difficulty through the Gate of Steenbergen. General Cronstrom was so near being taken in his Quarters, that it is faid he was obliged to abandon his Papers and the Military Chest. The Enemy did not pursue the Garrison any farther than the Gate that leads to Steenbergen, which they immemediately closed upon them. During. the Storm against the Town, there was a false Attack all along the Lines, and against the three Forts, which were abandon'd one after the other, as the Garrison of Bergen-op-Zoom and the Troops in the Lines retired towards Steenbergen. The Loss of the Garrison upon this Occasion is not yet known. General Cronstrom is now at Oudenbosch; where he has taken upon him the Command of the Army. The Prince of Hesse Philipsthal arrived here this Morning in a Yacht; and it is hoped will recover of his Wounds. This Day General La Rocque, late Governor of Hulst, was committed to close Custody, by an Order from the Council of State.
