Florence, September 5.

Ount Richecourt is gone to visit the Roads between this Place and Road thither without pain make a new Mountains. This is designed to facilitate the Transportation of Goods and Merchandizes into Lombardy, and Germany in particular, and if the Plan can be executed, such Merchandizes will be brought by the River from Leghorn to Signa, a Place some Miles distant from Florence, and from thence cross the Country towards Bologna and Ferrara, without paffing through this City. In Consequence of this Scheme, and to render it more perfect, Barks have been appointed at Ponte de Lago Scuro, which are to depart at certain regulated Times for Trieste, where the Court of Vienna has established Post Waggons to carry such Merchandizes to Vienna, by which Means a regular Method of Trading will be opened between that Part of Germany and this State.

From the Camp at Demont, Sept. 9. The King of Sardinia is encamped here with the Piedmontese Troops. The Austrians under General Brown are at Aysone and Vinadio, about five Miles more advanced. Prince Piccolomini has with him 14 Battalions at Sambuc, about se-

ven Miles farther. The Chain is continued by Posts of Grenadiers in the different Villages as far as Argentieres, where General St. André commands 2500 Men, detached from Prince Piccolomini, and the Territory of France.

Francfort, Sept. 18, N. S. The Elector Palatine will remove this Week from Dusseldorff to Manheim.

Liege, Sept. 19, N. S. Some Letters from Italy mention, that the French seemed to be making Dispositions for retiring out of the County of Nice to the other Side of the Var, whither they had transported their Hospitals and Magazines. Of the ten Battalions which were at Puget, there scarce remain 2000 Men. Fifteen Spanish Battalions, which had repassed the Var, have received Orders to march and occupy the Eminences of Menton.

Head Quarters at Richel, Sept. 25, N. S. We have made a Detachment of twelve Austrian Battalions, and two Regiments of Austrian Cavalry, together with the whole Hessian Corps here, consisting of five Battalions and seven Squadrons, all which will pass over the Maese at Ruremonde the Day after To-morrow, where Marshal Bathiani will join them. The Enemy continue at Bergen-op-Zoom, and have made a Detachment of thirty Battalions to Putten to invest Lillo, after the

taking which Place, the general Talk of the French Army is, that they shall go into Winter Quarters. The French King set out for Paris last Saturday, and the Troops have actually begun their Winter Reviews.

Hague, Sept. 26, N.S. We have Advices from Persia, by the Way of Russia, of the 6th of July, according to which, the Revolt in that Empire was become so general, that Schach Nadir, seeing his Affairs desperate, had resolved to sly, with some Awgaitzes and Usbecks, that still adhered to him, to the City of Kelat, an inaccessible Place, where he had lodged all his Treasures; but that, before he could execute this Resolution, he was fallen upon and murdered in his Tent by the Persians who still remained about him. His Head was immediately fent to his Nephew Ali-Kulikan, in whose Favour the Persians had revolted; who thereupon dispatched Orders over the whole Empire to suspend and abolish all the Contributions imposed by the late Schach. We hear from Syer antempret any I hing either against that Place, or against Tholen, but that M. St. Germain has been detached with 6000 Men, and a Train of Artillery, to besiege the Forts of Lillo, Cruysshaus, and Frederick Henry. The Reports which had been spread, reflecting upon the Conduct of the Bavarian Troops, at the Time when the French made themselves Masters of Bergen-op-Zoom, are absolutely false, it being certain, that there were no Bavarian Troops then in the Town, those who had affisted in the Defence of the Place, having been ordered into the Lines the Day before.

Rotterdam, Sept. 26, N. S. We have no News of the Motions of M. de Lowendahl's Corps, excepting that one of his Detachments has besieged Lillo, and another is siring upon Fort Frederick Henry. There are Letters from Steenbergen of Yesterday, which say, that the main Corps is still encamped under the Cannon of Bergen-op-Zoom.

Flushing, Sept. 27, N.S. The States of this Province have published an Edict to call in all the Plate of this Island, which

is to be coined into Species, and will, it is thought, produce about 40,000 l. Sterling, and for which the Owners are to have Four per Cent. They talk of following the Example of the Province of Holland, who are to furnish Two per Cent. upon their whole Capital. It is said that the Prince of Orange designs to send into these Islands Troops and all Things necessary for their Defence. Major General Lelly commands at Tholen, and hath about 2000 Men with him. They have already drowned, or are drowning all the Country lying Eastward of Tholen, and the present strong Winds are very favourable for their Inundations. According to Accounts here, the French have attacked Fort Frederick Henry. The Dutch have about thirty armed Vessels lying at the Mouth of the Scheld, and fourteen before Bergen-op-Zoom.

Dublin, September 14.

Yesterday arrived his Excellency the Earl of Harring Excellency was received at his Landing by the Lord Mayor, Aldermen and Sheriffs of Dublin; the' Foot Forces in Garrison, with the Militia of the City, lined the Streets through which his Excellency (attended by a Regiment of Horse, the Battle-Ax-Guards, and the other Officers attending the State) proceeded amidst the Acclamations of the People, with the usual Ceremony, to the Castle, where, in the Council-Chamber, his Excellency took the Oaths appointed to be taken by the Lord Lieutenant of Ireland, and received the Sword from their Excellencies the Lord Justices. After which, the Great Guns at his Majesty's Park the Phœnix were fired, and answer'd by Vollies from the Regiments on Duty, which were drawn out upon College Green. And his Excellency repairing to the Presence-Chamber, received there the Compliments of the Nobility and other Persons of Distinction, upon his safe Arrival to take upon him the Government of this Kingdom.
