Head Quarters at Hoichten, October still stively say, that Major General Thierry 16, N.S. had surrender'd himself Prisoner of War,


this Place, which is within a good League of Maestricht, and To-morrow we are to march through in one Day to Brey, the next Day to Hamont, and then to Eyndhoven, where we shall halt a Day; and proceed from thence in two Marches, the first to Osterwick, and the next to Breda.

Liege, Oct. 17, N. S. The Arrival of the Prince of Orange at Oudenbosch hath deserr'd the Breaking up of the French Army about Louvain. They sent away their Artillery on Sunday, and were to have marched into Winter Quarters Yesterday; but at Eleven on Sunday Evening Orders were sent to the Troops to remain in their Cantonment, till they saw what was the Intention of the Prince of Orange.

Hague, Ott. 17, N. S. We hear, that on the 13th Instant Major General Thierry, finding that Lillo could not be defended any longer, retired with his Garrison to Cruys Schans, leaving only an Officer and a sew Men to capitulate. The French immediately formed their Attacks against this last Place, which has since surrendred; but it is not known whether the Troops have been able to save themselves, and retire as they have done hitherto; though the Letters this Day from Antwerp pos-

had surrender'd himself Prisoner of War, with about 800 Men. The Tax of Two per Cent. is agreed to in the Provinces of Zealand, Utrecht, Frize, and Groningen. The Payment of this new Tax is begunt in the Town of Leyden; and, from the Appearance there, it is imagined that the Sums that will be raised, will greatly exceed the original Calculation. The States of Holland resumed this Day their Deliberations; but have postponed, for a few Days, their Conclusion upon the Motion that was made by the Nobles, to make the Dignity of Stadtholder hereditary in the Prince of Orange's Family. All the Towns in the Province of Holland, except Amsterdam, have already given their Consent, and it is not question'd but that it will do the same; though it is generally faid, some Conditions and Restrictions will be proposed not contain'd in the first Plan. The Towns of Teer Veer, Flushing, and Goes in Zealand, have likewise consented to the Settlement in Favour of the Prince of Orange's Issue; but the Assembly of the Province of Guelderland have broke up without coming to any Resolution, either upon the Tax of Two per Cent. or the Question that was proposed, namely, the Taking off the Limitation of the Power of Stadtholder in that Province. The Prince of Orange is expected at the House in the Wood either this Evening or To-morrow. Letters from Brussels of the 15th Instant say,

that the Austrians and Piedmontese had blocked up the Passage into Italy, and were preparing to renew the Siege of Genoa, from whence there was no Account of the Duke of Richelieu's Arrival. Letters from Paris say, that they had received Advices from Turkey of the 8th of September last, which mention, that the English, supported by the Indians, had blocked up Pondicherry by Land as well as by Sea, and that the said Place being in Want of Provisions, there was Reason to apprehend it could not long hold out.

Head Quarters at Eyndhoven, Oct. 20. His Royal Highness the Duke of Cumberland set out this Morning from the Army for Breda, and left the Command of it under the Orders of General Ligonier. The British Corps marched the 17th from Hoichten to Brey, thence the 18th to Hamont, and Yesterday reached this Place; To-morrow we are to march to Osterwick, and the Day following to the Neighbourhood of Breda. The French, fince the Reduction of the Forts Frederick Hendrick and Lillo, are preparing to put their Troops into Winter Quarters; and by the Intelligence received Yesterday from Marshal Saxe's Army about Louvain, they have been quite still, and seem to have been hinder'd from going into Winter Quarters, by the Expectation of feeing the Design of the March of this Corps.

Hague, Oct. 20, N.S. The Proposition for rendring the Dignity of Stadtholder hereditary in the Prince of Orange's Family, is not yet concluded, but the Deputies of Amsterdam being return'd this Night, it is thought that that Affair will be again taken into Consideration Tomorrow by the States of Holland; and it is expected that next Week it will be proposed to the States of Utrecht; and that the Province of Overyssel intends to follow their Example. We have now certain Advice from Antwerp, that the Garrisons of Frederick Hendrick and Lillo were obliged to furrender themselves Prisoners of War at the taking of the Cruys Schans. The Prince of Orange return'd to this Place the Day before Yesterday; and his Royal Highness the Duke of Cumberland is expected here on Sunday or Monday next.
