Hague, Jan., 5; N.S. When their High Mightineffes refolved upon the Promotion of General's last Tuesday; they likewife came to a Refolution of leaving entirely for the future to the Prince of Orange's Disposal, the Pensions that were always allowed to a certain Number of General Officers, of every Degree, according to their Seniority in the Army. The Prince of Orange received last Night an Express from Breda, with the News that Major General Haddich, an Officer of Huffars in the Auftrian Service; had attacked, the laft of December, N. S. a Convoy intended for Bergen-op-Zoom, and having entirely difperfed the Efcort, had taken fome Prisoners; with feveral Head of Cattle; but the Darkneis of the Night had prevented him from bringing away any of the Carriages; however, having fent the next Morning a Detachment of Fifty Hörse to the Place where the Convoy was attacked, they found above an Hundred Carts without Horfes, and the Meal, Sacks and Casks thrown upon the Ground and entirely spoiled. Many Soldiers and Peafants were likewife found dead upon the Spot. Hague,
