S Royal Highness the Duke of Cumbe land arrived here this Morning from Holland.

Egra, August 27, N. S. The three Columns of the Russian Croops are march'd into Bohemia.

Head Quarters at Eyndhoven, Aug. 29, N. S. The Sickness amongst the Troops abates, and the Physicians are of Opinion that but few will die of it.

Berlin, Aug. 30, N.S. The King of Prussia is expected here To-morrow from Potzdam, and will fet out the next Day for Silesia.

Hambourg, Aug. 31, N.S. There has been an Edict published in Sweden, prohibiting afresh the Use of either Gold or Silver in Apparel, and enacting, that all Swedish Subjects, though in foreign Countries, be obliged to observe the fame Ordinance, both with regard to their own


Persons, and the Liveries of their Servants, &c. Aix la Chapelle, Sept. 4, N.S. Upon an Article being inserted in the Cologne Gazette, in which it was said that a Protest from the Pretender's Son had been formally delivered to the Chief Burgo-Master of this Town, and accepted by him, the Earl of Sandwich and Sir Thomas Robinson, his Britannick Majesty's Ministers here, sent to the said Burgo-Master to enquire into the Affair, who thereupon sent them the original Journal of what had passed when the said Protest was offered to the Magistracy; by which it appeared that they had not only refuled registring, but even receiving that insolent and scandalous Libel; and they have since written to the Cologne Gazetteer, acquainting him with the Falsehood of the Facts inserted in his Paper, and infifting that he should contradict it in Form in his next Gazette.

Bruffels, Sept. 4, N.S. Marshal Saxe reviewed his Regiment on Monday last without the Port of Lacken, and 'tis said it will march soon from hence. The Wood, which was cut down in the Forest of Soignies, has be n sold to a Person, belonging to the Bishoprick of Liege, for Fourscore and Five Thousand Florins. The French Troops remain in their former Cantonments, and have lost a great many by Sickness. is reported that seventeen Squadrons of Horse

will come hither, as foon as the Troops are drawn out of their Cantonments; and 'tis believed, that some Time next Month all the Ca-

valry will be quartered in the Towns.

Hague, Sept. 6, N. S. The Prince of Orange is still at Amsterdam, and is not expected to return from thence till next Week. We do not yet hear that any Change has been made in the Regency of that Place; but all the Letters agree, that the Prince has been extremely taken up, ever fince his Arrival, with examining into the Burghers Complaints, and the Conduct of their Magistrates. The Mob has hitherto continued pretty quiet; but they threaten to begin again as foon as his Highness leaves their Town, unless the Magistrates are deposed. The Burghers of Leyden have printed a long List of their Grievances; and those of Rotterdam have appointed a Meeting as this very Day, at the Doel, where their Grievances are also to be taken into Consideration. We hear there have been fresh, Disturbances at Groningen, where the Boors and Populace have ill used M. Lecuwe d'Aduwart, one of the principal Members of the States, to the highest Degree, having knocked him down, and trampled upon him, as he was stepping out of his Coach, and put him into so much Danger, that, in order to escape their Rage, he was obliged to save himself over the Roofs of Houses. They afterwards compelled the States to take a Resolution, by which they give the Stadtholder the same Power and Prerogatives as have been given him by the States of Friesland. Three more Dutch East India Ships are arrived in the Texel, and are the last belonging to this Fleet. They bring positive News, that all the Ships belonging to his Majesty's Fleet under the Command of Admiral Boscawen arrived safe, in very good Order, and very healthy, about the 10th of April last, at the Cape of Good Hope, and that the Admiral (who had order'd 2000 of his Men to go on Shore for Refreshment) intended to fail again from thence in the Beginning of May, with a Reinforcement of five Dutch Ships, which the Governor of the Cape was to add to the Fleet. M. de Catwyck, one of the Dutch Plenipotentiaries, arrived here last Wednesday from Aix la Chapelle. Letters from



Paris of the 2d of September, N. S. mention, that all the Battalions of the French and Swiss Guards were arrived there, as well as a good many Officers belonging to the Regular and Irregular Troops. We also learn by the said Letters, that a pretty large Part of the Garrison of Namur will much from thence, in order to take up their Winter Quarters in Alface.
