## From Saturday October 8, to Tuesday October 11, 1748.

Aschaffenbourg, October 7, N.S.

HE Elector of Mayence returned hither on the 5th, when his Highnefs received a Notification of his being unanimoully elected Coadjutor to the Elector of Treves in the Bishoprick of Worms, which unites in his Hands the Direction of the Circle of the Upper Rhine with that of the Electoral Circle. Hambourg, Oct. 9, N.S. We have Advice from Copenhagen, that the Swedish Minister, Baron de Hoepkin, has received his Recredentials; and the Arrival of his Succeffor was foon expected. Count Dehn, the late Minister from the Court of Denmark to that of Spain, is arrived at Elfinore; and after he has waited on the King his Master, and made a Report of his Commission, will set out for the Post he is appointed to at the Hague. Hambourg, OEt. 12, N.S. Mr. Titley, his Britannick Majefty's Envoy Extraordinary to the Court of Denmark, left this Place Yesterday Noon on his Return to the faid Court. Hague, Oct. 15, N.S. Meff. de Catwyck and Pauw, who were fent to Leyden laft Thurfday, as Commiffaries from the Prince of Orange, to change the Magistracy of that Town, have not yet been able to terminate their Commission, baying met with many Difficulties on the Part of the People, who infift upon a total Change of their whole Regency. The Princess- Dowager of Orange, who has been at the Hague about a Month, set out last Saturday, in order to return to Leeuwarden. Hague, Oct. 18, N. S. The Commiffaries, who were fent laft Week to Leyden to change the Regency, have not yet been able to execute their Commission, by reason of the mutinous Dispositions of some of the People of that Town, who infift upon a total Change of their Magistrates. The Rioters attack'd, two Days ago, the House's of some of their Regents, and would have forced themselves into them, if the

City Militia had not luckily prevented them. It is, however, expected the Change will be effected in a Day or two. There has happened likewise some Disturbance at Tergau, where the People having conceived a Notion, that fome Troops, which are in that Neighbourhood, were to be quarter'd in their Town, assembled in a Riotous Manner, and, after committing feveral. Diforders, feized upon the Gates of the Town, difarmed a Party of the Foot Guards, confilting of a Serjeant and 15 Men, that were there to affift the Collectors of the Toll-Duties, and then turn'd them out of the Town, declaring, they will never fuffer any Regular Troops to enter it. In this Commotion their Penfionary M, Snelf was in great Danger of his Life, and faved himfelf with the utmost Difficulty. The Prince of Orange intends to fet out in a few Days for Breda. M. Van Til, the States General's Refident at the Court of Lisbon, and M. Greflein, Secretary to the Dutch Embaffy at Madrid, are both arrived here. M. Hop, their High Mightineffes Envoy Extraordinary at the British Court, is gone into Zealand for a few Days, before he returns to England.
