O-MORROW there is to be publick Thanksgivings in all the Churches of this City, and other Demonstrations of Joy, in Commemoration of its being the Jubilee Year of the Treaty of Munster, by the 28th Article of which, Those of the Confession of Augsburg were reinstated in the Possession of their Churches and Ecclesiastical Estates, and in the free Exercise of their Religion in the Empire.

Hague, Nov. 1, N.S. The Prince of Orange returned to this Place on Wednesslay Morning. The Earl of Sandwich arrived here late last Tuesday Night. Mess. de Catwyck and Pauw are returned from Tergau, in order to acquaint the Prince Stadtholder with the Situation of Affairs in that Place, and to receive his Highness's Inttructions before they proceed in the Change of the Regency.

Whitehall, October 25.

An Account has been received of the Gemoese Plenipotentiary having acceeded to the Definitive Treaty of Peace.

Dublin, October 11.

This Day being the Anniversary of his Ma-Jesty's Coronation, the Great Guns were fired in his Majesty's Park the Phœnix, and answered by Vollies from the Regiments in Garrison, which were drawn out upon Oxmantown Green. At Noon their Excellencies the Lords Justices met at the Castle, where a Squadron of Horse attended, and received the Compliments of the Nobility and other Persons of Distinction, upon this Occasion: At Night a Play was given by their Excellencies, for the Entertainment of the Ladies; and there were Bonfires, Illuminations, and all other Demonstrations of Joy.
