Brussels, Nov. 6, N. S. The Commissaries of the Empress Queen arrived in this City on Monday last, in order to settle all Affairs with those of France, in Conformity to the 8th Article of the Treaty of Peace, relating to the Evacuation of the strong Places in the Low Countries.

Hague, Nov. 8, N. S. The States General have taken into their Service, upon the Prince of Orange's Recommendation, M. Elliot, and given him the Rank of Lieutenant General, which he had in the Elector Palatine's Troops. The Prince Stadtholder's Commissaries are returned from Gorcum to make a Report to his Serene Highness of the State of Affairs there, and to receive his final Orders with Respect to the Alterations to be made in the Regency of that Town.
