Provided, and be it further enacted, That if any Action or Suit shall be commenced against any Person or Persons for any Thing done in pursuance of this or any of the said former Acts, in every such Case the Action or Suit shall be brought within Six Calendar Months next after the Fact committed, and not afterwards, and in the County where the Fact hath been, or shall be committed, and not elsewhere; and the Defendant and Defendants in such Action and Suit to be brought shall and may plead the general Issue, and give the special Matter of his Defence in Evidence at any Trial to be had thereupon, and that the same was done in pursuance of the said former Acts, or this present Act; and if the same shall appear so to be done, or such Action or Suit to be brought after the Time limitted for bringing the same, or shall be brought in any other County, Place or Places than where the Fact was committed, then the Jury shall find for the Defendant or Defendants; and upon fuch Verdict, or if the Plaintiff or Plaintiffs shall become Nonsuit, or discontinue his or their Action, after the Defendant or Defendants shall have appeared; or if, upon Demurier, Judgement shall be given against the Plaintiff or Plaintiffs, the Defendant and Defendants, in every such Case, shall and may recover Treble Custs, and have such itemedy for the same, as any Defendant or Defendants hath or have in any Cases by Law.

Naples, June 10, N.S. Last Week sailed from this Port for Sicily, on board of divers Transport Vessels, the Swiss Regiment, Wirtz, to relieve that of Jauch in Garrison in that Kingdom. The Prince of Franca Villa, agreeable to the King's Permission, is set out from this City for Turin, on his private Affairs. A few Days ago the Deferters out of the King's Troops, who had taken Refuge at Benevento, having mutined, forced the Centinels, and got Possession of the Arms of the Pope's Soldiers on Duty in that Castle, attempted their Escape, and fired at those who offered to oppose them; but being overpowered by a Detachment of the Militia that timely arrived there, they were arrested and ordered to a closer Confinement: Several Men on both Sides were killed and difabled in the Scuffle.

Rome; June 14, N.S. A few Days ago arrived in this City from Paris, on his Return to Naples, the Prince of Ardore, the late Ambassador from the Court of Naples to the King of France. He was received and complimented at some Distance from this City by Cardinal Orsini and the Prince of Santobono, in their Coaches and Six: On the 12th he had a private Audience of the Pope at Castle Candolso.

The Pope, on his Return to this City, intends to fill up the Vacancies in the College of Cardinals. On the 11th at Night a most dreadful Hurricane happened at this Place, the like of which has not been known in the Memory of Man: It was attended with exceeding great Claps of Thunder and Lightning, and has occasioned infinite Damage both to the City and Suburbs, having blown down several Walls, Houses and Trees, and killed many People.

Leghorn, June 16, N.S. On the 12th Instant the Eagle Merchant Ship, Capt. Massau, bound to London, richly laden with 80 Bales of Silk, &c. was cast away a few Hous after she sailed, behind Monte Nero, and all the

Florence, June 20, N. S. On the 7th Internation M. de Richecourt sent back to Vienna, the Courier which he lately received from that Court, with Dispatches both for him and Marshal Stampa at Pisa, relating to the Imperial Fiess of Carpegna and Scavolino, lately devolved to the Emperor by the Decease of the last Male Heir of the Counts of Carpegna; and to inform that Court with the Steps taken by the Regency to send a Detachment of 400 Men out of the Tuscan Militia to take Possession of it; which they accordingly did on the 17th Instant without any Opposition on the Part of the Pope's Soldiers.
