Lisbon, August 12.

HE King's Health seems better established every Day; so that the Journey which his Majesty had proposed to take to the Baths near Caldas, seems to be laid aside, at least for the present. Several Memorials have been presented to the King to obtain the Revocation of the late Ordonnance, but no-Resolution has as yet been taken on that Head.

Madrid, August 26. The 24th, being the Feast of St. Louis, whose Name the Infant Cardinal bears, the Court made a very grand Appearance, and received the Compliments of all the Nobility and Foreign Ministers on the Occasion, Mr. Keene, the British Minister, has frequent Conferences with his Majesty.

Vienna, Sept. 7, N. S. Courit Kaunitz. Ritherg, Ambassador from this Court to that 'of France, will soon set out for Paris, most of his Baggage being already sent away; and Don Sebastien Caravalho, who has resided here for some Time in Quality of Minister from his Pertuguese Majesty, will set out on Monday next on his Return Home. The Deputies of the States of Lower Austria, who are to assemble the 15th of this Month, are continually coming in. The Empress Queen came hither last Thursday from Schonbrun, and having heard a grand Mass celebrated at the Church of St. Peter and Paul by M. Serbelloni the Pope's Nuncio, let out for Hetzendorff to visit the Empress Dowager; and on Wednesday next the will go with a great Retinue to visit the Camp of Salenau, for which Place Count Harrach is already set out to make the necessary Preparations for her Reception. The Emperor is expected here from Hollitich towards the End of this Month. We have received Advice, that the Town of Crainbourg in Carniola is reduced to Ashes, which 'tis imagined was done by some malicious Persons, as it took Fire in three different Places at the same Time. Count de Bentinck, Minister from the States General, is soon

expected here.

Hambourg, Sept. 13, N.S. The Loan of 200,000 Crowns, which the Ducal House of Holstein is at present negociating with the Town of Hambourg, is thought to be as good as agreed. to; and that they are now only employed in fettling the Conditions upon which the Hambourgers are to hold the Mortgage of the Baily-wicks of Trittau and Rheinbuck, and fixing the Terms of the Repayment of the Money-advanced. We hear from Dresden, that his Polish Majesty did propose to separate the Assembly of the States of his Electorate, as next Sunday the 14th Instant, they having finally settled the Affairs which had occasioned their Convocation.

Berlin, Sept. 13, N.S. The King has given the Government of Colberg, vacant by the f Death of Felt Marshal Kleist, to Lieutenant General de Bredow. His Majesty has likewise appointed Prince Francis Adolphe d'Anhalt Bernbourg, to be Major of the Regiment of Lehwald, Infantry; Prince Christian d'Anhalt Bernbourg, to be Major of the Regiment of Fusiliers of Margrave Henry; and Capt. Borck; to be Major of the Regiment of Infantry of. Bredow. The Night before last died M. Wol-

ter, the Polish Resident at this Court.

Hague, Sept. 16, N. S. Melchior Guy Dickens, Esq; his Britannick Majesty's Envoy Extraordinary to the Court of Rullia, arrived here on Friday last, and has been introduced to the Prince and Princess of Orange. "The Princess Dowager of Nassau Siegen, and the young Countess of Bentheim, who have been here for some Days past, will set out To-morrow on their Return to Germany. M. de Haren, who is appointed Envoy Extraordinary from this Republick to the Court of Sweden; is let out on a Tour to Boilleduc, from whence he will rereturn in about ten Days. The Regiment of Saxe Gotha, which was in the Service of this Republick during the late War, has Orders to return to Germany, and will be filing off without Intermission.
