Madrid, September 23, N. S.

HE King's Birth-day will be celebrated here To-morrow, for which great Preparations are already made at Court; his Majesty then enters into the 37th Year of his Age. This Court seems now resolved to push its Enterprize against

the Algerines.

Naples, Sept. 23, N. S. On Friday last the Blood of St. Januarius, Protector of this Kingdom, was exposed in the usual Manner, and liquisied in less than 35 Minutes, to the great Joy of the whole City, who were immediately acquainted with it by a Discharge of the Cannon of all the Fortresses. The same Day his Majesty attended at Divine Service in the Church of St. Januarius, as did her Majesty, who advances happily in her Pregnancy, towards the Evening. Great Desertions have happened lately from the Regiments in Garrison in this City, insomuch that 60 Soldiers have gone off in a Night.

Genoa, September 29, N. S. The Corfairs of Barbary having lately infested these Seas pretty much, two Xebecks and an armed Bark are sailed from this Port, in order to give them

Plaisance, September 29, N. S. The Ducal Palaces at Parma and in this City are fitting up with great Diligence for the Reception of the Infanta, who is soon expected here from Versailles.

Prague, October 1, N.S. The Elector of Bavaria, accompanied by several Lords of his Court, arrived in this City the 28th past incognito; the next Day he heard divine Service in the Metropolitan Church, and it is expected he will set out this Evening on his Return to Muhich.

Breslau, October, 3, N. S. On Wednesday last a prodigious Swarm of Locusts was several Hours passing over this City, and went off without settling. Numbers of them dropt down in

this Neighbourhood, but were foon destroyed by the Ravens and Crows.

Breslau, October 8, N.S. Within these sew Days past a Fire broke out in the Castle of Goschutz, belonging to Count Reichenback, which burnt with such Violence, that it was soon reduced to Ashes with all its curious Furniture; which Loss is computed at 130,000 Crowns.

Copenhagen, October 4, N. S. Yesterday an extraordinary Council was held at Friedensbourg, where a magnificent Feast will be given on Monday next on Occasion of the Birth of the Princess Amelia, and the next Day the whole

Court will return to this City.

Vienna, October 4, N.S. Count Bentinck has had several Conferences with the Ministers of State since his Arrival, and is greatly distinguished by their Imperial Majesties. The Troops which were lately encamped at Salenau, Pilsen and Konigsgratz, continue going into their Winter Quarters. General Count Brown designs to set out in a few Days for his Government of Transsilvania. This Day being the Feast of St. Francis, whose Name the Emperor bears, the same will be celebrated with great Solemnity at Schonbrun.

Vienna, October 6, N. S. They continue to raise Recruits in all the Queen's Hereditary Countries, in order to compleat the Regiments

which are in Italy.

Dresden, October 7, N. S. The King is set out for St. Hubertsbourg to take the Diversion of Hunting, from whence is expected he will go to Leipsick.

Hambourg, October 7, N. S. The Marquess de Grimaldi, who arrived here a few Days ago from Berlin, set out this Morning for Stockholm, where he is to reside in Quality of Minister from

the Court of Spain.

Berlin, October 7, N.S. Last Thursday the Dutchess of Brunswick Lunebourg was safely delivered of a Princess, for which publick Thanks have been given in all the Churches of this City. This Day the Baron de Greissenheim, formerly Minister

Minister from the Court of Sweden to that of Dresden, arrived here; he is going to the Court of Russia in the room of the late Baron Hopken. The Great Chancellor Baron de Cocceii is returned hither from the Journey he has taken to Ostfrize. We have received Advice that the Dutchess of Brunswick Wolfenbuttle, his Majesty's Sister, was happily delivered of a Princess on the 2d Instant.

Berlin, October 11, N. S. The Marquess de Varoli, Envoy Extraordinary from the King of France, having received, on the 4th of this Month, an Express from Stockholm, with Dispatches from the Marquess de Havrincourt, he set out immediately for Potzdam, and communicated their Contents to the King, who gave him a particular Audience on this Occasion; after which he was in Conference with the Ministers of State, and on the 5th he returned to this Place, and dispatched a Courier for Paris.

Osnabrug, Ostober 8, N. S. The Locusts continuing to do vast Damage in Franconia and other Places, and even to advance towards the North West of Germany, publick Prayers have been put up in this Place, to beg Almighty God to desend this Country from the great Danger with which it is threatened from those devouring Insects. The Elector of Cologn, who is now taking the Diversion of Hunting at Clemenswert, is expected soon in this City; and as it is imagined that he will stay here some Time, great Preparations are making for his Reception.

Leipsick, October 11, N.S. The King and Queen of Poland with the Prince Royal and his Spouse, arrived here on the 8th Instant, and propose staying all the Time of the Fair.

Hague, October 15, N. S. The Court is not expected to return from Loo till the Beginning of next Month; and the rather, as we are informed that the Anniversary of the Birth of the Princes of Orange will be celebrated there on the 2d. The Greffier Fagel, M. Hop, Secretary of the Council of State, M. Verelst and M. Back, have all taken a Tour to the Castle of Loo to pay a Visit to their most Serene Highnesses. M. Haren will set out Tomorrow or next Day for Brussels. The States of this Province separated on the 11th. Lieutenant General du Faget van Assendelft, Lord of Heynenoort, whom the Prince of Orange had fent into Zealand to regulate the Reduction of the Troops, according to the late Resolution of their High Mightinesses, is returned hither. The Minister of the Landgrave of Hesse Darmstadt having figned a Convention with the Deputies of the Council of State for the Return of the two Regiments, which were in the Service of this State during the late War, into their own Country, 'tis expected they will be fetting forward in a few Days.

Hague, October 17, N.S. His Serene Highness the Prince of Orange having appointed

Count Nassau, Governor of Heusden, to be Colonel and Captain of a Regiment of Horse, vacant by the Death of Lieutenant-General Schagen, he has taken the usual Oath before the Council of State for that Command. The Regiment of Foot of General Pretorius, now in Garrison at Gertruydenbourg, is ordered to march from thence to Namur, as is also that of Lieutenant General Guy which is now at Boisleduc.
