Algiers, September 19.

N the 15th Instant one of our Corfairs returned from a Cruize, and brought in two small Vessels, one of which was a Genoese, and the other a Corfican; they were loaden with Corn and Wood, and had 29 Men on board.

Moscow, September 28. Last Saturday the Empress came from the Monastery of Jerusalem to this City; and on Monday the Grand Chancellor Count Bestuchef gave an elegant Entertainment to Lord Hyndford, and several other

Foreign Ministers.

Naples, September 30, N.S. Their Majesties set out Yesterday in order to pass some Days at Portici; and though the young Prince is perfectly recovered of the Small-pox, he is not to follow their Majesties thither, not being yet permitted to go Abroad. Within these few Days a Brigantine from Malta arrived in this Port; the Master says, he was attacked by several Algerine Xehecks, and though they fought him, pretty briskly for some Time, he had the good Fortune to escape with only one Man wounded, who died the Day after he came into Port. the Troops of this Kingdom are ordered to be compleated at foon as possible, the late Order the King had given for the Reform of the Troops being fince countermanded; the Fortifications of Pescara are also ordered to be repaired, and several Pieces of Cannon are to be sent thither, his Majesty being determined to put that Place in a good State of Defence. His Majesty, who often diverts himself with huning of Pheasants in the Island of Procide, has determined to build a Fort there, in order to secure himself from any Attempt which the Corfairs of Barbary may make on his Person, by wempting a Descent on the said Island. They write from Gaeta, that one of our Ships had brought in there a Corsair of Tunis, with twelve Pieces of Cannon and thirty five Men on board.

Leghorn, October 4, N. S. Several of the Novility, and other Persons of Distinction, are 1 continually arriving here and at Pisa from Genoas on occasion of the continual Troubles which

happen in that City.

Rome, October 4, N.S. On the 30th past Cardinal Portocarrero, the Spanish Ambassador, had a particular Audience of the Pope, and communicated to him the Contents of several Dispatches he had received from his Court. Great Diligence is used in beautifying all the Churches of this City against the approaching Holy Year.

Florence, October 4, N. S. The Pope having some Time ago consented to the Suppression of feveral Holy Days which used to be kept in the Dominions of the Grand Duke, the Archbishop of this Diocese has just now made it known to the People by a Pastoral Letter for that Purpose.

Plaisance, October 8, N.S. The Infant Duke having received certain Advice that the Infanta would be here by the Beginning of next Month, all the Nobility have been made acquainted therewith, and great Preparations are making for her Reception.

Parma, October 8, N.S. His Serene Highness has ordered publick Prayers to be put up in the Cathedral of this City, to beg the Almighty to preserve the Infanta and give her a happy Voyage. Grear Preparations are making here for her Reception as well as at Plaisance, not only in the Palace, but even in the Cathedral.

Vienna, October 11, N. S. Great Preparations are making, for celebrating, on the 15th Instant, the Feast of Sainta Theresia, whose Name the Empress bears; and a Day or two after their Majesties intend to set out for Moravia, where Prince Lichtenstein is already making Preparations for their Reception. All the Troops which were encamped in Bohemia, Moravia, and Austria, are gone into Winter Quarters. Her Majesty advances happily in her Pregnancy, and still continues to take great Pains in putting the Commerce of Hungary upon a good Footing.

Berlin, October 18, N.S. The 15th of this Month the King came from Potzdam to this City, and having permitted all the Foreign

Ministers to pay their Respects to him, his Majesty set out again the next Day for Potzdam.

Leipsick, Ostober 18, N. S. Yesterday the King and Queen, accompanied by the Prince Royal and the Princess his Spouse, left this City on their Return to Dresden; from whence we learn, that M. Guydickens, his Britannick Majesty's Envoy Extraordinary to the Court of Russia, arrived there the 7th Instant, and would soon set out for Petersbourg. His Majesty has given the Regiment of Cuirassiers, vacant by the Death of the Prince of Schwartzbourg Sondershausen, to Prince Eugene d'Anhalt Dessau, Lieutenant General and Governor of Wittenbourg. We have now in this City a great Number of Persons of the first Rank, who came to pay their Duty to their Majesties, and see the Fair, amongst whom were the Dutchess Dowager of Saxe Weissenfels, the Dutchess Downger of Courland, the Princes of Weissenfels, Prince Eugene d'Anhalt, the Ministers of State, Foreign Ministers, and a great Number of Polish Nobility.

his Britannick Majesty's Ambassador to the Diet of the Empire, is preparing to set out for Ratisbon, having already sent away his Equipage.

Paris, October 19, N. S. The King has appointed M. de Chevigny to be his Ambassador to the Republick of Venice. By an Express which arrived two Days ago from the Infanta, the Court was informed that she continued her Journey in perfect Health. The Duke of Lorrain and Bar is arrived in this City from Poland, and intends to spend the Winter here. The Marquess d'Hautefort, whom the King has named his Ambassador to the Court of Vienna, is preparing to set out next Month, Count de Kaunitz, Ambassador, from their Imperial Majesties, being expected here about that Time.

Brussels, October 20, N. S. M. de Haren is treated here with great Marks of Distinction. M. de Patin having been confirmed in the Prefidentship of the Council of Flanders, which Place he enjoyed before the War, he took Possession of it at Ghent the 17th of this Month.

Peris, October 22, N. S. The French King left Fontainebleau this Morning to go, to Choisy and Versailles for a few Days, and then return

again to Fontainebleau.

Hague, October 24, N. S. The Count de Wartensleben, Envoy Extraordinary from the States General to the Court of Sweden, is soon expected at Eoo, from whence he will come hither to make Preparations for his Journey to the Swedish Court. The Baron de Reischach, Envoy Extraordinary from their Imperial Majesties, returned hither last Night from Brisgow. The same Evening Count Gallowin, the Russian Ambassador, gave a grand Entertainment and a Ball to the Dutchess of Richmond, Count Charles Bentinck and his Lady, and to several foreign Ministers, and other Persons of Di-

stinction. The Dutchess of Richmond intends to set out on Sunday or Monday next for Brussels, where 'tis thought the Duke waits for her, in order to return to England by the Way of Calais.
