Moscow, November 7.

New Regulation has been made by the Senate with respect to the Rank of each Officer and Soldier in her Imperial Majesty's own Company of Guards; by which Regulation, the Captain-Lieutenant is for the future to rank with Generals, the Lieutenants with Lieutenant-Generals, the Second Lieutenants with Major-Generals, the Adjutant with Brigadiers, the Ensign with Colonels, the Serjeants with Lieutenant-Colonels, the Under-Serjeants with First Majors, the Quarter-Masters with Second Majors, the Corporals with Captains, the Vice-Corporals with Captain-Lieutenants, and the common Soldiers with Lieutenants.

Naples, Nov. 11, N. S. The 4th Instant, being the Féast of St. Charles, whose Name the King bears, the same was celebrated at Court with the usual Ceremonies; at Noon Cardinal Spinelli the Archbishop, together with divers of the Nobility, Foreign Ministers, Chief Magistrates of this City in a Body, and many other Persons of Distinction, went to Portici to compliment his Majesty on this Occasion; and in the Evening a general Discharge was made of our Artillery. Last Week the Inhabitants of this City, and those in the neighbouring Villages, were pretty much alarmed by two small Shocks of an Earthquake, however they both went off without doing any considerable Damage.

Genoa, Nov. 18, N. S. On the 13th Instant in the Morning, the Infanta Dutchess of Parma, with the Infanta Isabella her Daughter, who have been here for these eight Days past, set out from hence with a numerous Retinue; that Night they lay at Voltaggio, and the Night following at Novi; and, on the 15th in the Morning, they proceeded on their Journey to the Frontiers of Placentia, where the Infant Duke, with Numbers of the Nobility, wait their Arrival. At their Departure, they were saluted by a triple Discharge of all the Artillery of this City, and of

the feveral Ships in the Harbour.

Placentia, Nov. 19. The Infant Duke our Sovereign returned hither this Day, with the Infanta his Confort, whom he had met on the Road; they immediately repaired to the Ducal Palace, where they were complimented by the Nobility, and other Persons of the first Rank; and in the Evening all the Houses were illuminated, the Cannon fired, and great Rejoicings were made by the Inhabitants.

Turin, Nov. 19. The Small Pox still continues to rage so very much in this City, that his Majesty seems determined to stay at the Venerie

till it is somewhat abated.

Madrid, Nov. 24. Her Catholick Majesty being a little indisposed, the Departure of the Court from the Escurial, which was fixed for the 22d Instant, hath been put off to the 26th, when their Majesties are expected in Town. The last

Leters from Cadiz mention, that Admiral Spinola was not expected from the Havanna till the End of next Month; and that a Register Ship had sailed the 16th Instant from that Bay for Limas The 19th Instant being the Day of Stalsabella, whose Name the Queen Dowager bears, it was observed at the Escurial with the usual Solemnities.

Vienna, Nov. 26, N. S. On Sunday next, being St. Andrew's Day, the Emperor will hold a Grand Chapter of the Order of the Golden Fleece, and will make a Promotion of fix new Knights, viz. The Princes of Didrichstein, Emanuel Lichtenstein, Trautson, and la Tour Taxis, the Marshal Bathyany, and Count Kaunitz.

Venice, Nov. 28, N. S. M. Diedo, the Republick's late Ambassador at the Imperial Court, is returned hither; and Count Canal, the King of Sardinia's Envoy to the said Court, passed through here this Week on his Return to Vienna. Great Honours were paid to the Infanta at Tortona, and in all other Places of the King of Sardinia's Dominions through which the passed. Don Philip, upon the News of her Approach, went from Castle St. Giovanni to meet her upon the Road. On the 19th Instant they made their Entry into Placentia, and after having received the Compliments of the Deputies of the Nobility, and of those of the Merchants, they proceeded to the Ducal Palace, where they were received by great Numbers of the Nobility who were allembled there for that Purpose. Madame the Infanta has declared the Count San Vitale, a Parmesan Gentleman, to be her Master of the Horse.

Paris, Nov. 28, N.S. The King talks of fetting out on Tuesday next for Crecy, where he proposes spending two or three Days. M. de Montpeyroux set out a few Days ago for Genoa, in Quality of Resident from his most Christian Majesty to that Republick, in the Room of M. Champeaux, whom his Majesty has named his Minister to the Circle of Lower Saxony.

Berlin, Dec, 2, N. S. The King, accoming panied by Prince Ferdinand of Brunswick, and other Lords of his Court, arrived here Yesterday from Potzdam. Field Marshal Keith is appointed Governor of this City, in the room of the late Duke of Holstein Beck.

Paris, Dec. 5, N.S. On Tuesday last his Majesty went to Crecy, and returned this Night to Versailles. The Marquis de Valory, Minister from this Court to that of Berlin, having obtained Leave to be recalled, the King has appointed the Lord Tyrconnel to that Post. Last Saturday an Express arrived at Court from Placentia, with Advice of the Infanta's safe and happy Arrival there the 19th of last Month.

Hague, Dec. 9, N. S. The Count de Bentheim Steinfort, with the Countess his Spouse; set out from hence Yesterday for Germany. By Advices of the 4th Instant from Leuwarden we learn, that his most Serene Highness the Prince of Orange was returned thither from Gro-

hinguen, and that the Departure of the Court from Leuwarden for this Place, seemed fixed for Thursday or Friday next.

St. James's, November 29.

This Day Koied Mahammed Aga, lately arrived Ambassador from Tripoly, had his first Audience of his Majesty, to deliver his Letters of Credence; to which he was introduced by his Grace the Duke of Bedford, one of his Majesty's Principal Secretaries of State, and conducted by Sir Clement Cottrell Dormer, Kt.
