AT the Court at St. James's, the 12th Day of January, 1749.

PRESENT,

The King's most Excellent Majesty in Council.

HEREAS fince the Publication of his Majesty's Order in Council of the 14th of December last, For prohibiting the Removal of any of the Horned Cattle for the Space of Two Months, Diverse Informations have been received, whereby it appears, that great Inconveniencies are likely to happen from the said Prohibition to the Cities of London and Westminster, and many other Parts of the Kingdom; which having been this Day taken into Consideration ——His Majesty doth therefore order, by and with the Advice of his Privy Council, that the said Order in Council of the 14th of December last, be, and it is hereby Vacated and Repealed and that the Order of Council of the 22d of March 1747, and all the Rules and Regulations therein contained, shall be observed, kept, and performed in every Part thereof, until further Order.

And for the better Execution of so much of his Majesty's said Order in Council of the 22d of March 1747, as relates to the killing and burying the distemper'd Cattle; it is hereby further ordered, That the Owners of all Horned Cattle do, as foon as the Distemper shall appear in or among any of the faid Cattle, immediately give Notice thereof to the Constable of the Town or Parish, and also to the Church-wardens and Overseers of the Parish or Place where such infected Cattle shall be, of the Appearance of such Infection, or to any Inspector already appointed or to be appointed by the Justices of the Peace for the District where such Parish or Place shall lie.

And his Majesty doth hereby strictly charge and command all his Majesty's Justices of the Peace for the several Counties, Ridings, Divifions, Cities, Liberties, and Towns Corporate within this Kingdom, and also the Commisfioners of the Land Tax authorized to act herein, to carry his Majesty's said Order of Council of the 22d of March 1747, into due Execution. And also the several Acts of Parliament made in relation to the said Cattle; and that they do likewise cause the Penalties, directed by the said Acts, to be inflicted on all Persons who shall disobey any of the Rules, Orders and Regulations made by his Majesty in Council.

And for the better notifying of this Order, it is his Majesty's Pleasure, that the same be forthwith printed and published, and be also inserted in the next London Gazette; and be likewise read in all Parish Churches, Chapels, and other Places fet apart for Divine Worship, on the First

Sunday after the Publication hereof, instead of the Order in Council of the 14th of December last, which is hereby repealed; and that for the Time to come, his Majesty's Order in Council of the 22d of March 1747, be continued to be read, as is therein directed.

Moscow, Dec. 27. Yesterday her Imperial Majesty, accompanied by the Grand Duke and Dutches; and several Lords and Ladies of the Court, left this City on her Return to Petersbourg; and this Morning most of the Nobility and Foreign Ministers set out to follow her Ma-

jesty.

Petersbourg, Jan. 3. On Monday the 29th of last Month, being the Empress of Russia's Birth-Day, her Imperial Majesty, on her Return hither from Moscow, arrived and celebrated the same at Czarskio Ciezlo, one of her Country Houses about 18 English Miles off; and on Wednesday last at Noon her Imperial Majesty, and the Great Duke and Dutchess, arrived at her Palace here in Town; on which Occasion Three Rounds of the Cannon at the Citadel and the Admiralty were fired, to give Notice of this agreeable News to the Inhabitants of this Place.

St. Sebastian, Jan. 4. An Advice-Boat is arrived here from the Carraccas, and has brought the Guypuscoa Company some Dispatches concerning their Affairs in that Country, the Contents of which are, that the Inhabitants thereof still persist in their Resolution of carrying on Commerce independent of the Company, and that they had armed all the Negroes they could possibly get together, amounting to about 6000, in order to oppose any Succours which the Company's Agents may receive from Spain. The Company have laid the Contents of these Dispatches before the King, and begged his Majesty's further Protection and Assistance,

Leghorn, Jan. 4. The Magistrates of this City, in Consideration of the great Increase of its Inhabitants during the late War, and that there are at this Time a great Want of Houses, have resolved to erect a new Suburb on the West Side of it. Some Days ago a Felucca, having on Board a Courier bound from Corfica to the Court of France, was taken by a Tunefian Galliot, which the Marquess de Cursay, Commander of the French Troops in Corfica, being informed of, immediately sent out three small Vessels, with 40 Grenadiers on Board, in Pursuit of her, who soon came up with her, but fo far was the from engaging them, that the abandoned her Prize, and made all the Sail the could to escape. The Felucca is since arrived here, but as she had some Communication with the faid Corfair, it has been thought adviseable to oblige her to perform Quarantain.

Turin, Jan. 7. The King has appointed the Abbe Rolland to be Archbishop of Tarantaise. M. de Guymont, Envoy Extraordinary from his most Christian Majesty to the Republick of Genoa, passed through this City last Week on his Return to France. A few Days ago the Court went into Mourning on Occasion of the Death of the Landgrave of Hesse Rhinseltz, the King's Father-in-Law.

Konigsbourg, Jan. 9. Some Days ago Prince George Louis of Holstein Gottorp, Major General of the Prussian Cavaly, Colonel of a Regiment of Dragoons, Knight of the Order of St. Andrew of Rullia, and younger Brother to the Prince Successor to the Crown of Sweden, was married to the Princess Sophia Charlotte of Holstein Beck, Widow of the late Count Alexander Emile de Dohna, who was killed at the

Battle of Sorr in Bohemia.

Dresden, Jan. 12. The King has caused Orders to be sent to all the Officers of his Forces, to have their respective Regiments compleat by the Spring.

Ratisbon, Jan. 15. The General Diet of the Empire was opened here on the 12th In-

Francfort, Jan. 16. The raising a new Regiment of Dragoons, for the Service of the Imperial Court, goes on with fuch Success, as well in this Neighbourhood as in the Principality of Hesse Darmstadt, that it is already near compleat, and both Men and Horses make a good Appearance. We learn from Stuttgard, that the Marquess of Bareith was arrived there with a numerous Retinue, and had been received with great Affection by the Duke and Dutchess of Wirtemberg.

Paris, Jan. 16. On the 14th Instant the King gave Audience to several foreign Ministers, and this Morning his Majesty set out for Choisy, where it is imagined he will stay till Monday. The Duke de Richelieu is preparing to set out for Montpellier, to affift at the Opening of the States of the Province of Languedoc; and the Count de Mailly d'Aucourt is on his Departure

for his Government of Perpignan.

Hague, Jan. 22. The States of Holland and Westfrizeland will assemble on the 28th Instant. His Serene Highness the Prince of Orange has promoted M. Ulrich Meyer, and M. Sausure, to the Rank of Lieutenant Colonels; and his Highness has also disposed of several Military Subaltern Employments. Calkoen is on his Departure for Dresden, in Quality of Minister Plenipotentiary from their High Mightinesses. On the 17th Instant the Prince and Princes of Orange affished at the Marriage of Count Degenfelt with the young Countess of Nassau, one of her Royal Highness's Ladies of the Bed-chamber.
