T is thought necessary to republish the following Proclamation, in order to advertise the Publick, That his Majesty's Promise of a Reward of One Hundred Pounds, to be paid to any Person or Persons who shall discover and apprehend any Offender, who shall commit any Murder whatsoever, or any Robbery, with open Force and Violence, in any Street, Highway, Road, Passage, Field, or open Place, in the Cities of London or Westminster, or within Five Miles round the same, so as any of the said Offenders, so to be apprehended, be convicted of the faid Offences; and also the Promise of his Majesty's Pardon to any Person, that shall have been an Accomplice in any such Murder or Robbery, so discovering and apprehending any such Persons as aforesaid (except the Person actually giving a Wound in any such Murder) is now, and will continue in Force, until the First Day of May next ensuing.

#### A PROCLAMATION.

GEORGE R.

Hereas by an Act passed in the Fourth and Fifth Year of the Reign of their late Majesties King William and Queen Mary, intitled, An Act for the encouraging the Apprehending of Highwaymen, it is (amongst other Things) enacted, That from and after the Twenty fifth Day of March, One thousand fix hundred ninety three, all and every Perf n and Persons who shall apprehend and take One or more Thieves or Robbers on the Highway, and profecute him or them so apprehended and taken, until he or they be convicted of any Robbery committed in or upon any Highway, Passage, Field, or open Place, shall have and receive from the Sheriff or Sheriffs of the County where such Robbery and Conviction shall be made and done, without paying any Fee for the same, for every such Offender so convicted, the Sum of Forty Pounds, and also shall have and enjoy, to his or their Use and Behoof, the Horse, Furniture, and Arms, Money, or other Goods of the said Robber or Robbers so convicted, which shall be taken with him or them; but with a Saving of the Right of such Person or Persons from whom the same were before feloniously taken: And whereas by an Act of Parliament, made in the Ninth Year of his late Majesty King George the First, it is made Felony without Benefit of Clergy, wilfully and maliciously to shoot at any Person in any Dwelling-house or other Place: And whereas by another Act of Parliament, passed in the Seventh Year of his present Majesty's Reign, in-

tituled, An Act for the more effectual Punishment of Assaults with Intent to commit Robbery, it is enacted, That if any Person or Perfons, from and after the First Day of May, in the Year of our Lord One thousand seven hundred and thirty four, shall, with any offensive Weapon or Instrument, unlawfully and maliciously assault, or shall by Menaces, or in or by any forcible or violent Manner, demand any Money, Goods or Chattles, of or from any other Person or Persons, with a felonious Intent to rob or commit Robbery upon such Person or Persons, that then, and in every such Case, all and every fuch Person or Persons so offending, being thereof lawfully convicted, shall be and be adjudged guilty of Felony; and every such Offender and Offenders shall be subject and liable to be transported as in Cases of Felony; and the Courts by and before whom he, she, or they shall be tried and convicted, shall have full Power and Authority of transporting such Offenders for the Space of Seven Years, upon the like Terms and Conditions, and by the same Ways and Means, and in the like Manner, as other Felons may or are to be transported to any of his Majesty's Colonies or Plantations in America, by Force or Virtue of any Law for that Purpose then in being: And whereas we have received Information that frequent Murders, Robberies, and other Outrages, have of late been committed with open Force and Violence upon our good Subjects, passing and repassing in the publick Streets, Roads, and other Places in or near the Cities of London and Westminster, to the great Annoyance of our peaceable Subjects: And whereas one Thomas Jones, otherwise Harper, was on the Twentieth of January last committed to the Prison of the Gatehouse in Westminster, on Suspicion of Felony, and the said Thomas Jones, otherwise Harper, being so in Prison, divers Persons, to the Number of Twenty and upwards, armed with Pistols, Cutlasses, and other offensive Weapons, on the same Twentieth Day of January, in a forcible Manner did enter the faid Prison, and did wilfully and maliciously asfault, shoot at, and wound several Persons therein, and by Force and Violence took away and rescued the said Thomas Jones, otherwise Harper, from the said Prison, in open Defiance of the Laws of this our Kingdom; and several other Offenders, who have been taken into Custody, have of late, with Force and Violence been rescued and set at Liberty by great Numbers of Armed Persons; We therefore, out of a tender Concern for the Lives and Properties of our loving Subjects, and in order, if possible, for the Future, to prevent such wicked and detestable Practices, have thought fit, by and with the Advice of our Privy Council, to issue this our Royal Proclamation, and do here-by strictly charge and command, That the said

Laws,

Laws, and all other Laws made for the Prevention and Punissiment of Offences of this Sort, be duly put in Execution: And we do hereby strictly command and require all our Justices, Sheriffs, Under Sheriffs, and Civil Officers whatsoever, and all other our loving Subjects, that they do use their utmost Endeavours to discover and apprehend all such Persons as have been or shall be guilty of the Offences before mentioned, and that they do effectually put the said Laws in Execution; and for the Encouragement of all Persons to be diligent in endeavouring to discover and apprehend all such Offenders, we do hereby promise and declare, That any Person or Persons, who shall discover and apprehend any Offender, who bath at any Time within three Months last past committed, or hereafter, within the Space of Fifteen Months from the Date hereof, shall commit any Murder whatsoever, or any Robbery, with open Force and Violence, in any Street, Highway, Road, Passage, Field, or open Place in the Cities of London or Westminster, or within Five Miles round the same, or shall discover and apprehend the said Thomas Jones, otherwife Harper, or any of the said Persons who were concerned, or aiding and affifting in the Rescuing the said Thomas Jones, otherwise Harper, so as the said Thomas Jones, otherwife Harper, or any other of the said Offenders. To to be apprehended, be convicted of the said Offences, or any of them, shall have and receive for the said Thomas Jones, otherwise Harper, and each and every fuch other Offender so apprehended and convicted as aforesaid, the Sum of One Hundred Pounds, over and above all other Rewards to which such Person or Persons may by any Act of Parliament be intitled; which said Sum of One Hundred Pounds, for every such Person so apprehended and convicted as aforesaid, The Commissioners of our Treasury, or our High Treasurer of Great Britain for the Time being, are hereby directed and required to pay accordingly, without any further or other Warrant in that Behalf; and if the Person so discovering and apprehending any such Persons as aforesaid, (except the Perfons actually giving a Wound in any such Murder, and the said Thomas Jones, otherwise Harper) shall have been an Accomplice in any such Murder, Robbery, or Rescue, and by reason thereof shall stand in Need of our most gracious Pardon, we do hereby further promise and declare, That such Person shall have our most gracious Pardon.

Given at our Court at St. James's, the First Day of February, 1748, in the Twenty

second Year of our Reign.

#### GOD fave the KING.

Bassora, October 12. Ibrahim Shaw came from Fabirez to Koom, where he and the Ophgoon Soldiers left their Families and Effects, and set out for Mushat to meet Shawrook Shaw; when they had passed some Stages, the People, whose Business it was to provide Grain for the Army, returned and acquainted him, that the Subjects at a Village by Samnune had resused to give any, and were retired into the Castle; upon this the King ordered away Emeer Caun, Head Gun-

ner, with all the Artillery, to take it; but after he was set out one or two Days, the King was very apprehensive he should go farther than he had ordered, and join Shawrook Shaw; this he communicated to the Ophgoons (whom he depended upon, and encouraged more than the Persians, which from the Beginning has offended the latter much) who advised him immediately to send a Messenger to him with Orders to return; and as foon as he got him into his Hands, to cut off all the Persians; this Emeer Caun's People, that were in the Camp, adviced him of; in Answer to which he sent him, Word that the Mules were so tired they could not draw the Guns back again. As soon as he had dispatched the Messenger, he sent Word to the People he was come against, how the Case was, that he would join them, and when Ibrahim Shaw came near with his Camp, he would fire upon them; this they were glad of. The next Day the Army arrived, and accordingly, when they came very near, the whole Artillery were discharged upon them, which irritated the Ophgoons so much, that they fell upon the Persians in the Camp, and killed all they could, and the rest run away. The Ophgoons immediately marched to Koom, in order to get their Wives and Effects, but the People in the Town refused to deliver them, saying they belonged to Shaw. rook Shaw. Ibrahim Shaw followed the Ophgoons, and received the same Answer they had done. Emeer Caun, when he saw the Camp in that Confusion, followed them with his Soldiers, and arrived at Koom when they were parleying, fell upon the Ophgoons, cut the greatest Part of them to Pieces, and took the King Prisoner. The News of this soon spread about, and Spahaun was taken Possession of for Shawrook.

Naples, Jan. 13. The King, who fince his Advancement to the Throne has had no Ambassador at the Imperial Court, has at length no minated the Prince de Compo Reale, a Sicilian, for that Employment, and his Excellency will set out for Vienna soon after his Majesty shall be informed of their Imperial Majesties having named an Ambassador of equal Rank to reside at this Court. Orders are given for the immediate Equipping our Ships of War and armed Vessel, in order to cruize upon the Corsairs of Barbary, which still continue very much to infest the Coasts of this Kingdom.

Genoa, Jan. 17. By Letters from Leghorn we are informed, that a Venetian Frigate of War, and an English Vessel laden with Corn, had both perished at Sea in the Course of the preceeding Week, the first near Messina, and the last off the Island of Lys, but that the Crews of them had been saved. The same Letters add, that the Corsairs of Barbary are grown so audacious as to attack indifferently all Ships they meet, without regarding either their Passports or their Flags.

Turin, Jan. 20. The Quantity of Silk usually produced in this Kingdom, having fallen, very short last Year, the King, at the Request of the Manusacturers of that Commodity, has caused a new Edict to be published, strictly prohibiting the Exportation of it to Foreign Countries. The sending of Oxen out of this Kingdom is likewise prohibited. Orders are sent to Nice to prepare

A Palace for the Reception of the Infanta Dona Marie Antoinette, future Spouse of the Duke of Savoy, who is expected in the Month of April next, accompanied by the Cardinal Infant her Brother, and the Dutchess Dowager of Albe.

Vienna, Jan. 24. The Elector Palatine has hamed M. de Menshengen, one of his Privy-Councillors, to receive, from the Hands of the Emperor, the Investiture of his Estates, upon the ancient Footing; and we hear that all the other Princes of the Empire intend soon to follow his Example, several of them having already named Ministers Plenipotentiaries for that Purpose. The Aulick Council continue their Deliberations for reconciling the Differences which have lately risen between the Elector of Mayence and the Bishop of Wurtzbourg. By Advices from Munich we learn, that the Elector of Bavaria has named the Baron de Haslang to be his Minister to this Court.

Copenbagen, Jan. 30, N. S. This Morning, about Six o'Clock, the Queen of Denmark was happily delivered of a Princes; and her Majesty is at present as well as can be expected in her Circumstances. The new-born Princes, who is to be christened this Afternoon, is likewise in a very promising State of Health.

Berlin, Jan. 31. On the 27th Instant the Lord Hyndsord set out from hence for Hanover, from whence he will proceed on his Journey for London; and on the 29th the King went to Potsdam, accompanied by Duke Ferdinand of

Brunswick Wolfenbuttle.

Hague, Feb. 5, N. S. His Serene Highness the Prince of Orange assisted both Yesterday and To-Day at the Assembly of their High Mightinesses the States-General, when several Military Officers, who have been promoted by his Serene Highness, took the usual Oaths for their several Employments. The Prince of Saxe Hildburghausen is expected here in a few Days, as is also the Lord Hyndford from Berlin.

Saturday the 20th Instant, being the Anniverfary of his Royal Highness the Prince of Wales's Birth-Day, the Great Guns were fired at his Majesty's Park the Phoenix, and answered by Vallies from the Regiments in Garrison, which were drawn out in the Royal Square at the Barracks, and at Noon there was a splendid Appearance of the Nobility and other Persons of Distinction to compliment his Excellency the Lord Lieutenant upon this Occasion. In the Evening there was a Play given by his Excellency for the Entertainment of the Ladies, and the Night concluded with Bonfires, Illuminations, and all other Demonstrations of Joy: And last Night there was a Ball at the Castle for the Entertainment of the Ladies, who were very numerous, and dressed in the Manufactures of this Kingdom,
