IS Majesty came this Day to the House of Peers, and being in his Royal Robes seated on the Throne with the usual Solemnity, the Honourable Sir Henry Bellenden, Gentleman Usher of the Black Rod, was sent with a Message from His Majesty to the House of Commons, commanding their Attendance in the House of Peers. The Commons being come thither accordingly, His Majesty was pleased to give the Royal Assent to,

An Ast for continuing and granting to bis Majesty certain Duties upon Malt, Mum, Oyder, and Perry, for the Service of the Year One Thousand Seven Hundred and Fifty.

An Act for repealing the Duties now payable upon China Raw Silk, and for granting other Duties in lieu thereof.

An Act for punishing Mutiny and Desertion, and for the better Payment of the Army and their Quarters.

An Act to render Prosecutions for Perjury, and Subornation of Perjury, more easy and effectual.

An Act for enlarging the Term and Powers, granted by an AEt passed in the Fifth Year of the Reign of his present Majesty, for repairing and amending the Roads leading from the Town of Manchester in the County of Lancaster, through the Town of Ashton under Line and Parish of Mattram Longdendale, and from thence to Salter's Brooke in the County Palatine of Chester.

An Act for repairing, improving, and maintaining the Haven and Piers of Great Yarmouth, and for depthening and making more navigable the

several Rivers emptying themselves into the said Haven, and also for preserving Ships, wintering therein, from Accidents by Fire.

Petersbourg, March 1. Her Imperial Majesty is gone for a few Days with the whole Court to Czarkazelo.

Bologne, March 3. Prince Charles of Baden Dourlach arrived here last Saturday with a numetous Retinue; and after staying two or three Days; will proceed on his Journey to Rome.

Rome, March 3. The Pope has appointed Cardinal Guadagni to be Bishop of Frascati, in the room of the late Cardinal Bichi. Provisions have lately risen to such an extravagant Price in this City, on Occasion of the great Number of Foreign Nobility and others who are continually coming hither, that the common People begin to murmur very much.

Florence, March 6. On the 4th Instant the Turkish Ambassador, who arrived here some Days ago from Leghorn, set out from hence with all

his Retinue for Vienna.

Prague, March 7. The famous Rabin; who has been confined for some Time past in this City, having been convicted of feducing feveral Country People to embrace the Jewish Religion; was this Morning sentenced by his Judges to be burnt alive.

Dresden, Marth 12. M. Petzold, our late Resident at the Court of Russia, is appointed to go in the same Quality to that of Vienna, in the room of M. Lautenfach, who has obtained his Recall. We are assured that the King has changed his Sentiments with regard to the Journey he proposed taking to Leipzick, and that he will certainly set out for Poland immediately after Easter; which makes it believed; that the Affairs of that Kingdom require his Majetty's Presence rather more than was at first imagined; and 'tis now laid, that the Affair of the State Prisoners will be decided before his Departure. An Edict has been published here, within these sew Days past, by which all the Taxes of this Electorate are to be farmed out for & certain Number of Years to the highest Bidders. We learn from Dantzick, that the Bishop of Warmie was arrived there, in order to adjust the Differences which have sublisted for some Time past between the Magistrates and Inhabitants of that City.

Vienna, March 12. The Anniversary of the Birth of the Archduke Joseph, their Imperial Majesties eldest Son, will be celebrated at Court To-morrow with great Magnificence; on which Occasion Fifty-nine Noblemen will be declared Lords of the Bed-Chamber. The Departure of Count de Bentinck for the Hague, is fixed for the 15th of next Month. 'Tis said, a Resolution has been taken to keep, in Croatia, a Body of 16 or 18000 Troops in Readiness to march upon the first Notice. Their Imperial

Majesties have appointed Count Kaunitz, and the Duke de Spezzano, to be of their Privy Council.

Göpenhagen, March 17. The King has appointed the Baron de Rantzau to succeed the late M. de Lange, as Secretary of the Legation to their High Mightinesses the States General of the United Provinces.

Brussels, March 19. M. Berkenrode, Ambassador from the States General to the Court of France, arrived here Yesterday from the Hague. This Morning he was introduced to Prince Charles of Lorra'n; and To-morrow he proposes to set forward on his Journey to Paris.

Hague, March 24, N. S. On Saturday last the 21st Instant, M. de Boetzlaer and the other Commissaries appointed by the States of Holland to examine into the Methods by which the new Regulations relating to the Taxes have been carried on in the several Parts of the Province, and to hear and redress Grievances upon that Head, lest this Place on their Journey to Amsterdam, where they enter upon Business according to their Instructions, and will from thence continue their Progress through the other confiderable Towns of Holland, in Execution of the said Commission. There is another Commission likewise issued out, appointing M. de Catwyk, with some other Deputies of the States, to examine the State of the Finances of the Province, and to make their Report accordingly to the Prince Stadtholder. His Serene Highness is at present much engaged in fettling the new Commissions of several Deputies of the different Provinces to the States General, particularly those of Guelderland and Overyssel. In the latter M. de Rechteren has been displaced, and M. de Palland appointed to succeed him in his Office. It is faid, that the Prince of Orange has an Intention of going to Grave some Time next Month, in order to meet and confer with Prince Charles of Lorrain, before his Royal Highnes's Departute for Vienna. Admiral Schryver is lately returned here from Flushing in Zealand, where he has been employed in taking a Survey of the Dock, in order to lay before his Serene Highness a Plan for enlarging and making it more commodious for the Reception of Ships of War, the Necessity of which was particularly felt during the late War, when the English Fleet lay off that Coast. He has made his Report hereupon to the Prince, and it is thought a large Sum of Money will foon be negociated for the Execution of this Delign. Several Military Promotions have been made here within these sew Days, and many Officers, who have some Time ago been taken into the Pay of the States, have been assigned to their proper Regi-The Earl of Pembroke, who has been here about a Fortnight, set out this Morning for Utrecht, in his Way to Lausanne in Switzerland.
