Florence, March 20. On the 14th Instant M. On the 19th the Archduke's Name-Day was celebrated here with the usual Solemnity; on which Occasion, all the Foreign Ministers, the Nobility, and Military Officers, appeared at Court in their rich Habits.

Dresden, March 25. His Polish Majesty returned Yesterday from Hunting, and intends, after the Holidays, to take the same Diverfion, which it is expected will continue till near the Court's Departure for Warsaw.
