A PROCLAMATION.

George Armagh. Newport, C. THEREAS the Lords Justices of Great Britain have signified unto us their Pleasure, That the Parliament of this Kingdom, which now stands prorogued to Tuesday the Twenty Ninth Day of May Instant, be further prorogued to Tuesday the Tenth Day of July next; we do therefore publish and declare, That the said Parliament be, and accordingly the said Parliament is, hereby further prorogued to Tuesday the Tenth Day of July next: Whereof the Lords Spiritual and Temporal, and the Commons in this present Parliament, are to take Notice accordingly:

Constantinople, April 23. In the Night between the 15th and 16th Instant, a Fire broke out in the Scharschee or Market, where all the Riches of this great City center, and notwithstanding it was always supposed to be Fire-Proof, being vaulted and of Stone, it was entirely consumed to the Ground, and with it an immense Value in rich Apparel of all Sorts for Men and Women, Quilts, Sophas, Warehouses belonging to Dealers in Gold and Silver Wares, and Money Changers, who had a great Part of the Cash of this City in their Hands. The Damage is computed to amount from 10,000 to 30,000 Purses of Money, which is from 5 to 15 Millions of Dollars. This Fire appearing in several different and opposite Parts between Eleven and Twelve at Night, and some Bags of combustible Matter being found, it was imagined the Intent was to get at the Arms which were sold there, in order to raise a Rebellion; but an Order was fent to the Janizar Aga to keep the Gates of these great Exchanges shut. On the 18th one of the great Arches of the Buildings gave Way, and crushed some People under its Ruins, which occasioned so much Confusion, that the Malevolents took Advantage thereof, and began to cry out amidst the distressed Multitude, Rebellion, and that the Grand Signior was dead. On which an Alarm spread through the whole City, the Shops began to be shut, and Bake-houses to be stormed for Bread, so that double Guards were immediately placed, and Rounds made by the Vizier and other great Officers Day and Night. On the 19th, all the Cziosbaskys, or Colonels of Janizaries, were

called to the Porte, and a confiderable Sum of Money given them to distribute amongst the Janizaries, fince which Time all remains in perfect Tranquility. Upon some Murmurs and Complaints, the Janizar Aga has been deposed and exiled, and the Caul Cheaiazy, or Lieutenant General of the Janizaries, has been made Aga. Several Persons are imprisoned, but no Executions have yet been made.

Naples, May 14. Brigadier Colonne, Brother to the Prince de Stigliano, having married the Widow of the late Chevalier de Palma, contrary to the King's express Orders, which forbids Officers marrying without his Majesty's Permission, the King has ordered him to be committed to the Castle of Basa, and his Lady to be shut up in a Convent. His Majesty has likewise ordered the Bishop of Nosa, who gave his Consent to their Marriage, to be cited before the Royal Chamber, in order to his being cenfured for the same.

Dantzick, May 23. A Deputation of twenty fix Members of the Colleges of the Magistracy of this City, set out the 20th Instant for Warsaw, at the Head of whom are the Burgomaster Ferber, the Sindick Leynick, and the Councillor Janson. A Deputation of the Burghers took the same Route the next Day, having at their Head the Elders of each trading Company. These Deputations are to lay their Complaints against each other before the King, and to befeech him to reconcile them in such Manner as his Majesty shall judge most conformable to the Rules of Equity.

Munich, May 23. The Prince of Deux Ponts, who has spent some Days with their Serene Highnesses at the Palace of Nymphenbourg, fet out Yesterday Morning on his Return to Manheim. The Count de Aubigny, the French Minister at this Court, having obtained the King his Master's Leave to return Home, is preparing

to fet out for Paris.

Vienna, May 23. The Envoy from the Dev and Regency of Tripoly had Yesterday his Audience of Leave of Count Harrach, President of the Aulick Council of War, with the usual Ceremony; after which he was magnificently treated, with all his Retinue, by Order of the Court. The Chamberlain Count de Millesimo was married a few Days ago, in the Presence of their Imperial Majesties, to the Countess de Korzenski, one of her Imperial Majesty's Maids of Honour.

Nuremberg, May 25. The Duke and Dutchess of Wirtemberg, accompanied by a numerous Retinue, arrived last Saturday Night at Erlang, where the Margrave was come the same Day from Bareith to receive them. The two Courts passed that Night together there, and the next Day set out for Bareith, where the Duke of Wirtemberg proposes staying some Days.

Copenhagen, May 26. Last Friday Night the Queen arrived in persect Health at the Palace of Fredensbourg, where his Majesty was waiting to receive her. The new Regiment of Foot lately raised by General Scholten, in the District of Laland, was reviewed a few Days ago by that General, and made a very good Appearance.

Leipsick, May 27. M. Calkoen, Ministe Plenipotentiary from the States General of the United Piovinces to the King of Poland, as Elector of Saxony, arrived here last Week, and proposes to set out To-morrow for Dresden.

Brunswick, May 27. The Dake our So vereign has caused an Ordonnance to be published, by which, in order to increase the Number of French Protestants in his Dominions, he not only confirms all the Privileges and Advantages allowed by his Predecessors to those already settled in this City, but offers the same to all other French Protestants as shall hereafter come and settle here, or in any other Part of his Dominions.

Dusseldorp, May 29. Numbers of Families from the Lower Palatinate, from Swabia, and from the Principality of Sartzbourg, going as Settlers to Nova Scotia, continue passing through this City on their Way to the Rhine.

Middlebourg, May 31. The Prince of Orange has appointed M. Bomme, an eminent Merchant at Ziriczee, to be his Serene Highness's Representative to the East India Company, in the Department of the Chamber of Zealand.

Dort, June 2. The Baron de Boetslaer, and the other Deputies of their High Mightinesses, who have been for some Time at Rotterdam, making some new Regulations relating to the Finances of that Province, departed from thence Yesterday Morning in one of the States Yachts, and arrived that Asternoon in this City, where they are to make the like Regulations.

Hague, June 4. His Serene Highness the Prince of Orange has appointed Lieutenant Colonel Marty to be second Colonel of the Swiss Regiment of Sturler; and his Highness has also filled up several other Military Employments

which were become vacant.

Georgia Office, Westminster, May 25, 1750. Whereas the Trustees for establishing the Colony of Georgia in America, thought it necessary in the first Establishment of that Colony to restrain the Grants they made of Lots of Land to limitted Tenures only, in order thereby to prevent many Atuses which at that Time might probably have defeated the good Ends proposed by that Establishment, and during the late War it might have been of dangerous Consequence to have alter'd the Tenures; but as a general Peace and Tranquility happily prevail, the said Trustees are of Opinion, that the intended Enlargement of the Tenures may now be safely made, and have come to the following Resolution, viz.
