A D E C L A R A T I O N,
Appointing the Distribution of Prizes taken
from the *Genoeze*.

Dorset, P. Marlborough, Argyll, Bedford.

WHEREAS His Majesty's Ships of War did, between the First Day of May, One thousand seven hundred and forty five, New Style, and the entire Cessation of Hostilities, by virtue of the late Treaty of Aix la Chapelle, seize and take several Ships, Vessels, and Goods belonging to the Subjects of the Most Serene Republick of Genoa, the Property whereof, upon their being condemned as lawful Prize, belongs to his Majesty: And whereas the Genoeze did, within the Time aforesaid, take, and seize in the Port of Genoa, on Board a Tartan called the St. Catherine of Padua, Pedro Raffetti Master, divers Bales of Silk, the Property of several Merchants his Majesty's Subjects trading to Italy, to the Amount or Value of Six thousand six hundred eighty two Pounds, four Shillings and eleven Pence, the Prime Cost thereof (that is to say) one Bale belonging to Anthony Noguier, Value One hundred and sixty four Pounds, ten Shillings and five Pence; two Bales belonging to Richard Morhall and Company, Value Three hundred twenty seven Pounds, fifteen Shillings and one Penny; two Bales belonging to William Selwin and Company, Value Three hundred fifty three Pounds, eleven Shillings and eleven Pence; two Bales belonging to Peter Nouaille, and James Frushard, Value Three hundred twenty one Pounds, ten Shillings and four Pence; one Bale belonging to John Delamare and Company, Value One hundred and seventy three Pounds; one Bale belonging to Mary Magdalene Alavoine, Value One hundred seventy two Pounds, twelve Shillings; two Bales belonging to Henry Lonbier, Value Three hundred and seventy one Pounds; eight Bales belonging to John Blaquiere, Value One thousand three hundred seventy seven Pounds, nineteen Shillings and three Pence; five Bales belonging to William Sheldon, Value Eight hundred and seven Pounds two Shillings; four Bales belonging to Roger Hogg, Value Seven hundred thirty nine Pounds, eighteen Shillings and four Pence; three Bales belonging to Noah Titner, Value Five hundred thirty two Pounds, fourteen Shillings and eleven Pence; three Bales belonging to Joseph Poinhan, Value Five hundred and twenty Pounds; three Bales belonging to John Logier Lamotte and Company, Value Four hundred eighty five Pounds, fourteen Shillings and ten Pence; and two Bales belonging to William Wigget, Value Three hundred thirty four Pounds, fifteen Shillings and ten Pence; and afterwards proceeded to Condemnation thereof: And whereas a Commission did issue, by virtue of his Majesty's Order in Council, published in the Gazette of the Thirteenth of February, One thousand seven hundred and forty seven, to empower his Majesty's Courts of Admiralty to try and condemn the several Ships, Vessels, and

Goods, belonging to the Genoeze, which had been, or should be taken by his Majesty's Ships of War, as the Ships and Effects of his Majesty's Enemies; and several of such Ships and Effects so taken have been condemned as lawful Prize; but several Appeals have, by, or by the Orders of Signior Gastaldi, Minister of the Most Serene Republick of Genoa, being interposed to the Lords Commissioners of Appeals in Prize Causes from those Sentences: And whereas a Petition has been presented to his Majesty in Behalf of the Officers and Seamen concerned in the taking of the said Prizes from the Genoeze, setting forth, That from his Majesty's known Generosity and Bounty they had Reason to hope, that his Majesty would be graciously pleased to give up his Right in such Prizes as had or might be thereafter condemned, in their Favour; in Confidence whereof they had come to an Agreement with Signior Gastaldi, Minister of the Most Serene Republick of Genoa, acting in Behalf of the Genoeze Subjects, to take Place in case his Majesty should be graciously inclined to give his Royal Assent thereto, and which they prayed his Majesty would be pleased to do: And whereas a Memorial has been also presented by the said Signior Gastaldi, Minister of the said Republick of Genoa, setting forth, That for avoiding the great Expence of Law Suits, and other Causes, he did, on the Twentieth Day of September last, conclude such Agreement with the British Captors, in regard to the Prizes made upon the Genoeze Subjects, or Inhabitants of the State of Genoa, and hoping his Majesty would vouchsafe to give his Royal Assent to the said Agreement, and put thereby a perpetual Silence to future Disputes: And whereas a Petition has been also presented in Behalf of the said Merchants his Majesty's Subjects trading to Italy, setting forth their aforesaid Loss, and praying, That his Majesty would be graciously pleased to order, That, before any Distribution be made of the Produce of the said Ships and Effects that had been taken from the Genoeze, they should be reimbursed thereout the Amount of their said Effects, that had been so seized and condemned by the Genoeze; We having taken the Premises into our Consideration, do, by and with the Advice of his Majesty's Privy Council, hereby publish and declare, That the net Produce, arising from the Sale or Disposal of all the Ships, Vessels, Goods, Monies, Wares, Merchandizes and Effects, belonging to the Genoeze, which have been seized and taken by his Majesty's Ships of War, between the said First Day of May, One thousand seven hundred and forty five, New Style, and the Time of the Cessation of Hostilities as aforesaid, either upon Genoeze, or Neutral Bottoms, and which have been, or shall be condemned (and have not by the Sentence of any of his Majesty's Courts of Admiralty, or Vice Admiralty, or otherwise, been already restored to the Genoeze) upon Signior Gastaldi's withdrawing or releasing, or causing to be withdrawn or released, all Appeals interposed before the Lords Commissioners of Appeals, from any Sentences condemning any

Ships, Vessels, or Goods, as the Property of the Genoeze, shall be distributed, paid, applied, and disposed of as follows; that is to say, That in the first Place, by and out of the Money now remaining in the Bank, as the Produce of great Part of the Prizes taken from the Genoeze as aforesaid, there be paid and defrayed the Costs and Charges of withdrawing or releasing the said Appeals, and the other Costs and Charges incurred by the Captors, and the said Signior Gastaldi, towards carrying the aforesaid Agreement made between them into Execution; and in the next Place, there be paid thereout the said Sum of Six thousand six hundred eighty-two Pounds, four Shillings and eleven Pence, to the several British Merchants, Owners of the said Goods and Effects condemned at Genoa, herein before particularly named, in the Proportions herein before mentioned; and that the Residue of the said Money in the Bank (except such Part thereof, if any, as is the Produce of any Ship, Vessel, or Goods, which by Sentence of any of his Majesty's Courts of Admiralty, or Vice Admiralty, or otherwise, have been already restored to the Genoeze as aforesaid) be forthwith divided into three equal Parts, and one third Part thereof be paid to the said Signior Gastaldi, Minister of the said Serene Republick of Genoa, for or on the Behalf of the Subjects of that Republick, to whom the several Ships, Vessels, or Goods, which the said Money is the Produce of, did respectively belong, in full Discharge of all their Claims and Demands, for and in Respect of such Ships, Vessels, or Goods; and the two other remaining third Parts of the said Money in the Bank, be paid to and amongst the Officers and Sailors of his Majesty's Ships, who were concerned in the seizing and taking the Ships, Vessels, and Goods belonging to the Genoeze, of which the said Money is the Produce, and to be distributed and divided amongst the said Officers and Sailors, in the same Manner and Proportions, as is directed by a Proclamation of the Nineteenth of June, One thousand seven hundred and forty, for the Distribution of Prizes taken from the Enemy, in Pursuance of an Act of Parliament made in the Thirteenth Year of his Majesty's Reign, intituled, *An Act for the more effectual securing and encouraging the Trade of his Majesty's British Subjects to America, and for the Encouragement of Seamen to enter into his Majesty's Service*; and that all other the net Produce, arising from the Sale or Disposal of all and every or any the Ships, Vessels, or Goods belonging to the Genoeze, which have been seized and taken by his Majesty's Ships of War as aforesaid, and which have been or shall be condemned, shall be divided into three equal Parts, in like Manner, as the said Residue of the said Money remaining in the Bank is herein before directed to be divided; and that one third Part thereof be paid to the said Signior Gastaldi, and the other two third Parts thereof be paid to the Officers and Sailors of his Majesty's Ships of War, concerned in the taking of those Ships, Vessels, and Goods, in like Manner as is herein before directed, with Respect to the said one third and two third Parts of the said Residue of the said Money remaining in the Bank: And to the End that his Majesty's most gracious Intentions may be effectually carried into Execution, We do hereby strictly enjoin all and every Admiral and Admirals, Commander and Commanders of his Majesty's Ships of War, who have taken any Prize as aforesaid, as soon as may be, to transmit, or cause to be transmitted to the Commissioners for executing the Office of the High Admiral, a List of all

Ships, Vessels, and Goods belonging to the Genoeze, which have been taken by him or them, together with an Account of the net Produce arising from the Sale or Disposal thereof; and also to transmit to the Commissioners of his Majesty's Navy, a true List of the Names of all the Officers and Seamen, who were actually on board his Majesty's Ships of War under his or their Command, at the taking such Prize, which List shall contain the Number of each Person as he stands upon the Ship's Books, and the Quality of his Service, and the same shall be subscribed by the Captain or Commanding Officer, and three or more of the chief Officers on board; and we do hereby require and direct the Commissioners of his Majesty's Navy, or any three or more of them, to examine, or cause to be examined such List by the Muster Book of such Ships of War, to see that such List doth agree with the said Muster Book, as to the Names, Qualities, or Ratings of the Officers and Seamen belonging to such Ships of War, and upon Request, forthwith to grant a Certificate of the Truth of any List transmitted to them, to the Agents nominated or to be nominated and appointed by the Captors to take Care or dispose of such Prize, or the Produce thereof, and also upon Application made to them, to give or cause to be given unto the Agents, who shall at any Time or Times be appointed as aforesaid by the Captors of such Prizes, taken by any of his Majesty's Ships of War, Copies of all such Lists from the Muster Book of any such Ships of War, as the said Agents shall find requisite for their Direction in paying the Produce of such Prizes, and to be otherwise aiding and assisting to the said Agents as shall be necessary; and We do hereby further declare and direct, That publick Notification shall be given to the Persons or Agents so appointed, of the Day appointed for the Payment of the several Shares of the Captors, after which publick Notification, if any Mens Shares shall remain in the Hands of the Persons or Agents appointed as aforesaid, and shall not be legally demanded within three Years, then such Share or Shares so remaining in such Persons or Agents Hands, shall go to, and be paid to the Use of Greenwich Hospital: And to the End that all Persons who are or shall be intitled to any such Share or Shares, may have due Notice of the Time of Payment thereof, so as to make their Claims thereunto in due Time, We do hereby require, That the Persons or Agents which have been, or shall be appointed to make such Sales, shall give Notice of the Day and Place, which shall be by them appointed for Payment of the several Shares to the Captors in the London Gazette; and to the End that the Governors of Greenwich Hospital may know also who are the Persons or Agents employed to receive and pay the several Shares of such Persons, as were on board the Ship or Ships at the Time of taking any Prize, so as to demand the Shares of such of the Captors who shall not legally make their Demand within three Years, We do hereby direct, That a true List of the Names of the Persons, as shall be so appointed Agents for the Purposes aforesaid, shall be forthwith certified to the Governor or Deputy Governor for the Time being of the said Hospital, by his Majesty's High Court of Admiralty, which is hereby required to take an Account of the Names of such Persons as are or shall be appointed Agents by the Captors.

Tripoly, April 5. On the 19th Instant a cruizing Pollacco of this Place brought into the Port, after a smart Engagement, a Danish Ship of 16 Guns and 16 Men, called the St. Antonio, John Sands, Master.

Turin, May 6. The Dutchess arrived, as was expected, the 2d Instant at Rivoli, and the Day following all the Foreign Ministers waited on her Royal Highness there. On Thursday the 4th, her Royal Highness made her Entry, and she was received with all the Magnificence possible. On this Occasion the Garrison is augmented to nine Battallions and 15 Squadrons of Dragoons. The Foot were drawn up in the two Squares of the Town through which the Royal Family passed, and the Dragoons followed the Coaches. The King of Sardinia has declared the Chevalier Osorio Secretary of State, and the Marquess de Gorgegne is new Great Chamberlain,

Florence, June 4. They write from Milan, that about 29 Soldiers of the Regiment of Baleyra, who were in Garrison at Cremona, had deserted from thence last Week with their Arms, which Count Pallavicini having been informed of, ordered a Number of Officers on Horseback to follow and arrest them, who coming up with them, met with so warm a Reception, that nine of the Officers were killed upon the Spot, and two others dangerously wounded; whereupon the Remainder thought proper to retire without their Horses, with which the Deserters had taken the Road to Plaisentia,

Stutgard, June 9. The 26th past we had here, and in this Neighbourhood, a most surprising Storm of Wind, accompanied with very large Hail-Stones, which have done a deal of Mischief to the Fruits of the Earth, and particularly to the Vines. This Storm was followed by such a prodigious Shower of Rain, that in less than an Hour the whole Neighbourhood was so far laid under Water, as to make the Roads unpassable for some Days.

Paris, June 12. On Sunday last publick Prayers were put up, for the first Time, in all the Churches of this City, for the happy Delivery of the Dauphiness.

Berlin, June 13. Advices have been received at Court, that the King arrived at Coslin on the 3d Instant, and on the 4th continued his Journey for Prussia,

Copenhagen, June 13. His Danish Majesty comes to Town on Monday next, and the Day following there will be a Court at the Holm, where the Ships, now ready upon the Stocks, are to be launched in his Majesty's Presence. After this his Majesty sets out immediately for Bregentwed, the Seat of the Grand Marshal, and from thence pursues his Progress through the Baltick Islands. During his Majesty's Absence, which is like to be very short, the Queen, who is in perfect Health, proposes to divide her Time between Friedensburg and Jagerssprus,

Hanover, June 15. The King having appointed this Day for the first General Review of his Troops of this Electorate, to the Number of 18 Squadrons and 12 Battalions, they were early this Morning drawn up under Arms in a Plain near this City, where his Majesty, attended by several Persons of Quality, the Foreign Ministers, and other Persons of Distinction arriving about Eight o'Clock, was immediately saluted by a general Discharge of the Artillery, and having rode up and down the Line, saw the whole Body of Troops, by single Battalions and Squadrons, pass in Review before him. The Troops all made a very fine Appearance, and after having been review'd by the King,

perform'd three running Fires with the greatest and most exact Order possible, which gave his Majesty entire Satisfaction, who returned afterwards to Herrnhausen about One o'Clock. The particular Reviews of these Troops are appointed by the King for the following Days, viz. To-morrow the 16th his Majesty is to review the six Battalions undernamed, viz. 2 of the Guards, 1 of Souhiron, 1 of Sporcken, 1 of Freudemann, and 1 of Hardenberg. On Wednesday the 17th his Majesty is to review eight Squadrons of Horse, viz. the Life Regiment 2, Hammerstein's 2, Platen's 2, and Polnitz's 2, together with the Gardes du Corps and Horse Grenadiers. On Thursday the 18th his Majesty will Review eight Squadrons of Dragoons, viz. Pontpietin's 4 Squadrons, and Adelpsen's 4 Squadrons. On Friday the 19th his Majesty is to review six Battalions of Infantry, viz. Klinckowstrom's 1, Brunck 1, Krugh 1, Munchow 1, Cheusses 1, and Hodenberg 1. The second General Review, to consist of 16 Squadrons and 12 Battalions, is appointed by his Majesty for Monday the 22d Instant, and the particular Reviews of these Troops are to be as follow: On Tuesday the 23d his Majesty is to review five Battalions, viz. Boselager 1, Block 1, Borck 1, Ledebur 1, and Kielmannsegge 1. Wednesday the 24th is to be a resting Day. On Thursday the 25th his Majesty is to review eight Squadrons of Cavalry, viz. Montigny 2, Wreden 2, Bruchhausen 2, and Breidenbach 2. On Friday the 26th eight Squadrons of Dragoons, viz. Busch 4, and Behr 4. On the 27th six Battalions of Infantry, viz. Zastrow 1, Midzachten 1, Horn 1, Hugo 1, Haus 1, and Hammerstein 1. And at each of these general Reviews three Companies of the Artillery are to pass before his Majesty,

Hague, June 19. The Members who compose the States of Holland arrived here last Wednesday, according to their Summons, and Yesterday they resumed their Deliberations. Major General Cornabe, and Major General Sporcken, are gone to Amsterdam by the Prince Stadtholder's Orders, to settle every Thing necessary for the intended Expedition to Surinam.

This Day being the Anniversary of His Majesty's Succession to the Crown, the Guns in the Park and at the Tower were fired at Noon, and all other publick Rejoycings were shewn on this Occasion.
