Leghorne, June 8.

HE Corfairs of Tripoly, who some Time ago made themselves Masters of a Danish Ship, named the St. Anthony, of 16 Guns and the like Number of Men, and carried her into Algiers, have fince condemned the said Ship and Cargoe, but released the Master and his Crew.

Petersbourg, June 9. Her Imperial Majesty is returned to this City from Czarkazelo. M. de Wahrendorff, the Prussian Minister, has received by Express from his Court, the Character of Minister Plenipotentiary from his Prussian Majesty, and will soon be admitted to an Audience

of the Empress in that Quality.

Venice, June 13. The Master of a French Ship arrived here from the Levant, has brought us the melancholy News of a most terrible Earthquake which happened in the Island of Cerigo on the 7th of last Month, which lasted about five Minutes, during which Time it threw down a great Part of the Houses of that Island, and upwards of two Thousand of the Inhabitants were buried in the Ruins.

Aranjuez, June 15. The great Quantity of Rain that has fallen in old Castille gives Hopes of ga very plentiful Harvest in that Province; and by the last Letters from Cadiz we are informed, that such a Number of Vessels, laden with Wheat and Barley from the North, were arrived there, that the Price of the former was considerably diminished, and that several of the said Vessels had put out of the Bay again, in order to go to other Markets, The Corn we are expecting from the Levant, has been detained by contrary Winds. Don Pedro de la Cerda, with the Men of War under his Command, was still at Cadiz, waiting for a favourable Wind to convoy the Register Ships bound to America. By Express from Cadiz we have Advice, that the two Men of War, Constante and America, which were lately sent to the Caraccas, and from thence to Carthagena and the Hayanna, in order to take in the Funds that were in those Ports, were safely arrived in that Bay, with a Cargoe of One Million three hundred and twenty thousand Dollars, besides some Cacao, Tobacco, Baynilla, and other Commodities. The Infant Cardinal, who came to Aranjuez to pay his Respects to his Catholick Majesty upon St. Fernando's Day, returned to St. Ildephonso on the 9th Instant. The Court received on the 10th Instant, by Express from Cadiz, the News of the Arrival of M. Spi-

nola, with the Ships Phænix, Dragon, and Royal Family, with Sixteen Million five hundred and fifty thousand Dollars in Gold and Silver, and above two Millions in Fruits; and his Catholick Majesty has ordered the Effects to be immediately delivered to the Commerce. Count St. Marsan, the Sardinian Ambassador, had his first Audiences of their Catholick Majesties on the 12th Instant. And on the 14th an Express came from Cadiz, with an Account of the Arrival of two Ships, under the Command of M. Orosco, from the South Seas, with between three and four Millions of Dollars, besides other Effects.

Stackbolm, June 16. Last Week the King fet out for Carlberg, in order to spend the Summer, but his Majesty will frequently be coming hither. Yesterday the Prince Successor came from Drotningholm, and this Morning the Re-

views begin, which will last some Days.

Vienna, June 17. On Saturday last their Imperial Majesties came from Laxenbourg to Schonbrun, and on Monday his Imperial Majesty, accompanied by Prince Charles his Brother, set out for Hollitich, where they propose to spend some Days in Hunting. Prince Charles of Lorrain having declared his Intention of fetting out for Brussels about the 10th or 12th of next Month, Count Bentinck has deferred his Departure for Holland to that Time. Count Cerbellon, Vice-President of the Council of Italy, having desired Leave to lay down his Employment, and to be permitted to retire into his Native Country of Spain, for the Remainder of his Days, her Imperial Majesty has granted his Request,

Konigsberg, June 18. On the 10th Instant his Prussian Majesty arrived here from Berlin, accompanied by the Princes Henry and Ferdinand his Majesty's Brothers, Prince Ferdinand of Brunswick, Count Rothembourg, Brigadier Turpin, Colonel Bodenbroek, and divers other Officers. On the 11th and 12th the Troops passed in Review before his Majesty. On the 13th there was a splendid Entertainment and a Ball at the Castle, at which were present a great Number of the Nobility; there were three Tables, making together 120 Dishes. The Ball was opened at Seven o'Clock by Prince Ferdinand and the Princels of Holstein Gottorp; and when it was ended, all the Company had the Honour of supping with his Majesty: On the 14th the particular Reviews began, which continued for two Days; and on the 16th at Night his Majesty set out for Dantzick on his Return to Berlin.

Munich, June 19. Last Week a Courier was sent from hence for Hanover, with Dispatches for the Count de Haslang, Minister from this Court to that of Great Britain, contakning Instructions for his Signing the Renewal of the Treaty with the Maritime Powers. The . Cardinal Prince and Bishop of Liege continues still here, having put off his Departure for Liege for a Month of fix Weeks. Count d'Aubigny, Minister from his most Christian Majesty to his Court, having received his Letters of Revocation, has prefented the same to his Electoral Highness, and is since set out for Paris.

Berlin, June 23. The King returned hither from Konigsberg on the 20th Instant, very well satisfied with the Condition in which he had found his Troops in Prussia; that Evening he supped with the Queen-Mother, and the next Morning his Majesty set out for Potzdam.

Hambourg, June 24. On Monday Night and Yesterday Morning we had great Disturbances here, the whole City being almost in Confusion, occasioned by the Joyners and other Artificers gathering themselves together in great Numbers, and infifting on an Augmentation of their Wages; but the Magistrates having sent out the City Militia, with Orders to fire on those who should commit any Violence; these vigorous Measures obliged the Artificers to difperse, since which we have been pretty quiet.

Franckfort, June 25. The Duke of Wurtemberg and his Dutchess are returned to Stuttgard from the Journey they had taken to Bareith; by whom we learn, that the Margrave and Margravine of Bareith were fet out on the 18th for the Baths of Carelsbadt. A few Days ago died Count John Frederick Rhingrave de Daun, by whose Death the House of Rhin-

graves de Daun is become extinct.

Hogue, June 30. The Troops intended for Surinam are preparing for their Voyage; Part of them has been formed into a Regiment of Ten Companies, each of 40 Men, of which Major General Sporcken has been appointed *Colonel. This Regiment is to set out first. The Remainder of the Troops are affembled, but have not as yet been regimented.
