Vienna, August 12.

IELD Marshal Count Bathiani set out Yesterday with the Body Guard of Archers for Bohemia, and the Counts Archers for Bohemia, and the Counts de Colloredo, Uhlefeldt and Konigsegg are expected to set out likewise in a Day or two; but their Imperial Majesties will not set out for that Kingdom till the 16th in the Morning. The Court having received Advice, that Count de St. Ignon, General of Horse, Colonel of a Regiment of Cuirassiers, and Commander of the Imperial Troops in Moravia, died there the 4th Instant, her Imperial Majesty has already appointed General Philibert to command the Troops in Moravia: His other Employments are not yet disposed of, but 'tis thought the Regiment of Cuirassiers will be given to the Prince of Hohenzollern. The Ceremony of the Investiture of the Estates of the Margrave of Baden Dourlach is fixed for the 14th Instant. Her Imperial Majesty has caused an Edict to be published for preventing the Frauds which have been usually committed by Watermen, Carriers, &c. Count Christiani, Great Chancellor of Milan, who arrived here on Thursday last, has already laid before their Imperial Majesties the State of Affairs in that Dutchy.

Madrid, Aug. 13. On Tuesday the 4th of this Month, their Catholick Majesties received the melancholy News of the King of Portugal's Death; and a general Mourning has fince been ordered for fix Months. By subsequent Advices from Lisbon we hear, that the present King has appointed Don Sebastian Carvalho, and the Abbe Mendoza, Secretaries of State. There is Advice from Cadiz, that the two Ships Nuestra Senora de Montserrate, and Nuestra Senora de la Caridad, arrived in that Bay from La Vera Cruz on the 30th of last Month. They bring about one Million and forty Thousand Dollars in Silver, and two Thousand in Gold, besides other

Coblentz, Aug. 16. Berlin, Aug. 18. On Wednesday last died here Baron Gortz, our late Envoy to the Court of Russia; as did likewise, a few Days before, General de Beauvre, both greatly regretted. Mustapha Aga, Envoy from the Kan of the Tartars, having had his Audience of Leave of his Majesty, and received a handsome Present for his Masters, and 2000 Crowns for himself, is set out on his Return home.

Hague, Aug. 25. The Prince Stadtholder arrived here on Sunday Evening about Nine of the Clock from Loo, which Place his Highness had left the same Day in the Forenoon. Mess. de Larrey and Marcelis, who had been at Loo to pay their Respects to the Prince and Princes, and to give his Serene Highness an Account of their Negociations in France, arrived here likewise from thence on Sunday Evening. The King of Portugal's Death has been notified to the States General by a Letter from the present King, which M. Berkenroode, their High Mightinesses Ambassador at Paris, received from M. de la Cerda, the Portuguese Minister at the French Court, and which he was desired to forward to their High Mightinesses.
