Hallifax in Nova Scotia, August 19.

HE Transports, with Colonel Lascelles's Regiment from Ireland; the two Companies from St. John's, and the Recruits for Governor Cornwallis's Regiment from England, arrived the End of last Month and the Beginning of this.

* Lisbon, Sept. 6. The King has appointed M. Gaspar Penheiro da Camara Manoel to be Commodore of a Squadron of Shebecks, and other armed Vessels, which his Majesty has ordered to be fitted out to cruize against the Corfairs of Barbary, who are almost continually disturbing the Commerce on the Coasts of the Kingdom of Algarve.

Leghorn, Sept. 18. The King of Prussia ha-Ving determined to have Confuls at all the principal Ports in Italy, for the Advantage of the Commerce of his Subjects, a Person from Berlin is already arrived at Naples with that Character,

as is likewise another in this City.

• Petersbourg, Sept 18. On the 16th Instant, being her Imperial Majesty's Birth-Day, the same was celebrated at Court with great Magnificence.

Stockholm, Sept. 18. The King continues to enjoy a good State of Health, and walks out daily. Yesterday the Prince Successor, and the Princes his Spouse, accompanied by Count Tellin, set out with a numerous Retinue from Drottningholm for Gripsholme, a Royal Palace in Sudermania.

Prague, Sept. 26. The States of this Kingdom are to assemble on the 30th Instant. On Wednesday last the Regiment of Dragoons of Philibert arrived here, and set out the next Day for their former Quarters; and on Friday the Regiment of Gaisrugg marched through this City, and was followed by a Train of Artillery, taking the Road for Pilsen. The Regiments of Harsch and Archduke Charles are returned into Garrison here; and the other Regiments, which formed the Camp of Colin, are also on their March for their respective Quarters,

Warfaw, Sept. 26. The King has disposed of the Castellany of Wielau, in Favour of M. Galewski, Starosty of Bromberg. On the 21st Instant the Countess de Moszynska, Dowager of

the late Great Treasurer of the Crown, took her Leave of their Majesties, and set out for Dresden. The Advices we receive of the happy Issue of several of the Dietines, and of the Election of a Number of Deputies sufficient to the holding of the next Tribunal of the Crown, give Hopes that Unanimity will take Place as usual, and that the Administration of Justice will again take its ordinary Course. 'Tis said his Majesty proposes to set out from hence for Dresden about the 20th of next Month.

Vienna, Sept. 27. The States of Lower Austria, who have now opened their Assembly in this City, and appointed Count Koniglegg Erbs to be their Marshal, have under Consideration the Propositions made by the Empress Queen for raising the necessary Supplies to be granted to her Imperial Majesty for the ensuing Year. The Princes of Cordona, who married the Prince of Hohenzollern about two Months ago, died Yesterday in this City. The Baron de Burmania, Envoy Extraordinary and Minister Plenipotentiary from this Court to that of the States General, proposes to set out on Monday next for the Hague. Count Harrach, late Governor-General of the Milanese, is arrived he e from Italy. Yesterday their Imperial Majosties returned from Mannerstorff to Schonbrun.

Copenhagen, Sept. 29. The Kirg has ordered a confiderable Sum of Money to be issued from his Treasury, for the Relief of the poor Inhabitants of the little Town of Prestoe, who a few Months ago were almost ruined by Fire.

Berlin, Oct. 2. The Queen Mother, who has been very much indisposed, is now perfectly recovered, and the King has been to compliment her thereupon. On Saturday last his Majesty returned to Potzdam, after he had disposed, of several Military Employments; and Yesterday the Regiment of Gendarms, the five Squadrons of Hussars, and some other Troops in Garrison in this City and its Neighbourhood, were drawn up and performed several new Exercises in his Majesty's Presence at Potzdam.

Hague, Oct. 8. The States of Holland and Westfrizeland continue their Assembly; as do also the Deputies from the several Colleges of the Admiralty of this Country. On the 6th

Instant the Marques de St. Contest, Ambassader from Ftance, had an Audience of the Prefident of the Assembly of the States General, and delivered his Credential Letters. By Advices from Loo, his Serene Highness the Prince of Orange set out from thence on Saturday last for Zutphen, in order to assist at the Assembly of the States of Guelderland. The same Advices say, that his Serene Highness had raised Lieutenant Colonel d'Arkel, one of his Aids de Camp, to the Rank of Colonel.
