Naples, November 3.

N the 28th past the King's two Galliots, which went lately on a Cruize against the Corsairs of Barbary, returned into Port, and brought with them a Tripolitan Ship, which they took during their Cruize in the Sicilian Sea. The Count de Monasterol, his Sardinian Majesty's Ambassador to this Court, having received his Letters of Revocation, and taken his Audience of Leave of their Majesties, set out last Week from hence for Rome, on his Way to Turin; before his Departure, the King presented him with a Diamond Ring of great Value. The Court is expected here to Day from Portici, in order to celebrate To morrow the Feast of St. Charles, his Majesty's Name Day, for which great Prepafations are making.

Petersbourg, Nov. 6. Several Councils have been lately held at Court, in one of which it was refolved, that a confiderable Body of her Imperial Majesty's Forces, which are now quartered in the Ukraine, shall immediately join those of the King and Republick of Poland, and act in Concert with them, in order to put a Stop to the many Outrages and Cruelties that have for some Time past been committed by several

large Bodies of Heyducks.

Venice, Nov. 13. M. Chavigny, the French Amballador, arrived here on Monday last; but being ill of a Fever, he has not as yet notified his Arrival to the College and Foreign Ministers...

Vienna, Nov. 14. The Empress Queen of Hungary has lately ordered the Regiment of the Dragoons of Preysing to be disbanded. Engineer-General de Bohn, who has been to visit the Fortifications of Hungary and Esclavonia, is arrived here from Peter-Waradin, where he has given Orders for the carrying on of the new Fortifications of that Place. Their Imperial Majesties propose setting out To-morrow for Closter Neubourg, in order to celebrate the Feast of St. Leopold; and the Archduke Joseph, and most of the Foreign Ministers are to of accompany their Majesties on this Occasion.

Turin, Nov. 14. On Tuesday last being the Anniversary of the King of Great Britain's Birth, the same was celebrated here by the Right Hon. the Earl of Rochford, his Britannick Majesty's Envoy Extraordinary and Minister Plenipotentiaty to this Court; on which Occasion his Lordship gave a sumptuous Entertainment to the Foreign Ministers; at which were present all the English now residing at Turin.

Warfaw, Nov. 14. By some Dispatches received from the Castellan of Wastiz, dated from Wisniowicz the first of this Month, we have an Account, that the Plague has broke out again in Moldavia, and that several Villages in the Neighbourhood of Kaminieck are actually insected with it.

Copenhagen, Nov. 16. The King has declared his Intention of hunting no more this Season in the Forest of Jagersbourg. On Tuesday last the Queen had a Drawing-Room for the first Time since her coming to the Winter-Palace, and has ordered the same to be continued as usual at this Time of the Year. On Friday Morning last his Majesty went to the Dockyard of the West-India Company, and saw two new Ships, named the Caroline and the William, launched from off the Stocks; with which his Majesty was greatly pleased; and the tather, as no Accident of any Kind happened. The Queen Dowager intends to set out next Week for Hirscholm, where she proposes to stay the greatest Part of the Winter. Yesterday Morning Count Schulembourg arrived here from the Tour he has taken through Germany, and hast Night he had the Honour to be presented to the King, and met with a most gracious Reception.

Dresden, Nov. 17. The Weather is set in very severe in this Country; and as the Ground is now too hard for Hunting, their Majesties propose leaving St. Hubertsbourg on Tuesday next with the whole Court, in order to return to this City for the Winter.

Berlin, Nov. 21. The King came hither a few Days ago from Potzdam, and gave Audience to some Foreign Ministers; after which his Majesty paid a Visit to the Margravine of Bareith his Sister, who is perfectly recovered from her late Indisposition, and proposes, as 'tis now faid, to set out shortly on her Return to the Court of Bareith. The Day after his Majesty dined with the Queen-Mother, and set out the same Evening for Potzdam. Prince Maurice of Anhalt-Dessau is arrived at Potzdam from Brandenbourg; as is also Prince Frederick Eugene of Wirtemberg from Stolpe; Major General de Hautcharmoy, Governor of Brieg, from Silesia; and M. Klingraff from Hanover. On the 16th Instant died here the Baron de Borstel, in the 58th Year of his Age; he was one of the King's Chamberlains, Privy Councillor of War, and of the Finances and Domaines, Knight of the Order of St. John, and Hereditary Lord of Wester Egeln, Dobritz and Ferwitz.

Brussek, Nov. 23. On Thursday last the Empreis's Name-day was celebrated here with great Solemnity. Prince Charles of Lorrain, Governor General of the Low Countries, is returned hither from the Tour he lately made to Ter Vuren. Tis assured, that the Project for rebuilding the ancient Palace, which was burnt down, will shortly be put in Execu-

tion.

Hambourg, Nov. 24. The young Count Schonburn, Nephew to the Elector of Triers, and Heir to the late Bishop of Wurtzbourg his Uncle, who-travels with a very numerous Attendance, is

at present in this City.

Hague, Nov. 26. On Friday last his Serene Highness the Prince of Orange assisted for four Hours at the Assembly of the States of Holland and Westfrizeland; and on Saturday the said States separated for some Time. The new Company of Grenadiers, which has been lately raised, in order to be placed at the Head of the Dutch Guards, arrived here a sew Days ago from Loo; and having passed in Review before the Prince of Orange, who was greatly pleased with its Appearance, has since taken the Station for which it was raised.

Hague, Nov. 27. The States General received, on Monday last, a Letter from the French King, by which they were informed, that his Most Christian Majesty had thought proper to recall the Abbe de la Ville, his late Ambassador to the Republick; which Letter was delivered to the President of the Week by M. Chiquet, who at the same Time presented a for three Years to come.

Memorial from the Abbe de la Ville, by which that Minister' took Leave of their High Mighstinesses, who came to a Resolution to grant him the usual Present of a Golden Chain and Medal, of the Value of 1300 Florins, with one of 300 for M. Chiquet his Secretary. Yesterday in the Asternoon the Marquis de St. Contest, the new French Ambassador, waited in Ceremony on the Prince Stadtholder, who received him at the Foot of the great Stair Case, and reconducted him to the same Place. And this Day his Serene Highness returned the Ambassador his Visit, in great Pomp: His Excellency received his Serene Highness at the Coach Door, to which he likewise reconducted him at his Departure,
