GOD Save the KING.

Petershourg, February 16. The Preparations which were making for her Imperial Majesty's Journey to Moscow, are all countermanded. The Court has received Advice from Cronstadt and Revel, that the Men of War and Gallies in those Ports are ready to put to Sea upon the first Notice. By Letters from Finland we learn, that all Things remained there in perfect Tranquillity; and that the Troops of her Imperial . Majesty, and those of the Sweeds, continued very quiet in their respective Quarters.

Leghorn, Feb. 21. We have received Advice that the Corsairs of Tunis have lately taken a rich Venetian Merchant Ship, the Cargo of which confisted of 125 Bales of Cotton, 150 Barrels of Cyprus Wine, 6 Bales of Raw Silk, and about 70,000 Crowns in Specie. There was on Board 24 Persons, who were all carried into Slavery, amongst whom was a Venetian Lady of the Family of Benzoni, and two of

her Children.

. Turin, Feb. 24. The Dutchess of Savoy advances happily in her Pregnancy. The Military Conferences are continued, at which the Duke of Savoy almost constantly assists. They have already regulated some Points in regard to the Alterations the King proposed making in the Habits and Exercise of his Troops. His Majesty finding it necessary to continue the extraordinary Taxes upon the same Footing they were during the War, has caused an Edict to be published, by which he makes known his Intentions on that Subject.

Ersurt, Feb. 26. Yesterday a Fire broke out at Alpersted, a Village situate about two Violence, that twenty Houses were reduced to Ashes in about three Hours Time, notwithstanding the Inhabitants of this Town and those of all the neighbouring Towns and Villages. gave them all the Assistance in their Power.

Copenhagen, Feb. 27. The Diversions of the Carnival have been extremely brilliant, and ended on Monday last with a grand Ball at Court. Within these sew Days past several Swedish Deserters have found Means to cross the Sound upon the Ice, and have inlifted them-

selves in the Troops of this Kingdom.

Stockholm, Feb. 27. The King continues to enjoy his Health to Admiration, and affifts regularly at the Diversions of the Court. His Majesty has appointed M. Schulberg to be Keeper of the Records of this Kingdom. The Russian and Prussian Ministers have frequent Conferences with Count Tessin, and on Friday last each dispatched a Courier for his Court.

Vienna, Feb. 27. Yesterday an extraordnary Council was held at the Palace, at which her Imperial Majesty assisted; after which she delivered to his imperial Majesty the necessary Full Powers for managing all publick and private Affairs during her Lying-in, which is now almost daily expected. 'Tis still said that Prince Charles of Lorrain will come hither from Brussels towards the Beginning of May, in order to accompany their Imperial Majesties to Presburg.

Dusseldorp, March 5. The Rhine, which has lately done great Damage in the neighbourhood of this City by its Overflowings, is now confined again within its Banks. Yesterday a considerable Number of Recruits for the Imperial Troops quartered in the Low Countries, passed through this City on their Way to their respective Regiments.

Franckfort, March 5. The Cardinal Prince and Bishop of Liege set out from Munich the 25th past for Manheim, where he proposed staying for ten Days, and then return to his

Principality.

Amsterdam, March 6. We have received Advices by a Ship which is arrived at Zealand from Surinam, that the Troops which sailed from hence some Time ago for that Colony under the Command of General Sporcketi, landed there the Beginning of December last, having weathered a violent Tempest some Days before; that the General had been pretty much out of Order during Part of the Voyage, but was perfectly recovered when he arrived at Surinam; that the Troops were in good Health, having lost but very few during the Voyage; that they were received in a very obliging Manner by M. Mauritius the Governor; and that they found every Thing there in perfect Tranquillity, there not being the least Appearance

of the late Conspiracy of the Blacks, who were all quietly at Work in the Plantations as before.

Hague, March 12. The States of Holland opened their Ordinary Assembly on Wednesday last, and the Prince Stadtholder assisted at it for some Time. Two Placarts have been published in their Names, which were resolved on during their Extraordinary Assembly. The First is dated the 20th of February, and is intended to explain the 6th and 8th Articles of their Ordonnance relating to the Tax upon Coaches, Horses, &c. In relation to the said 6th Article, the States declare, That their Intention is, that whoever sets up a Vehicle of a superior Degreé to that he kept before, or puts a greater Number of Horses to his Vehicle than what he used to do, must give the Collector Notice of it, within eight Days after such Alteration, and be taxed accordingly; and whoever fets up an Equipage, not having kept one before, must give the like Notice. By the 8th Article it is ordered, That whosoever keeps Carriages of any Sort, without Horses, either to lend or let them out, or to use them themselves with borrowed or hired Horses, shall pay the same Tax as if they kept Horses also; and those who keep Horses only, upon the same Footing, are to be taxed in like Manner. Those however, who will swear, that their Carriages have not been used at all during the whole Year, are exempted from the Tax. By the other Placart, which bears Date the 27th of February, the States explain the 10th Article of their last General Placart, by which, in order to prevent Smugling, they had enacted, That no Commodities liable to the Provincial Taxes or Duties, should be transported otherwise than in the publick and regular Market Boats, Waggons or other Carriages: As this was attended with some ill Effects, the States have added a Clause to that Regulation, according to which it will be lawful to hire a Boat or Vessel for the Transportation of any Quantity of fuch Goods directed to any one Person, provided the said Boat belongs to any Boat-man, who shall be a Member of the Gilde in that Place from whence the Goods are sent; and that the Vessel be at least of the Burthen of 12 Lasts, or that the Freight amount to eight Florins. The Owner of the Vessel is also obliged to go in Person along with it: And it is further enacted, That Goods sent to Market are not to be comprehended in this Clause.
