Lisbon, March 12.

HE Court is still at Salvaterra, and it is generally believed will not return to this City till towards the End of this Month. 'Tis said that a numerous Promotion of Land and Sea Officers will soon be made; and 'tis likewise said, that some new Ordonnances, greatly in Favour of the Commerce of this Kingdom, will be published soon after the Return of the Court. Count Stahrenberg, having finished the Commission he came hither to execute on the Part of their Imperial Majesties, is preparing to set out on like Return to Vienna. A general Review of the Troops of this Kingdom being to be made the latter End of next Month, or the Beginning of May, all the Officers are fuccessively setting out from hence for their respective Regiments. We are in daily Expectation of the Arrival in this Port of several Ships richly laden from the Indies.

Lucca, March 23. The Accommodation of the Differences which have subsisted for some Time between this Republick and the Regency of the Grand Dutchy of Tuscany, in relation to the new Roads we had begun to make in the Mountains of Grasignana, having been left to the Arbitration of the Court of Vienna, we are in daily Expectation of hearing the News of the Decision of that Affair, which we have great Reason to believe will be in our Favour.

Turin, March 24. The King and all the Royal Family continue to enjoy perfect Health, and the Dutchess of Savoy advances happily in her Pregnancy. Count Colloredo, Envoy Extraordinary from their Imperial Majesties to this Court, having had his Audiences of Leave last Week, set out Post Yesterday for Vienna.

Petersbourg, March 26. General Lieven is for the present appointed Commander of the Troops assembled in the conquered Provinces. An Officer is arrived here from Cronstadt with Advice, that the Fleet of this Empire is ready to put to Sea upon the first Notice.

Venice, March 26. The Court of Vienna having entirely agreed to the Alterations made here in some of the Articles for settling the Affair of Aquileja, the Senate has sent Orders to M. Tron, the Republick's Ambassador at Vienna, to conclude the Treaty.

Milan, March 30. Count Colloredo, whom their Imperial Majesties have recalled from his Embassy at the Court of Turin, and appointed Commander of the Imperial Troops in Lombardy, is arrived here on his Way to Vienna, from whence 'tis expected he will soon return hither, in order to take upon him that Employment; and the Great Chancellor Count Christiani is ordered to repair to the Court of the King of Sardinia, to take Care of the Affairs of their Imperial Majesties at that Court in his Room. The Report lately spread, that the Troops in this Dutchy were to form a Camp this Summer, appears to have no Foundation, at least no Preparations of any Kind are as yet making for it. We learn by Letters from Venice, that as the Corsairs of Barbary continue very much to infest their Coast, and greatly interrupt their Commerce, it had been resolved to augment considerably the Maritime Forces of that Republick, to the End that they may foon be in a Condition of forming a fufficient Squadron of Ships and Vessels to protect their Trade, and give Chace to those Corsairs.

Warsaw. April 3. The Waters of the Vistula, which had overflowed a great Part of the
Country in the Neighbourhood of this City,
and thereby done great Damage, are at length
greatly abated, and we hope will now soon be
all gone off again. We have received Advice,
that Prince Leon of Radzivil, Great CupBearer of the Dutchy of Lithuania, died a sew
Days ago at his Country Seat of an Apoplectick
Fit. The Tribunal of Petrikau continues its
Sessions with great Success under the Direction
of M. de Czarnolowsky, who presides there in
the Absence of the Marshal of the Crown

Vienna, April 3. The Emprels Queen is so far recovered from her late Lying-in, that several Ladies were last Sunday admitted to visit her in her Apartment for the first Time. And her Imperial Majesty has given Orders, on the Occasion of her happy Delivery and Recovery, that all the Deserters from her Troops, who were condemned to work at the Fortifications, should be immediately set at Liberty on Condition of their joining their respective Regiments.

Copenhagen, April 3. The Anniversary of the King of Denmark's Birth-day having been celebrated here on the 31st past, in the usual Manner, several Promotions were made on that Occasion; the Chief of which are these, General Lerche is made a Count; General Levetrau and the Privy Counsellor M. Brockorst have received the Order of the Elephant; and the Colonels Baurenseind, Castagna and Caltenborn are advanced to the Rank of Major Generals of Infantry.

Dresden, April 3. The Queen has been a little indisposed for some Days past, but we hope her Illness will be attended with no very

bad Consequences.

Brussels, April 12. Count Stampa, one of Prince Charles of Lorrain's Adjutant Generals, having had a Regiment given him by the Queen of Hungary, set out from hence on Friday Morning last for Vienna, in order to take Possession of the same; and to compliment their Imperial Majesties, in the Name of Prince Charles of Lorrain, upon the Birth of the young Archdutchess. We are assured that the Government have at Length granted a Permission to the Magistrates of the City of Mons, to make a new Canal from that City to Ath; and that in Consequence thereof, they are making Preparations in order to begin that Work.

Hambourg, April 13. This Morning the Swedish Resident received, by an Express from Stockholm, the melancholy News of the Death of the King of Sweden, who died the 6th Instant; and the Day following the Prince Successor was proclaimed King, and received the Compliments of the Senators of Sweden upon the Occasion. The Magistrates of this City have already given Notice, that a Vessel is ready to sail for Algiers with a new Pass, agreeable to the Treaty lately concluded between this City

and that Republick.

Hague, April 15. The States of Holland and Westfrizeland, who were assembled Yesterday, have to Day continued their Deliberations. The Deputies of the several Colleges of the Admiralty of this Kingdom, who arrived here a few Days ago, have already entred upon Business.
