The Procession to be from the Prince's Chamber, through the Old-Palace-Yard to the South East Door of Westminster Abbey, and being entered the Church, to pass up directly to the Steps leading to Henry the Seventh's Chapel.

At the Entrance within the Church, the Dean and Prebendaries, attended by the Choir, are to receive the Body, and are to fall into the Procession just before the Officer of Arms, who precedes the Master of the Horse, and so are to proceed into King Henry the Seventh's Chapel, where the Body is to be deposited on Tressels, the Coronet and Cushion being faid at the Head, and the Canopy held over it; the Supporters of the Pall standing by it, the chief Mourner and his Two Supporters seated in Chairs placed for them at the Head of the Corps, the Lords Assistants, Master of the Horse, Groom of the Stole, and Lords of the Bed-Chamber on both Sides, the Four White Staff Officers standing at the Feet, the others feating themselves in the Stalls on each Side of the Choir.

That Part of the Service before the Interment being read by the Bishop of Rochester Dean of Westminster, the Corps is to be carried to the Vault preceded by the White Staff Officers, the Master of the Horse, Chief Mourner, his Supporters, and the Assistants following, Garter going before them, and are to place themselves near the Vault.

The Corps being interred, the Dean of Westminster is to go on with the Ossice of Burial, which ended, Garter King of Arms is to proclaim the Stile of His Royal Highness, and the White Staff Ossicers are to break their Staves, and to throw them into the Vault.

Naples, March 23. On the 15th Instant failed from this Port the King's Xebecks to cruize in the Adriatick against the Barbary Pirates. On the 16th a large House fell down in the Street of the Silversmiths, by which Accident eight Persons were buried under the Ruins, and many others were greatly bruised and disabled. The same Day Count Policastro was, by the King's Orders, sent Prisoner to the Castle of Gaeta, for having abused a Judge of the Criminal Court, at the Time that he had confined him to his House for having challenged and fought M. Sepino. On the 18th some Soldiers of the Foot Regiment of Calabria pursuing, in a Quarrel, some Sea-faring People of Chiaja, who took Shelter in the Palace of the Prince of Strongoli, the young Prince and his Uncle came down Stairs to prevent Mischief; but the Soldiers, without any Regard, fired their Guns, killed a Man upon the Spot at the Elbow of the young Prince, and wounded him dangerously in the Face with a Cutlash. The Soldiers were arrested,

and the Nobility are very impatient to see what Punishment will be inflicted upon them.

Rome, March 27. On the 19th Instant Cardinal Rezzonico had a long Audience of the Pope, in Consequence of a Commission had received from the Senate of Venice; he being charged with their Assairs till the Arrival of the new Ambassador. On the 22d the Portuguese and Sardinian Ministers had each an Audience of the Pope, to communicate to him the Commissions from their respective Courts. Besides the Body of Sta. Crestina, and a Bason of Agnus Dei, the Pope presented to the Duke of Deux Ponts a fine Picture of Mosaick, and two others in Tapistry of the Fabrick of St. Michael.

Florence, April 2. On the 28th past Count Richecourt returned from Leghorn, where he had been to see his Son, who was performing Quarantain after the Voyage he had made to the Levant, &c. with the Emperor's three Ships of War commanded by Commodore Acton; and, agreeable to the Emperor's Commands, to give the necessary Orders for disarming those Ships, and laying them up at Porto Ferraio, where Preparations are making accordingly for that Purpose. These Ships were to be admitted at Pratick this Day the 2d Instant. On the 29th Colonel Mill set out from hence on his Journey to England. By the last Letters from Vienna, the Regency received Notice of the happy Delivery of the Empress of a Princess.

Barcelona, April 4. His Danish Majesty's Envoy to the Court of Spain passed through this City this Week in his Way to Madrid.

The King has been pleased to constitute and appoint his Grace the Duke of Bedford, one of his Majesty's Principal Secretaries of State, to be Lord Lieutenant and Custos Rotulorum of the County of Devon, and of the City of Exeter and County of the same, in the room of the Earl of Orford, deceased.
