Lisbon, May 10.

HEIR Majesties continue their Refidence at Villa Viciosa, where they divert themselves almost daily with Hunting. The Queen Mother has been slightly indisposed, but is now perfectly recovered. A few Days ago the youngest Infante was seized with the Small Pox. On Saturday last a Proclamation was published here, for preventing of Luxury, in which however the Use of gilt Coaches and Chariots is allowed, provided they are made in this Kingdom.

Petersbourg, May 24. In Consequence of the Notification which Count Posse made a few Days ago to her Imperial Majesty of the Death of the late King of Sweden, this Court went into Mourning on Monday last, which is to continue for Six Weeks. The Empress intending to pass some Time at Petershoff, the necessary Preparations are making there for her Reception. We have received Advice from the Ukraine, that the Generals who command the Russian Troops in that Country, having been informed that a contagious Distemper has lately broke out in several Places on the Frontlets, which rages with great Violence, and daily carries off Numbers of People, have ordered several strong Detachments of Troops to march thither, in order to prevent the Spreading of the said Distemper, by cutting off all Communication between them and the interior Parts of that Country. On the 17th Instant a Courier arrived here from Persia, by whom we learn, that the new Schach appeared greatly difposed to do all in his Power for promoting the Commerce of his Subjects with those of the European Powers.

Warfaw, May 29. The Command of the Crown Army, vacant by the Decease of the late Count Potocky, devolves on Count Branicky, who will take Possession of it accordingly on the Return of the Courier who is gone to Drefden with the News of Count Potocky's Death; and 'tis said he will be succeeded in his Post of Lieutenant General by M. Rzewusky, Palatin of Podolia. Marshal Count Lowendahl is still in this Kingdom, and to all Appearance his Family Affairs will keep him here till towards the End of the Year. We have received Advice, that the Heyducks have again invaded the Territories of Poland on the Side of the Ukraine, where they have burnt feveral Towns and Villages and put the Inhabitants to the Sword; but upon those Heyducks being informed that the Regiment of Podolia and a considerable Detachment of Russian Troops were marching against them, they had thought proper to retire to the Mountains, from whence tis impossible to force them.

Rome, May 29. We are informed by Letters from Civita Vecchia, that the Maltese Gallies were arrived there the 21st of this Month, and were immediately joined by those of the Pope, in order to go on a joint Cruize against the Corsairs of Barbary. This News gives us great Satisfaction, as the Number of those Corfairs have greatly encreased for these two Months past upon our Coasts, where they have lately taken several Vessels loaden with Corn.

Modena, June 2. The Duke our Sovereign, and all the Court, will leave Reggio Tomorrow, and repair to the Castle of Rivalta, where 'tis thought they will spend great Part of the Summer. A Courier is arrived here from Turin with Advice of the Dutchess of Savoy's happy Delivery of a Prince on the 24th past. We learn also by several private Letters from . Turin, that, in Conformity to the Orders of his Sardinian Majesty, they were proceeding to make a considerable Reduction in the Troops of that Prince, every Battalion in the National Regiments being to be reduced to 550 Men, and the Foreign Regiments in Proportion. They write from Genoa, that the Master of a French Ship arrived there from Malta reports, that the Corsairs of Barbary had landed some Troops in the Island of Pantarale, belonging to Sicily, but that those Troops had met with so warm a Reception from the Inhabitants, that they had been obliged to quit the Island with great Precipitation, 40 of them having been killed or wounded.

Dresden, June 5. The Count de Mnizeck, Son-in-Law to our Prime Minister Count Bruhl, set out on Saturday last for Poland, in order to regulate some Affairs relating to the Death of Count Potocky, Great General of the Crown Army, by whose Death nine or ten Starosties become vacant in his Majesty's Disposal.

Berlin, June 8. We have received Advice that the King having finished the reviewing of his Troops in Magdebourg, arrived on Thursday last at the Duke of Brunswick Wolfenbuttle's at Salzthal, where he proposed staying two Days, and then to continue his Journey towards Cleves. The Queen set out Yesterday with the whole Court for Schonhausen for the Summer; and the Queen Mother purposes shortly to take up her Residence at the Castle of Monbijou.

Middlebourg, June 13. His Serene Highness the Prince of Orange continues to enjoy a perfect State of Health, and assists almost daily at the Assembly of the States of this Province. Yesterday his Serene Highness made a Tour to Ter Veere, and having dined with the Burgomaster Verelst, returned hither in the Evening. The Day of his Departure for the Hague is not yet fixed. On Tuelday Evening last arrived in our Road the Huystendonck from Ceylon,

Amsterdam, June 14. We learn from the Texel, that the Liefde, the Herstelder, and the Craffbendyk, three Ships belonging to the India Company, arrived there the 10th of this Month; the two first from Batavia, on board of one of which was M. Swellingrebel, Governor of the Cape of Good Hope, and the third from Ceylon. These three Ships left the Cape on the 5th of March, in Company with three others, two of which are already arrived in other Ports of these Provinces, and the other is daily expected.

Hague, June 15. The States of Holland and Westfrizeland are to re-assemble To-morrow. We learn by the last Post from Germany, that Prince Frederick of Hesse Philipsthall, younger Brother to the Landgrave of that Name, died at Philipsthall on the 30th of last Month,

in the 22d Year of his Age.
