Turin, June 26.

ER Royal Highness the Dutchess of Savoy has begun to receive Compliments on her Recovery from her late Illness. This being the Anniversary of his Royal Highness the Duke of Savoy's Birth-Day, there was a grand Appearance at Court, and the Foreign Ministers had Jeparate Audiences of his Royal Highness to congratulate him upon that Occasion.

Turin, June 29. All the Royal Family continue to enjoy perfect Health; and the King is very affiduous in his Endeavours to put his Finances upon a good Footing. Count Moris, who lately failed for a considerable Sum, and found Means to retire to Lugano, returned hither on the 22d Instant, in order to affist in settling his Affairs. Private Letters from Italy inform us of several considerable Bankruptcies that have lately happened at Bergame, Novi, Modena, Genoa, Naples, and even at Leghorn and Florence, which are principally attributed to the Diminution of the Price of Silk.

Genoa, June 28. Letters from Calvi, dated the 20th Instant advise, that the French Troops in Corsica were to be at St. Fiorenzo by the 25th, from whence they were to embark for France; but the Transports were not arrived

when those Letters came away.

Vienna, July r. Count Colloredo, Vice-Chancellor of the Empire, who arrived here on Sunday Morning last from Hungary, was next Day in Conference with several of the Foreign Ministers, and set out immediately after to join the Court at Presbourg. Yesterday the Pope's Nuncio performed the Ceremony of Installing our new Archbishop in the Metropolitan Church of this City. The Departure of their Imperial Majesties for the Camp at Pest, is deferred to the 20th of next Month.

opening of the Diet of the States of this Kingdom begins now to draw near, and 'tis expected the necessary Summonses for that Purpose will soon be dispatched. The Number of Houses burnt down by the late Fires are more than were at first imagined, it appearing that there are upwards of 950 consumed. Several scandalous Resections having been thrown out on this melancholly Occasion against some of the Foreign Ministers and their Servants, the King has caused a Placard to be published, for-

bidding the same for the suture on Pain of Death.

Hambourg, July 9. The Queen Dowager of Denmark, accompanied by the Margrave of Culmbach, arrived here on Friday last from Altena. And Yesterday the Dutchess Dowager of Holstein Sleswick, Mother to the present King of Sweden, set out from hence for Eutin, in Company with the Duke and Dutchess of Saxe Gotha, who have been here some Days paying her a Visit. We have received Advice from Gothenbourg, that the Frederick Adolphus was arrived there from China on the 29th past, richly laden.

Hague, July 15. The Baron de Nieuwker-ken, and M. Harzolte, have taken the usual Oaths before the Council of State, the first in Quality of Colonel of the Regiment of Orange Groninguen, and the latter in Quality of Lieutenant Colonel in the Regiment of the Prince of Baden Dourlach, to which they were lately preferred by his Serene Highness the

Prince of Orange.

Kensington, July 7.

This Day Signior Vignola, lately arrived here Resident from the most Serene Republick of Venice, had his first private Audience of his Royal Highness the Duke; to which he was introduced by Sir Clement Cottrell Dormer, Knt. Master of the Ceremonies.

Whitehall, July 9.

The King has been pleased to constitute, and appoint, the most Honourable, Charles, Marquess of Rockingham, to be his Majesty's Lieutenant of the West Riding in the County of York, and of the City of York, and County of the same City; and, also, to be Custos Rotulorum of the North, and West, Riding in the said County of York, and of the City of York and County of the same City, and Ansty, otherwise Aynstre of York.

The King has been pleased to appoint the Right Honourable William Lord Cavendish, of Hardwyck, to be his Majesty's Master of the
