Turin, July 12.

CCORDING to the Advices we receive here daily from Vaudier, the King continues to drink the Waters at that Place with great Success; and tis said his Majesty proposes taking a Tour from thence to Fenestrelles, to examine the Condition of the Fortifications of that Place, so that he is not expected here till the 5th or 6th of next Month. A Courier is arrived here from the Count de Sartirane, Envoy Extraordinary from this Court to that of Genoa, with Dispatches relating to the Affairs of Corsica.

Naples, July 13. Their Majesties came here last Friday from Portici; and the next Day there was a grand Appearance at Court on Occasion of its being the Feast of St. Amelia, whose Name the Queen bears. We have received Advice, that three of our Gallies, being on a Cruize, came up with a Tunesian Corsair on the 28th past off Lapari, and soon made themselves Masters of her: She had 18 Guns on board; and her Crew, consisting of about 30 Men, were all sent to work at the Gallies.

Petersbourg, July 13. Within these few Days past, a great Number of Workmen have been sent, by the Empress's Order, to Petershoff, in order to repair and beautify the Royal Palace and Garden's of that Place. Last Week her Imperial Majesty made a numerous Promotion of Subaltern Officers, not only in the three Regiments of her Foot Guards, but likewise in those of her Horse Guards. Count Verthern, Plate a Major General in the Service of the Elector of Bavaria, is soon expected here, in proder to enter into the Service of this Court in the same Quality. Count Posse, the Swedish Minister, is taking his Leave of the other Foreign Ministers, being to set out To-morrow or next Day for Stockholm. Yesterday a Man of War of 86 Guns was launched at the Dock belonging to the Admiralty, and appeared to be an exceeding fine Ship. By an Express arrived here

a few Days ago from Russian Finland, we received Advice of the Death of Lieutenant General Grouschoff, Commander of her Imperial Majesty's Forces quartered in that Country, but as yet no one is appointed to succeed him. The Departure of Count Lynar from Copenhagen is again deferred; and 'tis now said it will not take Place till after that Minister has finished a Negociation he began some Time ago with the Ministers of the Great Duke of Russia, concerning the Dutchy of Holstein.

Breslau, July 20. On Tuesday last there fell, in the Principality of Munsterberg, a prodigious Quantity of Hail, and so very large, that it has done an infinite deal of Damage to all the Fruits of the Earth. We learn from Faustadt and Lissa, that the Locusts begin to appear in such Numbers, that they have great Reason to be apprehensive of their doing as much Mischief this Year as they did the last.

Vienna, July 21. On Monday last the Emperor, accompanied by Prince Charles of Lorrain, and attended by feveral of the principal Lords of the Court, arrived in this City; and. Yesterday his Imperial Majesty signed several Dispatches; after which he went to Schonbrun, to see the young Archdutchesses; and this Morning he set out, with the Prince his Brother, on his Return to Presbourg. In Consequence of the Scheme which is on Foot for the better Regulation of the Commerce of Hungary, Magazines are going to be erected there in divers Places, in which are to be deposited all the Surplus Grain, and other unperishable Productions of that Kingdom; and the Duties that used to be paid upon all Corn, Wine and Cattle, are going to be considerably lessened, in order to facilitate, by that Means, the Sale of such Part of those Commodities as shall be transported from Hungary into the Hereditary Countries. The Departure of the Court for the Camp at Pest is again deferred for some Days, and tis now believed will not take Place till the 4th of next Month. Count Colloredo, Vice Chancellor of the

the Empire, came here on Sunday last from Presbourg; from whence the Secretary of State, Baron Bartenstein, will likewise arrive To-day or To-morrow. A few Days ago a Courier was dispatched to Count Cajetan Kollowrath, with an Account of the Death of his Brother; and of his being appointed, by his Will, universal Legatee. We are informed by Numbers of Persons who have been from hence to view the Camp at Pest, that the Troops go daily thro' their Exercise, and make a yery fine Appearance; and that they are to continue so doing till they have been reviewed by their Imperial Majesties. We have received Advice from Manheim of the Death of General Count Berlichingen, but it is not as yet known to whom her Imperial Majesty will give the Command of his Regiment of Cuirassiers. The Aulick Counsellor, M. Gartner, arrived here last Week from Dresden, to which Court he went some Time ago to execute a private Commission from

their Imperial Majesties.

Stockholm, July 23. The Court is still at Drottingholm, and will not come hither, as 'tis believed, till towards the Time fixed for the Coronation; in the mean while all necessary Preparations are making for that great Ceremony. The rebuilding of the Houses consumed by the late Fires, goes on with great Expedition; and there arrive daily, from divers Provinces of this Kingdom, Numbers of Workmen who are all immediately employed. Count Panin, Envoy Extraordinary from the Empress of Ruslia, continues to have Conferences with Count Tessin, and the other Ministers of this Court, in Relation to the Means that are to be employed for establishing the Peace of the North. 'The Directors of our East-India Company have given Notice, that they will begin to put up to Sale, on the 9th of next Month, at Gothenbourg, the Effects lately arrived in that Port no board the Frederick Adolphus. Claude de Ralamb, Governor of Sudermania, is appointed a Member of the Council of the Finances.

Warsaw, July 24. We have received Advice by an Express, that Count Sapieha, Great Chancellor of Lithuania, died on the 6th Instant at his Seat at Lisowody in Podolia, in the 71st Year of his Age; by whose Decease Prince Czartoryski, Vice Chancellor of Lithuania, succeeds to that

important Post.

Copenhagen, July 24. The King is expected here on Tuesday next from Friedensbourg; and tis said, that soon after his Return, a Minister will be appointed to go to the Court of Sweden, in order to reside there on the Part of his Majesty. Several Ships belonging to the Merchants of this City, bound for the West-Indies, are now ready to put to Sea, and will sail with the first sair Wind.
