AT the Court at Kensington, the 9th Day of August 1751,

PRESENT,

The King's most Excellent Majesty in Council.

Where's his Majesty hath received Information, That from the roth Day of June to the 1st Day of September in the last Year #750, a very small Number of the Horned Catthe had died of the Distemper, or had been killed on that Account, in the County of Middlesex; but that from the said First Day of September to the Tenth Day of November following, no less than Nine hundred and eighteen Oxen and Cows, and Thirty-one Calves had been killed and buried by the Inspectors, within the said County; which great and sudden Increase of the faid Distemper, was apprehended to have arisen from the holding two great Fairs for Horned Cattle near the Borders of the said County of Middlesex, the one in that Part of Barnet which lies in the County of Hertford, on the 24th of August, and the other at Harlow Bush in the County of Essex, on the 29th of the faid Month; to which Fairs, distemper'd Cattle being brought, were there bought and fold, and dispersed all over those and the Neighbouring Counties.—And whereas his Majesty hath this Day received further Information, that from the 13th of April in the present Year, to this Time, the Distemper hath entirely ceased In the County of Middlesex, not one Ox, Bull, Cow of Calf having either died or been killed bh Account thereof; but that there is great Rea-16th to apprehend, if the afore-mentioned two Fairs should be permitted to be held this Year, the same Mischies may arise as in the last, the ill Consequences whereof may prove very injutious to many of his Majesty's good Subjects:-His Majesty taking the same into his most sefious Consideration, and being desirous of doing Wery Thing in his Power to prevent the Spread-My of the said Distemper, hath therefore thought fit, and doth, by this his Order in his Privy County, declare and order, that no Fair or Fairs, Market, or Shew of Cattle, be held for the Stile of Cattle on the 24th of this Instant Altgust, at Barnet aforesaid, or any Place ad-Jacent, nor any Fair or Fairs, Market, or Shew of Cattle at Harlow Bush on the 29th of this Instant, or any Place adjacent thereto: —And

his Majesty doth hereby strictly forbid the sending, driving, or removing, or causing to be sent, driven or removed, any Ox, Bull, Cow, Calf, Steer or Heiser, to either of the said Fairs or Markets, or any other Fair or Market, or Shew of Cattle, in any Place adjacent: -- And his Majesty's Justices of the Peace in the Counties of Hertford and Essex, near to the Place where the afore-mentioned Fairs are usually held, are hereby required to issue their Orders to the Chief Constables or Headboroughs of the Hundreds, Lathes, Rapes or Wapentakes, and to the respective Petty Constables of the respective Pa+ rishes within the same, to prevent the holding the said Fairs or Markets: And if any Person or Persons shall presume to drive, remove, or send, or cause to be driven, removed, or sent; any fuch Cattle to the faid Fairs or Markets contrary to this Order, such Person or Persons fo offending, shall be carried before some Neighbouring Justice, to be dealt with according to Law.

And his Majesty doth hereby strictly charge and command, not only the Justices of the Peace within the said Counties of Hertford and Essex, but also all the Justices of the Peace, and other Magistrates throughout the Kingdom of England, that-they do take Care at this Season of the Year, when Fairs and Markets are usually held for the Sale of Cattle, to inform themselves thoroughly, whether the holding the said Fairs and Markets are likely to be attended with the Danger of Spreading the said Distemper; and if they shall apprehend them so to be, that them the said Justices do, at their General or Quarter Session, or at any Adjournment thereof, within their respective Counties, cause a Stop to be put to the holding the same, pursuant to the Powers vested in them for that Purpose, by his Majesty's Order in Council of the 22d of March 1747.

And his Majesty doth likewise hereby strictly charge and command all the said Justices of the Peace, and other Magistrates and Officers, to be careful and diligent in carrying into Execution the Rules and Regulations contained in the several Acts of Parliament and Orders of Council for putting a Stop to the Spreading of the Director of the Horned Cattle.

Naples, Faly 27. The King proposes setting but next Week for the Island of Procida, in order to take the Diversion of hunting for some Days. We are informed by the Masters of several Ships that are just arrived here from the Coast of Sicily, that on the 11th Instant two violent Earthquakes happened at Palermo, and in that Neighbourhood, by which a great Number of Houses had been very much damaged. During the Course of last Week fifteen more of the Banditti, who have lately infested the publick Roads of this Kingdom, were brought here under a strong Guard and committed to Prison.

Rome, July 31. Last Monday Night the Inhabitants of this City were greatly alarmed by a violent Shock of an Earthquake, which however went off without doing any confiderable Damage. M. Cervini, Patriarch of Jerufalem, died here on Thursday last, very much advanced in Years.

Florence, July 31. Count Richecourt; President of the Regency, is indefatigable in his Endeavours to bring to Perfection the great Road that is making over the Mountains of this State to Bologna; from whence 'tis expected our Commerce will reap great Advantages. We learn from the Romagna, that they have felt feveral flight Shocks of an Earthquake within these sew Days past, but that happily they had done very little Damage.

Florence, Aug. 6. On the 1st Instant an Express arrived here from Siena with Notice, that the Evening before, whilst they were acting an Opera, an accidental Fire broke out in the Theatre, which was soon quite destroyed by

Genoa, Aug. 2. We are waiting here with great Impatience to learn what Resolutions will be taken at the General Assembly that is now holding at San Fiorenzo, in Relation to the Affairs of Corfica. The Master of a Ship arrived here on Saturday last from Naples says, that one of our armed Barks, which has been cruizing for some Time off Cape Colonna, had been taken, after a smart Engagement, by a Tunesian Chebeck, and carried into the Port of Otranto. Our last Letters from Madrid say, that the King of Spain, upon a Representation made to him of the great Want of People in general, and particularly of Handycraftsmen, in the West Indies, had agreed to allow some peculiar Privileges and Exemptions to fuch of his Subjects or others as should be willing to go thither, and exercise their Trades.

Turin, Aug. 3. On Wednesday the King, accompanied by all the Royal Family, and attended by several of the principal Lords and Ladies of the Court, went on a Party of Pleasure in a Gondola upon the River Po. - His Majesty has appointed the Count de Brisquerasque, Governor of the Duke of Chablais, to be Viceroy of the Kingdom of Sardinia, in the Room of Don Emmanuel de Valguarnera, whose three Years is expired, being the Time that Place is

Branswick, Aug. 6. Venice, Aug. 6. Great Disturbances have lately happened at Crema, on Account of the Dearness of Corn and Provisions, which obliged the People to complain to the Podesta, desiring that the Syndicks might, regulate the Prices of them, and it was accordingly done to their Satisfaction: But the Podesta being highly displeased with the Behaviour of these Magistrates, ordered them to be put into Prison. Upon this the People rose, and threatened to murder the Podesta, unless he released them; who apprehending they would put their Menaces in Execution, acquainted the Senate of his Situation. Whereupon Signior Mosto, an Inquisitor, was immediately sent with full Powers, who, soon after his Arrival, caused the three Syndicks to be hanged, and condemned several of the Ring. leaders of the Riot to the Galleys. These Proceedings greatly irritated the People, who not daring to attack the Troops the Inquisitor had a brought with him, retired in great Numbers into the State of Milan, and those who remain. ed, declared they would no longer obey the. Governors sent by the Republick. In this State of Things it was thought necessary to try other Methods, and Signior Luigi Pisani, Governor of Palma, was sent with Offers of a General Pardon, and Promises from the Senate to redress the Grievances complained of, which has succeeded, and thereby an End is put to an Affair which could not but give great Uneafiness here. They write from Naples, that in Consequence of an Edict lately published there against the Free Masons, several Persons have aleady been taken up and put into Prison.

Vienna, Aug. 7. Yesterday an Express arrived here with Advice, that on Wednesday Evening last their Imperial Majesties reached Buda, where they rested that Night, and the next Morning fet out for the Camp, where they proposed staying five or fix Days. On Thursday a long Conference was held at Field Marshal Count Konigseck's, at which Marshal Bathiany, and the Counts Colloredo and Uhlefeldt affifted. The same Day a Fire broke out at a Baker's House at Nusdorff, about a League from hence, which burnt with such Violence, that upwards of thirty Houses were consumed before a Stop

could be put to it. Breslau, Aug. 8. Great Preparations are making for the King's Reception, who is expected here towards the End of this Month; and all the Regiments quartered in this Province have Orders to hold themselves in Readiness against that Time to be reviewed by his Majesty. We learn from the Frontiers bordering upon Poland,

that

that the Locusts have appeared for several Days past in prodigeous Numbers, and spoil every Field and Garden wherever they settle.

Copenhagen, Aug. 10. This Afternoon the Pilot of 60, and the Iceland of 50 Guns, two new Men of War, were launched here in the Presence of their Majesties, of several of the Nobility, and of a prodigeous Concourse of the common People.

Ratisbon, Aug. 12. On Friday last Field Marshal Count Hohenembs was unanimously elected, by all the three Colleges, into the important Employment of General of Horse of the

Empire.

Hanover, Aug. 12. We hear from divers Places in this Electorate, that the Distemper amongst the horned Cattle, which twas thought had entirely ceased in this Country, has broke out again, and rages with greater Violence than beretofore.

Cleves, Aug. 16. The Regency of this Dutchy have published an Ordonnance, by which, in Conformity to the King's Orders, all private Persons whatsoever are forbid fending their Children to be educated in any other University than those in his Majesty's Dominions.

Brussels, Aug. 16. 'Tis said an Ordonnance is preparing, and will be published in a sew Days, to prevent the sending of Corn out of this Country, on Account of the great Rains we have had here for some Time past, which has already occasioned a Rise of that Commodity.
