HE following Address of the Lord Mayor, Sheriffs, Commons, and Citizens of the City of Dublin, having been transmitted to his Grace the Duke of Dorset, Lord Lieutenant of Ireland, has by his Grace been presented to his Majesty: Which Address his Majesty was pleased to receive very graciously.

To the King's most Excellent Majesty,

The humble Address of the Lord Mayor, Sheriffs, Commons, and Citizens of the City of Dublin, in Common Council assembled.

May it please your Majesty,

WE your Majesty's most dutiful and loyal Subjects, do, with unfeign'd Joy, congratulate your Majesty on the safe Delivery of her Royal Highness the Princess of Wales, and the Birth of a Princess.

The Bleffings we enjoy under your Majesty's Government can only rife in their Estimate from a Prospect of their Continuance— And that Prospect is enlarg'd to us by the Birth of this Princess, as it has added to the Number of the many other Royal Pledges, heretofore fprung from you, for our future Security.

Every Increase of your Family must be a Circumstance of the highest Satisfaction to your Subjects, especially as they see how equally your paternal Care is shar'd between your Offfpring and your People—You have given us many Instances of this your Goodness, but amongst them, none more conspicuous, than that wife Provision (schem'd and made perfect by you) whereby unexperienced Youth will be guided and directed in the Government of your Kingdoms by the Maxims of found Policy, and the true Interest of the People preserv'd in the tender Years of an Infant Successor when it shall please Heaven to afflict us with the Loss of you.

In Testimony whereof we have caused the common Seal of the said City to be hereunto affixed this 29th Day of July, One thousand seven hundred and fifty one.

Petersbourg, Aug. 1. The Number of Forces ow on Foot in this Empire, that are ready to take the Field upon any Emergency, amount, according to a List lately sent to Court, to 200,000 effective Men, 160,000 of which are Foot, and 40,000 Horse, besides Calmucks, Cossacks, and the Militia of the Country. Mafor General Brown, Son-in-Law of the late Eleld Marshal Count Lascy, and the Count de

Brigly, Commander of the Troops quartered in Easthonia, are both solliciting their Discharge from this Service, the latter on Account of his great Age and bad State of Health. A Courier is arrived here from Constantinople, by whose Dispatches we learn, that the Porte has sent new Orders to the Kans of Crimea and Budziack, to take especial Care that the Tartars conduct themselves in such a Manner, as that the Subjects of the Russian Empire, bordering upon them, have not the least Cause to com-

plain of their Behaviour.

Bastia, Aug. 3. The Deputies of the several Communities of this Island being assembled at San Fiorenzo, pursuant to Summonses which were fent to them for that Purpose, the Chevalier de Chauvelin and the Marquess de Cursay communicated to them a new Regulation for establishing the Tranquillity of this Country 5 and, after the same had been taken into Consideration, the Deputies returned for Answers that there were some of the Articles liable to Objections, however they would lay them before their Communities, and do all in their Power to support them.

Plaisance, Aug. 5. The extreme dry Weather we have had for some Time past in this Country, having greatly damaged all the Fruits of the Earth, publick Prayers are at length put up in all the Churches of this Dutchy for wet Weather. The Court is to continue at Sala till the Middle of October next, and is then to return to Parma. The Infanta Dutchess advances happily in her Pregnancy. Cardinal Alberoni has confiderably augmented the Revenues of the Seminary which he lately establish-

ed in this City.

Rome, Aug. 7. The Congregation of the Sacred Rites, which was held a few Days ago in the Pope's Presence, was composed of 17 Cardinals, besides many Prelates; and others; when the Proofs of the Miracles that have been performed through the Intercession of that venerable Lady Maria de Chantal, Foundress of the Religious Order of the Visitation, were fully admitted, so that to all Appearance they will soon proceed to her Beatification. We have received Advice from Anzio, that the Maltele Gallies put to Sea on Wednesday last on a Cruize against the Barbary Pyrates. All the Advices we have received for some Days past from different Parts of the Ecclesiastical States are full of melancholy Accounts of the great Damage they have received by the late Earthquakes. A few Days ago the Pope caused & Bull to be fixed up in different Parts of this City. notifying to the Publick, the Suppression of the Patriarchiate of Aquileja, and the Erection of

the

the two Archbishopricks of Udine and Gorizia, and his Reconciliation relating thereto with the

Republick of Venice.

Buda, Aug. 9. On Wednesday last their Imperial Majesties, accompanied by Prince Charles of Lorrain, arrived at the Camp near Pest, and were received by a Discharge of several Pieces of Cannon. The next Day the 17 Regiments of Horse, of which it consists, were drawn up in order of Battle; and their Imperial Majesties having taken a View of them in Front, retired to a magnificent Tent that was erected for their Reception, when each Regiment filed off and marched by in great Order before them; and then joining again, made a most surprizing quick running Fire. When this was over their Imperial Majestics were entertained at Dinner by Prince Lichtenstein, who commands in Chief the Troops there encamped; and several of the Nobility and General Officers were admitted to dine at their Table; after which the three Sclavonian Battalions of Foot were drawn up and went through their new Exercise with great Dexterity. On Friday and Saturday they reviewed each Regiment feparately, and express'd great Satisfaction at their Behaviour and Appearance. And Yesterday their Imperial Majesties, accompanied by Prince Charles of Lorrain, and attended by several of the Nobility and General Officers, came hither to view this City and its Citadel.

Stockholm, Aug. 10. The King has caused an Edict to be issued, forbidding, under very severe Penalties, the Publication of any Books or Papers relating to the imaginary Fears that have been for some Time spread in Relation to the establishing of Arbitrary Power in this Kingdom. We are informed by Letters from the respective Provinces, that they have already elected the greatest Part of the Deputies who are to assist at the general Diet of the States of this Kingdom, which Elections having been carried on with all possible Tranquility, give great Reason to believe their Deliberations will be attended with all the Success imaginable.

Vienna, Aug. 14. The young Imperial Family enjoy perfect Health at Schonbrun, from whence the Archduke Joseph, and the Princess Charlotte of Lorrain, proposed setting out as Yesterday Asternoon or this Morning for Presbourg, in order to wait there for and receive their Imperial Majesties on their Return from

the Camp at Pest.

Dresden, Aug. 15. The Troops encamped in the Neighbourhood of this City consists of 4000 Foot and two Regiments of Horse, commanded by Field Marshal Count Rutowsky. On the 5th Instant they were reviewed by the King, when they performed all their Evolutions and Firings in his Majesty's Presence, who appeared greatly pleased with their Appearance and Behaviour. A Committee of the States of this Electorate are to assemble here in a short Time, in order to take into Consideration divers Plans which have laid before the Court for the Re-establishment of the Finances. On Tuesday last M. Durand, the French Minister, had his Audience of Leave of his Majesty.

Ratisbon, Aug. 16. A few Days ago the Swedish Minister, and a Minister from his Sezene Highness the Prince of Orange, delivered to the Diet of the Empire, the Acts by which his Swedish Majesty, as Duke of Pomerania,

and the Prince of Orange for the Principality he possession Germany, accede to the general Guarantee the Empire lately gave to the Treaty of Dresden.

Copenhagen, Aug. 17. The Report that was fpread some Days ago of the Queen's being again with Child, seems to be confirmed, and 'tis now said the same will shortly be declared at Court. A Resolution has been taken to erect a new Battery of Cannon at Elsenore, and 200 Men are ordered thither from this Garrison for that Purpose. The Dey of Algiers has wrote a Letter to the King, dated the 11th of June last, giving him the strongest Assurances of his inviolable Resolution to maintain the Peace which at present subsists between his Country and the Kingdom of Denmark; and assuring his Majesty, that the Reports which have been spread to the contrary have not the least Foundation, and are only propagated by ill designing People.

Hambourg, Aug. 17. Field Marshal Count Lowendahl is expected here from Berlin in a few Days. We are informed by Letters from Copenhagen, that the King of Denmark has raised M. d'Ahleseld, Commander of Gluckstadt, to the Rank of Lieutenant General of Horse. By our last Letters from Poland we have Advice, that a Detachment of the Crown Army had furprised, in a Wood, a small Body of Heyducks, whom they had entirely defeated, The same Letters say, that notwithstanding all the Measures that have been taken, in Conjunction with the Russian Troops, to extirpate that Race of common Plunderers, they still continued to commit, from Time to Time, in small Bodies, great Violations in the Polish Ukraine, where they have lately pillaged feveral Gentlemen's Country Seats, and even fome Convents.

Hague, Aug. 24. M. Salles, Lieutenant Colonel of the Regiment of Lieutenant General Villattes, having been appointed by his Serene Highness the Prince of Orange, to the Post of Governor of the Fort of St. Michael at Venloy he this Day took the -usual Oaths before the Assembly of their High Mightinesses, in order to qualify himself for that Employment. His Serene Highness has likewise disposed of the late General Cronstrom's Regiment of Foot, in Favour of Major General Holsten. They write from Leyden, that M. Vander Goes, Receiver of the Finances of that City, died lately there; and from Bergen-op-Zoom we have Advice of the Death of Colonel Vye, Director of the Fortifications of this Country.
