The Lords of His Majesty's most Honourable Privy Council,

HEREAS upon Information of the Plague raging with great Violence at Constantinople and Parts adjacent, His Majesty thought proper, by His Order in Council of the Fourth of September last, to require and command all Ships and Veisels that should arrive after that Time from the Levant, to perform a Quarantine of Forty Days in Standgate Creek ---- And whereas some Doubts may arise concerning the Extent of the Levant, it is therefore judged necessary hereby to declare and order, that the Levant be understood in this Case (as formerly on like Occasions) to extend itself Eastward from the We of Corfu on the Borders of Greece in the Ionian Sea, and from Cape Rusata on the Coast of Barca in Africa. Whereof the Lords Commissioners of his Majesty's Treasury, and the Lords Commissioners of the Admiralty, are to take Notice, and give the necessary Directions herein accordingly.

Naples, Sept. 23. The King is determined if possible to have the Men of War and Frigats now actually upon the Stocks, launched early in the Spring, for which Purpose his Majesty has given Orders that the Workmen be paid for working all extraordinary Hours. Two of our Gallies, which have been eruizing for some Time upon the Coast of Calabria, against the Barbary Pyrates, are returned into Port, in order to be repaired, having suffered very much lately in a violent Storm. The King has appointed Don Mirabelli, to be one of the Judges of the Criminal Court of Justice of

this Kingdom.

Rome, Sept. 25. The Pope has given M. Maggi Leave to relign his Employment of Prelident of the Mint, and M. de Bonacorfi is appointed to succeed him. Orders are dispatched to all the Frontiers of the Ecclesiastical State, for the late Prohibition against sending of Corn out of this Country, to be skrictly carried into Execution. The Collection that has been made in this City, and its Neighbourhood, for the Relief of the Sufferers by the late Earthquakes at Ombria and Ancona, amount to a very considerable Sum, the greatest Part of which has already been remitted to them for their present Sublistence. Neapolitan Pink in the Sea of Tuscany.

Legborn, Sept. 26. The Pope's Gallies, that were drove into this Port a few Days ago by contrary Winds, are put to Sea again, and failed for the Island of Corsica, where they are to be joined by some Genoese armed Vessels that are ordered to go with them on a Cruize against the Algerine Corsairs, who appear in great Numbers on the Coast of the Ecclesiastical State, and greatly interrupt the Commerce. The Master of a French Ship just arrived in this Port from Tunis says, that four large Galliots, and two Tartanes, were fitting out there by Order of the Dey and Regency, and that it was confidently reported they would be ready to put to Sea by the Beginning of next Month, in order to oruize in the Spanish Seas.

Warfaw, Sept. 26. All the Accounts we receive from Turky agree, that although the Ottoman Troops, who advanced some Months ago into the Neighbourhood of Checzin, Bender and Oczakow, continued very quiet in their respective Quarters, yet the repairing and augmenting the Fortifications of these three Piaces were carrying on with great Vigour by the

Grand Seignior's express Orders.

Vienna, Oct. 2. Preparations are making at Schonbrun for celebrating the Emperor's Name-Day on Monday next. 'Tie said & Resolution has been taken to keep 30000 Imperial Troops on Foot in Bohemia, for the enabling this Court to be always ready to fulfill its Engagements with that of Russia. Yesterday the Court went into Mourning for the Death of the Electress of Bavaria, and the young Prince of Est, second Son of the Duke of Modens. Her Impetial Majesty has sent Orders to the Commanding Officers of her Forces quartered on the Frontiers of Hungary, bordering on the Dominions of the Grand Seignior, to cause the Troops under their Command immediately to form a Line, in order to prevent the Plague, which still rages pretty much in some of the neighbouring

neighbouring Provinces, being brought into her Dominions. The Empress has appointed M. de Cammermayer, to be Governor of the important Fortress of Clausenbourg, upon the Frontiers of the Bannat of Tameswear.

Leipsick. Off. 4. According to all Appearance our Fair will be extreamly brilliant this Year, owing principally to the Presence of their Majesties, and the young Royal Family, who

arrived here last Saturday.

· Copenhagen, Oct. 4. The Court is still at Friedensbourg, but their Majesties are expected here some Day next Week. Several of the Nobility, and other Persons of Distinction of both Sexes, are gone with the King's Permission to Stockholm, in order to fee the Ceremony of the Coronation of their Swedish Majesties. A few Days ago one of our Ships arrived here from Saffia, by which we received an Account of the. Methods that are taking there for increating our Commerce with the Barbary Coast, which 'tis computed will now be soon put in fuch a flourishing Condition, as to produce yearly to this Kingdom at least a Million of Germany Crowns.

Berlin, Oct. 5. The Ceremony of the Marriage of M. Marschalls, eldest Son of the late Privy Counsellor of that Name, with one of the Daughters of Count Podewils, his Majesty's Prime Minister, was performed here Yesterday with great Magnificence; to which almost all the Nobility in Town were invited and affifted. We have received Advice by the last Post from Silesia, that a Fire broke out on the 27th of last Month in the little Town of Sulau, which burnt with such Violence, that the greatest Part of the Houses were consumed before it could

be extinguished.

Frankfort, Oct. 6. The Landgrave of Helle Darmstadt, accompanied by a numerous Retinue, passed by here last Saturday for Giessen, to which Place he was going in order to take the Diversion of Hunting in the Forests in that Neighbourhood. We have already began the Vintage in feveral Places; and as we have had very fine Weather for these eight or ten Days past, 'tis hoped the Wines will prove much better than were expected.

Wetzlar, O.J. 8. Last Monday being the Feast of St. Francis, whose Name the Emperor bears, the same was celebrated here with great Magnificence. TOp this Occasion a general Discharge was made in the Morning of the Cannon upon the Ramparts, At Noon all the Members that compose the Imperial Chamber went in a Body to the principal Church of this City, and affifted at TexDeum which was fung to Musick during which another Discharge was made of our Artillery; the Citizens, who were under Arms, making at the same Time several Discharges of their Small Arms. After Divine Service the Prince of Hohenlohe Barten-Hein gave a sumptuous Entertainment to the Members of the Imperial College, of one hundred Covers; which was followed by a Ball that lasted till Midnight.

Brussels, Oct. 14. Prince Charles of Lorrain, our Governor Generalaris expected here from Vienna about the 25th or 26th of this Month, when 'tis said forme Affairs of Importance will

be brought on the Carpet.

Hague, Oct. 18. The States of Holland and Westfrizeland have continued To-day their Deliberations; as have likewise the Deputies of the several Colleges of the Admiralty of this Country. The Duke of Brunswick Wolfembuttel is daily expected here from his Government of Bois-le-Duc.
