HIS Day an Express arrived at his Grace the Duke of Newcastle's Office, from Solomon Dayrolle, Esq; His Majesty's Resident to the States-General of the United Provinces, with an Account, That on Friday the 11th Instant, about Two o'Clock in the Morning, His most Serene Highness the Prince of Orange, Hereditary Stadtholder, Captain General and Admiral General of the United Provinces of the Low Countries, died after a very short Illness. And the same Day the States-General, and also the States of Holland, fent a Deputation with Compliments of Condolance to the Princess Royal upon this melancholy Event, and to administer to her Royal Highness the Oaths as Gouvernante and Guardian to the young Prince Stadtholder her Son.

Lord Chamberlain's Office, Oct. 15. THE Court goes into Mourning on Sunday next the 20th Instant, for his late most Screne Highness the Prince of Orange, Hereditary Stadtholder, Captain General and Admiral General of the United Provinces of the Low Countries, viz.

Whereas upon Information of the Plague raging with great Violence at Constantinople and Parts adjacent, His Majesty thought proper, by His Order in Council of the Fourth of September last, to require and command all Ships and Vessels that should arrive after that Time from the Levant, to perform a Quarantine of Forty Days in Standgate Creek----And whereas some Doubts may arise concerning the Extent of the Levant, it is therefore judged necessary hereby to declare and order, that the Levant be understood in this Case (as formerly on like Occasions) to extend itself Eastward from the lile of Corfu on the Borders of Greece in the Ionian Sea, and from Cape Rusata on the Coast of Barca in Africa. Whereof the Lords Commissioners of his Majesty's Treasury, and the Lords Commissioners of the Admiralty, are to take Notice, and give the necessary Directions herein accordingly.

This Day the Parliament having met ac-cording to the Prorogation, his Grace the Lord Lieutenant went in State to the House of Peers, and being seated on the Throne with the usual Ceremony, his Grace sent for the Commons, and made the following Speech to both Houses.

His Grace the Duke of Dorset, Lord Lieutenant General and General Governor of Ireland, his Speech to both Houses of Parliament, at Dublin, on Tuesday the 8th of October 1751.

My Lords and Gentlemen,

I Shall ever esteem it the greatest Honour, and my peculiar Happiness, that the same gracious Sovereign, who formerly placed me in this high Station, hath again commanded me to meet a Parliament, whose dutiful and affectionate Attachment to His Royal Person and Government, I have so often experienced, and upon all Occasions have faithfully represented to His Majesty.

A fincere Zeal for His Majesty's Service, and for your Prosperity, shall ever be the governing Principle of my Administration; and my perfect Knowledge of your Temper and Unanimity assures me, that we all meet with equal Incli-

nation to promote the publick Welfare.

The zealous Concern that His Majesty's faithful Subjects of Ireland have so eminently shewn, for the Preservation of the Crown, in His Illustrious House, leaves me no Room to doubt, that you were deeply affected by the late publick Loss which these Nations have sustained: And you must be filled with the warmest Sentiments of Reverence and Gratitude, when you consider the Greatness, and the Goodness of His Majesty's Mind, who immediately proposed those salutary Provisions, which have since passed into a Law, for guarding against every remote Danger, and for securing the People, as far as human Wildom could reach, against the Consequences of any fatal Event.

Gentlemen of the House of Commons,

I have ordered the proper Officers to-prepare the several Accounts and Estimates to be laid before you, as also a particular Account of the Money expended in Repairing, Rebuilding, or Building Barracks, pursuant to your Address in a former Session of Parliament.

It gives me great Satisfaction to observe the extraordinary Produce of the Funds which you

have formerly granted, and I have nothing to

ask but the usual Supplies.

I am commanded by the King to acquaint you, that His Majesty, ever attentive to the Ease and Happiness of His Subjects, will graciously consent, and recommends it to you, that such a Part of the Money now remaining in His Treasury, as shall be thought consistent with the Publick Service, be applied towards the surther Reduction of the National Debt.

My Lords and Gentlemen,

The two great Objects which demand your constant and most serious Attention are, the Security of the Protestant Interest, and the Advancement of your Trade. It must necessarily occur to you, how much the Support of the Charter-Schools, and the Encouragement of your Linnen Manusactures, will contribute to the Attainment of these important Ends, and what surther Provisions may be expedient, will be the Subject of your Deliberations. My Conduct shall convince you, that nothing on my Part shall be wanting, that may effectuate His Majesty's gracious Intentions, to make His Subjects of Ireland as happy, as I know them to be dutiful and loyal.

Lishon, Sept. 17. We are assured, that the Cession of the Island of St. Sacrament, which was made to the Crown of Spain during the preceding Reign, has been approved and confirmed by his present Majesty, on the Conditions stipulated in the Treaty concluded between his

late Majesty, and that Crown.

Petersbourg, Sept. 26. There is no Appearance at present of any Alterations being to be made in the Situation of our Troops quartered on the Frontiers of Finland; on the Contrary, Orders have been lately sent thither, for filling all the Magazines with Provisions and Forage. Tis generally believed the Court's Journey to Moscow this Year is laid aside, at least there are not as yet any Preparations at all making for it.

Naples, Sept. 27. On the 19th Instant, being the Festival of St. Gennaro, the King, attended by the Knights of that Order in their Robes, performed the usual publick Ceremony and Procession in the Royal Chapel; and, in the Asternoon, after having visited the Cathedral Church, set out with the Queen and the Royal Family for Portici. A Proposal is laid before the King for opening a new Street from the Castle dell'Ovo, to the Garrison of Pizzo Falcone.

Rome, Sept. 27. Last Week arrived in this City, Part of the Baggage of the Chevalier Capello, the new Venetian Ambassador to the Pope, who is expected shortly to arrive here. On the 20th Instant the Pope held a Confistory, in which he appointed the Bishop of Messina to be Archbishop of Jerusalem. On the 21st the Cardinals Alexander Albani and Mellini had an Audience of the Pope, in Confequence of some Dispatches they had received from the Court of Vienna. The same Night the French Ambassador received a Courier from his Court, with Notice, that the Dauphiness had, on the 12th Instant, been brought to Bed of a Prince; which Event the Ambassador, in a publick Audience, attended by the Gentlemen of the College of Cardinals, those of the Foreign Ministers, and 37 Prelates, communicated to the Po e. The Duke de Nivernois who

was on his Departure for France, has suspended that Journey; and, agreeable to the Directions he has received from his Court, is making the necessary Dispositions for publick Rejoycings on this Occasion. We have received Advice from Nani, a small Town in the Province of Ombria, that on the 23d and 24th two small Shocks of an Earthquake were felt there, and in that Neighbourhood; but that they had happily gone off without doing any considerable Damage.

Florence, Oct. 1. In Consequence of an Attempt which the Barbary Pyrates made a sew Days ago, to carry off forceably a Neapolitan Vessel then at Anchor under a small Tower on the Coast of Tuscany, from which Attempt they were obliged to desist by the Fire which was made upon them from the Tower, and by which several Moors were killed, the Regency sent last Week express Orders to Port Ferraio, to sit out, with the utmost Expedition, one of the Emperor's three Ships of War to cruize on these Coasts, and to keep those Corsairs in Awe.

Parma, Oct. 1. On Sunday last Cardinal Portocarrero arrived here from Rome, with a Retinue of 40 Persons, and the next Day waited on the Duke and Dutchess at Colorno, who received him with all possible Marks of Distinction. The Ceremony of his Baptizing the young Princess, is fixed for the 17th Instant; and, according to the Preparations that are making on this Occasion, it will be very magnificent.

Leghorn, Oct. 2. The common People here have lately rose in a very tumultuous Manner upon the Jews, alledging that they had fired upon a Priest at whose House three Jewish Woman had retired in order to embrace the Christian Religion; and the Disturbances were carried so far, that the Governor was obliged to draw out the Garrison before the Tumust could

be appealed.

Zerbst, O.E. 6. The Distemper amongst the Horned Cattle continuing to carry off great Numbers of them in some of the neighbouring Provinces, the Princess our Sovereign has caused and Ordonnance to be published, forbidding under very severe Penalties, the bringing any Horned Cattle to our approaching Fair, unless it appears by authentick Certificates, that they neither come from, or have passed by any Place where

the said Distemper now rages. Vienna, Oct. 9. On the 4th Instant the Emperor's Name-day was celebrated at Schonbrun. with great Magnificence; on which Occasion the Court was extremely brilliant, and their Majesties dined in Publick, with the young Archduke and Archdutchesses. The Assembly of the States of Lower Austria is fixed for the 16th Instant at Schonbrun, where the Propositions to be made by her Imperial Majesty will be laid before them; after which they are to adjourn to their Assembly-Room in this City, in order to take them into Consideration. Last Week a grand Conference was held at Field Marshal Count Konigseck's, at which Prince Lobkowitz, and several other General Officerse's assisted, wherein it was determined what Number of Troops are to be quartered in each off the Hereditary Provinces. Prince Charles of Lorrain will set out from hence on the 17th; Instant for Brussels, the necessary Relays of Horses upon the Road being already ordered.

Frankfort, Oct. 10. According to our last Advices from Alface, the Troops appointed to Garrison in that Province during the Winter, consist of 37 Battallions, Teven Regiments of Horse, and two of Dragoons, and are to be distributed in Conformity to Orders delivered from the War Office, as follows, viz. four Battallions in the Citadel of Strasbourg, and twelve in the City, with the two Regiments of Dragoons; fix Battalions, and a Regiment of Horse, at Landau; two Battallions at Lauterbourg; three at Hagenau; two at Fort Louis; two, and a Regiment of Horse at Shelestat; three, and a Regiment of Horse at Brisac; three, and a Regiment of Horse at Huningue; two Regiments of Horse at Phalsbourg; and one Regiment of Horse at Thionville.

Berlin, Oct. 11. On Friday last the King, accompanied by Prince Ferdinand of Brunswick arrived here from Potzdam; and having given some Audiences, went to dine with the Queen-Mother at Monthijou: The next Morning his Majesty reviewed the Regiments here in Garrison, and then set out on his Return for Potzdam.

Hambourg, Oct. 14. They write from Poland, that several of the Dietines for the Election of Members to assist at the Tribunal of Petrikau, are separated without coming to any Choice; and that in some of them the Disputes ran so high, that several Swords were drawn, and some Persons wounded. We are informed by our last Letters from Stockholm, that Count Gyllenbourg's being elected Marshal of the Diet of the States of that Kingdom, gives great Satissaction on all Sides.
