HIS Majesty came this Day to the House of Peers, and being in his Royal Robes seated on the Throne with the usual Solemnity, the Honourable Sir Henry Bellenden, Gentleman Usher of the Black Rod, was sent with a Message from His Majesty to the House of Commons, commanding their Attendance in the House of Peers. The Commons being come thither accordingly, His Majesty was pleased to make the following most gracious Speech.

My Lords and Gentlemen,

IT is with great Satisfaction that I meet you in Parliament, at this Time, when the Continuance of the Publick Tranquillity, and the flourishing Condition of my Kingdoms, leave us nothing to desire, but to secure and improve our present Situation. To this End all my Views and Measures have been directed both at Home and Abroad; and, in this State of Things, nothing can give me more real Pleasure, than to observe those solid Advantages, which my good Subjects reap from it, in their Trade and Manufactures; some Branches whereof have also received considerable Benefit, from the wise Provisions which have been made by this Parliament.

The Treaty lately entered into with the Elector of Bavaria, was laid before you in your last Session; and I then acquainted you, that I was taking such further Measures, as might tend to secure the Tranquillity of the Empire; support its System; and timely prevent such Events, as had been found by Experience to endanger the Common Cause. I have since, for the same Purposes, in Conjunction with the States General of the United Provinces, found it necessary to conclude a Treaty with the King of Poland, Elector of Saxony; which shall be communicated to you.

The unfortunate Event of the Prince of Orange's Death, has made no Alteration in the State of Affairs in Holland; and by the prudent and early Measures taken there, the Quiet of that Country has been preserved, and their Government carried on upon the Foundation of the Settlement, which had, with so much Foresight, been previously established by Laws of the Republick. I have received the strongest Assurances from the States General, of their firm Resolution to maintain that strict Union and Friendship, which so happily subsist between me and those ancient and natural Allies of my Crown.

Gentlemen of the House of Commons,

I have ordered Estimates of the Expences of the ensuing Year to be prepared and laid before you; and have no other Supplies to ask of you, but such as are requisite for those Services, and for making good such necessary Engagements, as you are made acquainted with. The Success which has attended your Firmness in reducing the Interest of the National Debt, will, I am confident, give you the greatest Satisfaction.

My Lords, and Gentlemen,

The Experience I have had of your dutiful and steady Conduct, makes it wholly unnecessary for me to press upon you Unanimity and Dispatch in your Deliberations. But I cannot conclude, without recommending to you, in the most earnest Manner, to consider seriously of some effectual Provisions to suppress those audacious Crimes of Robbery and Violence, which are now become so frequent, especially about this great Capital; and which have proceeded, in a great Measure, from that profligate Spirit of Irreligion, Idleness, Gaming, and Extravagance, which has of late extended itself, in an uncommon Degree, to the Dishonour of the Nation, and to the great Offence and Prejudice of the sober and industrious Part of my People.

Walter Titley, Esq; His Majesty's Envoy Extraordinary to the Court of Denmark, has transmitted to his Grace the Duke of Newcastle, His Majesty's Principal Secretary of State, the following Account from Copenhagen, dated the 30th of October N. S. It having been found necessary to change the Situation of the Fire kept hitherto upon a Sand-Bank, at the Point of Jutland, called Schagen, for the Use of Mariners; His Danish Majesty has ordered Notice thereof to be given to the Publick, and, in Pursuance of that Order, the proper Officers sent an Advertisement, accompanied with a Memorial, to Mr. Titley, desiring him to transmit the said Advertisement to England, for the Information of the British Traders to the Baltick; of which Advertisement the following is a Translation.

Advertisement.

Whereas the Sand-Hill at Schagen, upon which a Fire has been kept hitherto in the Night Time for the Direction of Ships sailing through the Cattegat, is almost washed away by the Sea; and there is now erected, instead of the said wasting Sand-Hill, a Tower of Sixty Four Feet high, standing further within the Land at the Distance of Eight Hundred Feet from the Sand-Hill, and Four Hundred Feet more towards the North; upon which Tower the Fire is to be kept for the Future, and to commence on the ^{21st of January, O. S.} _{1st of February, N. S.} in the ensuing Year 1752: Therefore, by Order of the King of Denmark, Norway, &c. this Notice is given to the Publick, to the End that Mariners, being duly apprized of the Alteration beforehand, may regulate their Course through the Cattegat accordingly.

Should the foresaid Sand-Hill happen to be destroyed and carried quite away, by any violent Storm, before the Time abovementioned, in that Case a Fire will immediately be lighted up upon the Tower, instead of that which has hitherto burnt upon the Sand-Hill.

Naples, Oct. 25. In Consequence of a Resolution lately taken by the King to erect a Port at Cotrone, on the Coast of Calabria, they have began, to make the necessary Dispositions for carrying that Work into Execution. The erecting the Fort at Barletta goes on very successfully; and, according to Advices from Sicily, that of Giorgenti is already so forward, as to receive small Ships. The Commissary of War, who withdrew from Orbitello with about ten thousand Ducats of the King's Money, which were lodged in his Hands for paying the Troops of that Garrison, has been arrested in the Ecclesiastical State, at his Majesty's Request. He has since been brought to this City, escorted by a large Body of Soldiers, and Prosecutions are carrying on against him with the utmost Rigour. On Saturday last was felt here and in this Neighbourhood, a very smart Shock of an Earthquake; but we don't hear it has done any considerable Damage.

Leghorn, Oct. 30. Notwithstanding the Plague is greatly abated at Constantinople, we still continue to take all imaginable Precautions against its being brought here in any Goods or Merchandize whatever, for which Reason all Ships coming from the Levant are obliged to perform the strictest Quarantine. The Master of a Ship just arrived from Bastia assures us, that the Detachments of Troops which were sent by the Marquis de Cursay, amongst the dissatisfied Pieves or Communities, and particularly that of Niolo, which had been joined by some of the Neighbouring ones, were all returned to their respective Quarters, and that every Thing seemed now quiet again in the Island of Corsica. The last Advices received here from Spain assure us, that his Catholick Majesty has lately published an Ordonnance in Favour of all those who shall fit out armed Vessels to cruize against the Corsairs of Barbary, by which they are entitled to the Whole of all Prizes that shall be taken by them, without being liable even to pay the usual Duties.

Genoa, Nov. 2. The Assemblies of the Great and Lesser Councils, which have been suspended for some Weeks past, on Account of the Absence of most of the Members of the Regency, who have been spending the Autumnal Season at their respective Country Seats, were opened again a few Days since, and have under Consideration the necessary Means for establishing the Credit of the Bank of this City, and for preserving the Tranquillity of the Island of Corsica. We learn from Naples, that some Deputies were lately arrived there from a District of Esclavonia, who having obtained an Audience of the King, had informed his Majesty that the People they represented, not being able any longer to live in their own Country, on Account of the many heavy Taxes that were laid upon them, were obliged to seek out for a Livelihood elsewhere; and that having been informed of the Mildness of his Majesty's Government, they were desirous of becoming his Subjects, and therefore besought his Majesty to grant them a certain District in his Dominions belonging to the Crown; to allow them Provisions for one whole Year, and an Exemption from all Duties and Taxes for twenty Years; and in that Case, they would solemnly engage to become faithful Subjects to his Majesty and his Successors in all the Wars in which the Kingdom of the Two Sicilies shall hereafter be engaged. 'Tis said his Majesty has agreed to their Proposals, and that he has allotted for them the Island of Vento di Terra.
