Dditional Article to the antient Treaties subsisting between His Majesty and the Dey and Government of Algiers, agreed to by the present Dey, Mahomet, and His Majesty's Plenipotentiaries the Honourable Augustus Keppel, and Ambrose Stanyford, Esq; His Majesty's Agent and Consul General at Algier.

THAT all Packets or Express-Boats, bearing His Britannick Majesty's Commission, which shall be met by any of the Cruizers of Algiers, shall be treated with the same Respect as His Majesty's Ships of War, and all due Respect shall be paid to His Majesty's Commission; and both at Meeting and Parting, they shall be treated as Friends: And if any of the Algerine Cruizers commit the least Fault or Violence against them, the Captains or Raizes so offending, shall, on their Arrival at Algiers, and proper Complaint being made of them, be most severely punished, without admitting of their Excuses. Dated at Algiers the 3d Day of June 1751, and in the Year of Hageira 1164, the 20th Day of the Moon Regil.

MAlter Titley, Esq; His Majesty's Envoy Extraordinary to the Court of Denmark, has transmitted to his Grace the Duke of Newcastle, His Majesty's Principal Secretary of State, the following Account from Copenhagen, dated the 30th of October N.S. It having been found necessary to change the Situation of the Fire kept hitherto upon a Sand-Bank, at the Point of Jutland, called Schagen, for the Use of Mariners; His Danish Majesty has ordered Notice thereof to be given to the Publick, and, in Pursuance of that Order, the proper Officers fent an Advertisement, accompanied with a Memorial, to Mr. Titley, desiring him to transmit the said Advertisement to England, for the Information of the British Traders to the Baltick; of which Advertisement the following is a Translation.

Whereas the Sand-Hill at Schagen, upon which a Fire has been kept hitherto in the Night Time for the Direction of Ships

failing through the Cattegat, is almost washed away by the Sea; and there is now erected, instead of the said wasting Sand-Hill, a Tower of Sixty Four Feet high, standing further within the Land at the Distance of Eight Hundred Feet from the Sand-Hill, and Four Hundred Feet more towards the North; upon which, Tower the Fire is to be kept for the Futures and to commence on the 21st of Jahuary, O. S. in the ensuing Year 1752: Therefore, by Order of the King of Denmark, Norway, &c. this Notice is given to the Publick, to the End that Mariners, being duly apprized of the Alteration beforehand, may regulate their Course through the Cattegat accordingly.

Should the foresaid Sand Hill happen to be destroyed and carried quite away, by any violent Storm, before the Time abovementioned, in that Case a Fire will immediately be lighted up upon the Tower, instead of that which has

hitherto burnt upon the Sand-Hill.

-Constantinople, Nov. 5. The Plague is now entirely ceased in this Capital, and the Grand Signior, the Ministers of the Divan, and most of the Foreign Ministers, are come to Town. According to our last Advices from Persia, the Prince of Georgia continues to make great Progress in Ghilan, having already made himself Master of the greatest Part of that Province,

Petershourg, Nov. 19. Every Thing is now ready for the Empress's Departure for Moscow, and to all Appearance it will take Place as soon as a sufficient Quantity of Snow shall have fallen, and the Sledging Ways are become open. A few Days ago a private Gentleman was beheaded here for having betrayed the Secrets of this Court; and his Accomplices, after having been punished severely with the Knout, were banished to Siberia. The Weather is set in so very cold here for these three Days past, that not only Foot Pas- ' sengers, but even Carriages have already begun to cross the Neva. Several young Gentlemen, of the best Families in this Empire, have lately obtained her Imperial Majesty's Leave to go to different

different Universities in Europe, to prosecute Their Studies.

Cremona, Nov. 24. The Treaty lately concluded between the Empress Queen our Sovereign, and the King of Sardinia, is made publick, and tends principally to establish a lasting Friendship between those Powers, for the Preservation of their respective Territories in Italy. By this Treaty each others Subjects are to have free Liberty of carrying all Sorts of Goods and Merchandizes up and down the River Po, upon paying certain Rates and Duties, which are now greatly reduced to what they were before.

Stockholm, Nov. 26. The Russian Minister has declared to this Court, that the Empress his Mistress having nothing more at Heart than to cement the good Understanding that at present subsists between the two Courts, was ready to appoint Commissaries for regulating the Limits of Finland, which were left undetermined by the Treaty of Abo. And 'tis said the King, who is in the same good Disposition with the Empress of Russia, immediately communicated this Declaration to the Diet, who, after having examined it in a secret Committee, had acquainted his Majesty, that they lest that Affair entirely to his own paternal Attention, and doubted not but that he would take such Resolutions therein as he should judge best for the Good of the Kingdom.

Copenhagen, Nov. 30. A few Dags ago two new Gallies were launched here in their Majesties Presence, and named the Fredericksdhall and Frederickstadt; and his Majesty has ordered four others to be built in the Port of Frederickshaven in Norway. Yesterday being the Queen Dowager's Birth-Day, who then entered into the 62d Year of her Age, the same

was celebrated at Court as usual.

Vienna, Dec. 4. Yesterday there was a numerous Appearance of the Nobility and Gentry at Court for the first Time since their Imperial Majesties came to Town from Schonbrun for the Winter. We are assured that the Difficulties which retarded the Affair of the Investitures are entirely removed; and that, in Consequence thereof, several Princes are disposed to send Commissaries hither with Full Powers to receive, in their Names, the Investitures of their Estates from the Hands of his Imperial Majesty.

Breslau, Dec. 4. The King has appointed M. Carmer, heretofore Director of the Regency of Oppelen, to be Director of the Regency of this City; and M. Averdyk, heretotore Councillor of the Regency of Glogaus, is appointed Director of the Regency of Oppelen in his Room. We have received here an Account of the Death of Count Nostitz, Chamberlain and Privy Councillor to the King of Poland, at his Seat at Damnitz near Steinau,

in the 71st Year of his Age.

Dantzick, Dec. 5. Count Malachowsky, Great Chancellor of Poland, is arrived bete from Warsaw, with the King's Commission for terminating the Differences that have subsisted

for a long Time between the Magistrates and

Citizens of this City.

Berlin, Dec. 7. The Duke and Dutchess of Brunswick, accompanied by their eldest Daughter the Princess Caroline, and a numerous Retinue of Gentlemen and Ladies, arrived at Potzdam on Saturday last, and were received by the King with great Marks of Affection. Yesterday Morning the Prince of Prussia, and the Princes Henry and Ferdinand, arrived here from Potzdam, and were foon after followed by the King, and the Duke and Dutchess of Brunswick and their Daughter. The same Afternoon the Duke and Dutchess were presented to the two Queens, the Princess of Prussia and the Princess Amelia, by the Barons de Willich and Lentulus, whom his Majesty has appointed to attend them during their Stay at this Court.

Cologn, Dec. 10. Yesterday 300 Recruits marched from hence in order to complete the Imperial Regiments quartered in Luxembourg, and other Places in the Low Countries. A few Days ago two notorious Highwaymen, dressed in the Habits of Clergymen, who have committed several Robberies in this Neighbourhood, were apprehended and committed to Prison at

Duytz.

Hague, Dec. 16. The Honourable Joseph Yorke, Esq; Minister Plenipotentiary from the King of Great Britain to this Court, arrived here this Afternoon. Major General Creutnach has taken the usual Oaths before the Council of State, in Quality of Colonel of the Regiment of Artillery, in the room of Lieutenant-General Glabbeck, who, on Account of his Age, has obtained from her Royal Highness the Princes Governante, his Dismission from that Employment.
