On Thursday next there is to be a great Hunting Match in the Neighbourhood of Grunnewald, at which the King, all the Princes of the Royal Family, the Duke of Brunswick, and a great Number of the Nobility and General Officers are to be present; after which his Majesty proposes giving them a grand Entertainment at the Castle of Charlottenbourg.

Franckfort, Dec. 15. The Price of Corn is considerably risen, not only in this City and its Neighbourhood, but also in all the neighbouring Provinces, which is attributed to the large Quantities the French have bought up to fill the Magazines at Strasbourg, and other Places in Alsace.

Bonn, Dec. 17. The Elector of Cologne our Sovereign, accompanied by the principal Lords of the Court, set out from hence on

Wednesday Morning last for Munich.

Hague, Dec. 21. 'Tis said the Corps of his late Serene Highness the Prince of Orange is to be interred on the 15th of next Month. Yesterday the Hereditary Prince of Brunswick Wolfembuttle set out from hence for Brussels.
