Y the following Acts of Parliament now in Force, and which were made, for preventing His Majesty's Subjects from Trading to the East-Indies, under Foreign Commissions; and from being interested, or concerned, in any Foreign East-India Company, to be erected; it is Enacted as follows, viz.

5th Geo. I. Cap. 21.] By an Act passed in the 5th Year of His late Majesty, King George the First, all His Majesty's Subjects, except those Licensed by the East-India Company, are prohibited from going to the East-Indies. — And to the End such Offenders may be brought to Justice, the East-India Company are empowered to arrest, and seize, such Offenders in the East-Indies, and to send them to England, there to answer for the said Offence; And every British Subject, who shall procure, sollicit for, obtain, or act under, any Commission, Authority, or Pass, from any Foreign Prince, or State, to sail, or go, or trade, in, or to the East-Indies, incurs, and forfeits, for every fuch Offence, 500 l.

passed in the 7th Year of His late Majesty King George the First, every Subject of His Majesty, who shall go to, or shall Trade, or Adventure into, or from, the East-Indies, (contrary to the Laws in being,) and shall be convicted thereof, in any of His Majesty's Courts of Record, at Westminster, is to pay, and suffer such Fine, and Imprisonment, as the Court shall think sit.

And all the Goods, and Merchandize, that shall be bartered or traffick'd for, in the East-Indies, or purchased there, by any such Offenders, or that shall be found in his Custody, or in the Custody of any

oth Geo. I. Cap. 26.] By an Act passed in the 9th Year of His late Majesty King George the First, all His Majesty's Subjects are prohibited from subscribing, contributing to, encouraging, or promoting, the raising, establishing, or carrying on, any Foreign Company, from, and after, the 24th Day of June 1723, to be raised, formed, or erected, for Trading to the East-Indies, and from being interested in, or intitled to, any Share in the Stock, or Capital, of such Foreign Company, under Forseiture of all his, her, or their Interest, in the Capital, Principal, Stock, or Actions, of any such Foreign Company, together with Treble the Value thereof.

And the Attorney General is empowered to exhibit Bills of Complaint in the Court of Chancery, or Court of Exchequer, against such Offenders, for the Discovery of such Offence; which Discovery such Offenders are obliged to make on the Attorney General's waving in such Bill, the said Forseiture of the Treble Value, and insisting only on the Single Value thereof; And in such Case, the Single Value is to be decreed to be paid by such Offender.

And that every Subject of His Majesty accepting of any Trust, or knowing of any Interest, Share, Part, Proportion, or Concern, which any other of His Majesty's Subjects shall have, or be intitled to, in any fuch Foreign Company; and who shall not, within Six Months. next after the Accepting such Trust, or coming to the Knowledge of fuch Interest. Share, Proportion, or Concern, as aforefaid, truly discover the same in Writing to the East-India Company, or their Court of Directors, shall forfeit Treble the Value of the Interest so accepted in Trust, or so known and not discovered, as aforefaid; and any Person making such Disco. very, is intitled to a Moiety of the Forfeiture.

And all His Majesty's Subjects, (other than such as are lawfully authorized there-unto,) going to, or found in the East-Indies, are declared guilty of a High Crime,

Crime, and Mildemeanor, and are made liable to Corporal Punishment, Imprisonment, or Fine, for the same, at the Diferetion of fuch of His Majesty's Courts of Record at Westminster, where the Prosecution for such Offence shall be commenced.

And every Person so offending may be; feized, and brought to England, and committed to Goal there, by any one of His Majesty's Justices of the Peace, until sufficient Security be given by Naturalborn Subjects or Denizens, to appear in the Court, where such Prosecution shall be commenced, to answer the same, and not depart without Leave of the Court.

3d Geg. II. Cap. 14.] By an Act passed in the 3d Year of His present Majesty, it is Enacted, That if any of His Majesty's Subjects (other than the East-India Company, and those licensed by them,) shall directly, or indirectly, go to, trade, or adventure into, or from, the East-Indies, every such Offender shall incur the Forfeiture, and Loss, of all the Ships, and Vessels, employed in such Voyage, Trade, or Adventure; and also all the Goods laden thereupon, or that were sent to, acquired, traded or adventured, within the East-Indies, and all the Proceed, and Effects, of the same, and Double the Value thereof,

Vienna, Feb. 9. M. Migazzi, lately appointed Minister from this Court to that of Spain, had on Friday last his Audience of Leave of their Imperial Majesties, and set out from hence on Monday for Madrid. General Count Brown arrived here Yesterday from Transilvania, and proposes setting out in a sew Days for Bohemia, in order to take upon him the Command of the Troops in that Kingdom. Major General Corial, an experienced Officer, died here on the 3d Instant, in the 79th Year of his Age.

Venice, Feb. 11. Last Week Application was made to the Council for the usual Liberty of performing Operas and Masking during the Fair of the Ascension; but, in order to put a Stop to the Licentiousness and Disorders which are the natural Consequences of such Practices, the same was rejected. This occasions great Murmuring, not only amongst those who are disappointed of their Diversions, but also amongst the Trades People and Shopkeepers. The Ports of Ancona and Trieste do great Prejudice to the Trade of this Place, the latter particularly is every Day improving.

Copenhagen, Feb. 12. The Differences which have fublisted for some Years between this Court and that of Sweden, in Regard to the Regulation of the Limits in Norway, are, as we are affured, upon the Point of being adjusted to the reciprocal Satisfaction of both Crowns.

Berlin, Feb. 15. Major General Stosch has obtained Leave to resign his Employments, and is allowed a considerable Pension: The Command of his Regiment of Dragoons is given to Lieutenant Colonel Langermann. The King has conferred on M. Munchow, the Dignity of Provost of the Chapter of St. Sebastians at Magdebourg, in the room of the late Prince of Anhalt Dessau. His Majesty has disposed of the Regiment of Dragoons of the late Count Rothenbourg, in Favour of Baron Schonaich; and the young Prince of Anhalt Cothen is appointed Captain of a Company in the Regiment of Meyering, which is here in Garrison. 'Tis generally reported, that the Marriage of Prince Henry, the King's second Brother, with the Princess Wilhelmine of Hesse Cassel, will be celebrated in a short Time.

Hague, Feb. 22. The States of Holland and Westfrizeland will open their Assembly To-morrow, most of the Members being already arrived. We learn from Leyden, that M. Assendelft, ancient Burgomaster of that City, died there on Sunday last, in the 60th
