Whiteball, April 7.

Holdernesse's Office, with an Account, that the Yachts, with His Majesty, sailed from Harwich Yesterday, about Three of the Clock in the Afternoon, with a fair Wind, for Holland.

Naples, March 21. Within these few Days feveral Vessels, laden with Corn and other Provisions for this Capital, which have been detained for some Time past by high and contrary Winds, arrived fase in this Port. We are assured, that in Consequence of the strong Sollicitations made by Prince Esterbasy, Ambassador from their Imperial Majesties to this Court, Orders have been fent to the Commandant of Messina to release the Ship which carried his Imperial Majesty's Flag, and which was detained there under Pretence that the Captain was one of his Neapolitan Majesty's Subjects, and as such forbid by the Laws of his Country from ferving at Sea under any Foreign Power. The Eruptions of Mount Vesuvius have entirely ceased, so that at present we are delivered from the dreadful Apprehensions we have been under for some Time past. 'Tis said the Queen is again with Child, and that the same will soon be declared at Court. Upon a Rumour that some of the Persons who lately robbed and murdered the King's Treasurer at Barletta, were come hither in order to dispose of some of the Effects they stole from thence, Orders are given for a strict Search to be made in order to discover them. A great Number of Sailors arrived here last Week from Lipari, in order to serve on board the Squadron that is going on a Cruize against the Barbary Pyrates. Last Saturday a Maltese Man of War arrived here from Spain, having on board 500,000 Piaftres, being a Remittance from his Catholick Majesty to this Court. Some Days ago a Felucca, with 35 Persons on board, was lost in a violent Storm in the Gulph of Policastro, and every Soul perished.

Rome, March 22. 'Tis said the Elector of Treves hath at length obtained Leave of the Pope to name a Coadjutor for himself to his Arch-

bishoprick, which he has been a long Time solliciting. They have begun to work with great HIS Morning Richard Lucas, one of His Majesty's Messengers, arrived at the Right Honourable the Earl of Project for cutting a new Canal from Tevero to the Sea, which will be of infinite Service to Commerce.

Petersbourg, March 22. Her Imperial Majesty has appointed Captain James Kennedy, an Irish Gentleman, and Captain Ywan Tscherewin, to be Rear Admirals of her Fleet. Welearn by different Accounts from Persia, that Prince Heraclius of Georgia has lately obtained such considerable Advantages, that 'twas imagined he would in the End supplant Schach Doub, and procure himself to be acknowledged Sovereign. They likewise add, that most of the Russian Merchants were retiring with their Effects to Derbent, in order to prevent their being involved in the general Confusion the Troubles in that Kingdom were like to bring on the Inhabitants; and at the same Time to be ready on all Occasions to retire into the Russian Dominions.

Turin, March 24. We now feel the good Effects of the Precautions used by the King in fending for all the Corn from Sardinia that could be spared, and in filling Magazines therewith, in order to hipply his Swijects with it in case of Need; for, notwithstanding the Shortness of the Crops last Year in Piemont, and other Provinces, we have now Corn at a reasonable Price, when all the neighbouring Provinces are in the greatest Want of it. The Officers appointed to review the Troops in the different Garrisons of these States, have already acquainted his Majesty with the good Condition in which they found those Regiments that have passed in Review before them. We have received Advice from Vienna, that Count Seilern is appointed by their Imperial Majesties to be Envoy Extraordinary to this Court.

Copenhagen, March 30. The Celebration of the King's Birth-Day is deferred till Easter Monday. Count Linar, late Envoy Extraordinary and Plenipotentiary from this Court to that of Russia, and who lately returned from ' thence, had a private Audience of his Majesty on the 19th Instant. The King enjoys a presty good State of Health, and often diverts himself

with Hunting in the Neighbourhood of Jagersbourg. On Saturday last M. Paludan, lately nominated by his Majesty to the Bishoprick of Christiansand in Norway, was consecrated by

the Bishop of Zeelande.

Vienna, April 1. On Thursday last, being Maunday Thursday, their Imperial Majesties, the Archduke Joseph, the Archdutchess Maria Anne, and the Princess Charlotte of Lorrain, received the Holy Sacrament from the Hands of the Pope's Nuncio. After which his Imperial Majesty, according to ancient Custom, washed the Feet of twelve poor old Men; whilst her Imperial Majesty did the same to twelve poor old Women, in her own Apartment. The Affair of the Investitures goes now on entirely to the Emperor's Satisfaction, for besides the feveral Princes of Germany, who are preparing to fend Ministers here with the necessary full Powers for that Purpose, we are assured that the King of Sardinia, and the Duke of Modena, intend to receive the like Investitures of the Estates they hold in Italy by the Title of Fiess of the Empire. The Court has sent into Upper Austria a Person they can confide in, who is to examine strictly into the Cause of the Tumults that have lately happened there on Account of Religious Grievances, which he has full Power to redress in such Manner as he shall judge proper.

Lyons, April 2. We have already retaken most of the Prisoners who escaped lately out of the Archbishop's Prison, several of whom are to be executed next Week. The Price of Bread, which has been excessive dear for some Time past in this Country, begins to diminish. They write from Avignon, that M. Folard, Knight of the Royal and Military Order of St. Louis, died there the 23d of last Month, in the 84th

Year of his Age.

Dresden, April 3. Prince Charles having been seized at Elsterwerda with the Symptoms of the Small Pox on Monday last, the King immediately gave Orders for his being conveyed to the Palace in this City, where he was no sooner arrived than they began to appear. All the Court were greatly alarmed on this Occasion; and as neither the Prince Royal, nor the two youngest Princes, have had that Distemper, they are all ordered into distant Apartments.

Munich, April 5. On Monday last being the Elector of Bavaria's Birth Day, who then entered into the 26th Year of his Age, the same was celebrated at Court with great Magnificence. The Departure of the Elector of Cologn is fixed for Friday next; and the Elector Palatin's Ar-

rival is foon expected.

Mayence, April 8. The Elector our Sovereign, who was seized some Days ago with a Fever, is now perfectly recovered. We learn by private Letters from Alsace and the three Bishopricks, that they continue to make the necessary Preparations in those Provinces for the Camps that are to be formed during the Summer.

Hague, April 13. Yesterday the States of Holland and Westfrizeland opened their Assembly, and this Morning continued their Delibe-

rations. A Deputation from the States of the Province of Guelderland, confisting of Count Byland, and the Barons Hekeren and Tork, are arrived here to execute a private Commission, and have already had a private Audience of her Royal Highness the Princess Governante.

The King has been pleased to issue his Letter under his Majesty's Royal Sign Manuel, to the Earl Marshal of England, that the Honourable Dame Mary Sherard (Relict of Sir Brownlow Sherard, Bart. deceased, and eldest of the two Grand Daughters and Coheirs of the Right Honourable Robert Sydney, late Earl of Leicester, deceased) and her Issue, shall use and enjoy the Name of Sydney, and bear and use the Coat Armour of the said late Earl of Leicester, deceased.
