PRESENT,

Their Excellencies the Lords Justices in Council.

THEREAS it hath been represented to their Excellencies the Lords Justices at this Board, That Colin Campbell of Glenure, who had been appointed by the Court of Exchequer in that Part of Great Britain called Scotland, to be the Factor or Steward upon the Estate of Charles Steuart of Ardshiell, lately attainted of High Treason, but fled from Justice beyond the Seas, having received Directions from the faid Court, to remove all the Tenants belonging to the faid Charles Steuart, (some of) them his near Relations, and all of whom had been in the late Rebellion) from the Possessions they had obtained of him before the Attainder—The said Colin Campbell did, upon Thursday the 14th of this Instant May, proceed to execute the Decrees of the said Court, taking with him a Messenger, (being the proper Officer for that Service) as also a Nephew of his own, and his Servant; and in the Way as they passed through a Wood on the Farm of Lattermore, in Duror in Argyllshire, Part of the said forfeited Estate from which the Tenants were to be removed, the faid Colin Campbell was, from behind a Bush, shot dead on the Spot.—And whereas it is highly necessary that the Person or Persons who committed or were concerned in the said cruel and detestable Murder, in Violation of the Peace, and Defiance of the Laws of this Realm, should be brought to speedy and exemplary Punishment—It is hereby ordered by their Excellencies the Lords Justices, with the Advice of his Majesty's Privy Council, that all Magistrates and other Civil Officers whatsoever, and all other his Majesty's Subjects, do make strict and diligent Search and Enquiry after the Person or Persons concerned in the said Murder, and the Authors, Actors and Abettors thereof; and that they do apprehend and seize, or cause to be apprehended and seized, the said Offenders, that they may be punish'd with the utmost Rigour of the Law.—And for the Encouragement of all Persons to be diligent and industrious in their Endeavours to make such Discovery, and for the better and more effectual bringing the Offenders to Justice, it is hereby further ordered, That if any Person or Persons concerned therein, except the Person who actually shot the said Colin Campbell, shall dis-

AT the Council Chamber Whitehall, the 28th cover any other Person or Persons concerned in the said Fact, so as the Person or Persons thus discovered may be apprehended and convicted thereof, such Discoverer or Discoverers shall receive his Majesty's most gracious Pardon.—And it is hereby likewise further ordered, That any Person or Persons, who shall discover and apprehend, or cause to be discovered and apprehended, any of the Persons concerned in the said heinous Offence, so as he or they be convicted thereof, shall have and receive, for every such Person so convicted, the Sum of One Hundred Pounds, to be paid by the Receiver-General for Scotland, according to Directions to be given for that Purpose by the Right Honourable the Lords Commissioners of his Majesty's Treasury, who, are hereby directed to give fuch Orders accordingly.—And all his Majesty's loving Subjects are hereby required to use their utmost Endeavours, in their several Stations and Places, to find out, discover, and apprehend the Offenders as aforesaid, upon Pain of his Majesty's highest Displeasure.

Petersbourg, May 13. On Saturday last her Imperial Majesty's Coronation was celebrated at Court with great Magnificence; on which Occasion Major General Hampsf was promoted to the Rank of Lieutenant General, and the Brigadiers Proforofsky, Devier, and Isakoff, to that of Majors General. Her Imperial Majesty also nominated the Baron de Samorokoff to be Master of the Horse, in the Room of the late Prince Kourakin. On Tuesday last the Court quitted the Winter Palace, and went into the Summer Palace. Orders have been sent to all Commanding Officers of our Troops, to cause all the Men to be regularly exercised three Times a Week till further Notice. We learn from Persia, that Prince Heraclius still continues to gain some Advantages over Schach Doub, but that the Report of his being in Possession of Ispahan is without Foundation.

Naples, May 14. Commodore Martinez. who lately funk a large Algerine Shebeck, has been promoted by the King to the Rank and Pay of a Colonel for his gallant Behaviour in that Action. Last Week he put in at Messina, where he landed 169 Moors to perform Quarantine, whom he had taken up from the Sea; and after having refitted his Squadron of Shebecks, and provided them with the necessary Provisions, sailed again on a Cruize. The Loss the Algerines sustained by the above Ship, has not hindered their appearing in great Numbers on the

of our coassing Vessels, amounting, as is alledged by our Merchants, to the Value of upwards of 100000 Crowns within these sew Weeks. The Negociation that has been carrying on for some Years between this Court and the States General of the United Provinces, for settling a Treaty of Commerce, is at length so far advanced, that the same is almost daily expected to be signed. They have already taken eleven of the eighteen Prisoners who last Week sound Means to break out of one of the Prisons of this City, and 'tis thought by the Discoveries which some of them have already made, the rest will soon be apprehended.

Rome, May 16. The Departure of the Pope for Castle Gandolso, is fixed for the 25th of this Month. We have received Advice from Civita Vecchia, that the Barbary Corfairs have taken a Genoese Felucca, with about 50 Men on board, whom they have carried into Slavery. The same Letters add, that they have likewise taken a Catalan Pink, with 120 Recruits on board, who were going to Naples, in order to compleat the Spanish Regiments in his Neapolitan Majesty's Service. They write from Macerata, a small Town of the Marche of Ancona, that a Person having been committed to Prison there for being concerned in the running of Goods, a large Body of Smuglers came and demanded him to be fet at Liberty, but being refused, they immediately broke open the Prison, and carried him off in Triumph, the Goaler having escaped being murdered with the greatest Difficulty.

Bologne, May 16. We learn from Reggio, that the Duke of Modena, who has been there with his whole Court during the Time of the Fair, proposed to set out from thence on Saturday next for Sassuolo, in order to pass the Summer.

Parma, May 16. The Corn brought hither from the Ferrarois and Naples, not being sufficient to supply the Inhabitants with Bread till Harvest, the Duke our Sovereign has obtained Leave of the Court of Vienna for his Subjects to purchase Corn in the Mantuan, where they have at present a greater Quantity than most

other Countries of Italy.

Florence, May 19. On the 13th Instant the Empress's Birth day was celebrated here with the usual Solemnity, the Foreign Ministers, the Nobility, and Military Officers, appearing in their rich Habits; and in the Evening there was the usual Fireworks, and the Cannon of the Castles were fired. On the 14th and 15th two Couriers from the Court of Naples passed by this City, whereof one for Parma and Madrid, and the other for Dresden, with Notice, that on the 11th Instant the Queen of Naples was happily delivered of a Prince. Within these few Days past this Government has restored the Inquisitor to his former Authority with regard to the Press, having caused a Notification to be given to the People concerned in it, to obtain first his Approbation, not only for the Printing, but also for the Exportation and Importation of all Books. The Emperor has lately granted 38 Commendaties of the Order of St., Stephen, to divers

Knights of that Order; and amongst them, a Commendary of 60 Crowns a Year to each of the young Gentlemen who went on board of the three Ships of War in their late Voyage to

Constantinople, &c.

Lisbon, May 22. A Circumstantial Account of the great Damages received last Month by the Inhabitants of Aveira and Buarcos, as well by ' Earthquakes, as by the Overflowings of the Rivers, having been laid before the King, his Majesty was so affected therewith, that he not only ordered them to be supplied for the present with Corn at his own Expence, but also ordered that they should be exempt from paying all Duties and Taxes whatfoever for ten Years. The Corfairs of Barbary have of late interrupted the Commerce of this Kingdom so very much, that Orders are given for the immediate equipping four Men of War, and the like Number of Frigats, in order to give them Chace. from the Bahia and Maranham are both arrived richly laden; that from the Bahia having on board half a Million on the King's Account, be-. sides two Millions on the Merchants Account,

Turin, May 23. The Accounts received at. Court from the Inspectors of the Troops, as to the Appearance and Behaviour of the several Regiments they have reviewed, give great Satisfaction. The Dutchess of Savoy advances happily in her Pegnancy, and 'tis expected will be brought to Bed about the Beginning of July.

Venice, May 26. Early this Morning there was a violent Storm which has done a great deal of Mischies. The Lightning sell in several Parts of this City, and has damaged the Churches of Sta Croce and St. Moise, the Convent of St. Andrea and Sta Margarita, and killed several People. Some private Houses have likewise suffered, particularly the Imperial Ambassador's.

Berlin, May 27. On Thursday Morning last the King reviewed all the Regiments, that had been drawn together for that Purpose, on the Plain of Templow. Most of the General Officers in Town, and many of the Nability, were present at this Review, and were afterwards invited to dine with his Majesty, at his own Table. The King expressed great Satisfaction at the Appearance and Behaviour of his

Troops.

Vienna, May 27. On Wednesday last their Imperial Majesties, accompanied by the two eldest Archdutchesses, and the Princess Charlotte of Lorrain, set out from Schonbrun for Laxembourg, in order to divert themselves with hunting for a few Days. Count Keyserling, the new Russian Ambassador, is soon expected here, upon whose Arrival Count Bestuches will immediately depart from hence for Petersbourg. Several considerable Bodies of Recruits have lately been fent, by Way of the Danube, into Hungary, in order to complete the Regiments in Garrison in that Kingdom. On Sunday last General Count Brown set out from hence sor Bohemia, in order to take upon him the Command in Chief of the Imperial Troops in that Kingdom.

Hague, June 6. We learn from the Uppet Palatinate, that an Epidemical Distemper had

lately

lately broke out at Vernberg, a small Town in the Neighbourhood of Amberg, which greatly resembled the Plague; and that a great Number of the Inhabitants of that Place had died of it in a very few Days.

Last Sunday being the Birth-Day of his Royal Highness the Prince of Wales, the Great Guns were fired in his Majesty's Park the Phoenix, and answered by Vollies from the Regiments in Garrison, which were drawn out in the Royal Square at the Barracks.
